PETITION TO MODIFY COVENANTS

Restrictive covenants for the College Heights Addition to the City of Blair, Washington County, Nebraska ("College Heights Addition") were recorded in the real estate records the County Clerk of Washington County, Nebraska, on November 28, 1972, at Book 71, Pages 485 through 487. Paragraph I of such covenants provide that "No two story dwellings shall be permitted on any lot in College Heights Addition" and further provide at Paragraph M that "These covenants, restrictions and conditions shall run with the land and continue until January 1, 1998, after which such time they shall be automatically extended for successive periods of ten years, unless an instrument signed by a majority of the then owners of said land shall have been recorded in the office of the County Clerk of Washington County, Nebraska, agreeing to change same in whole or in part".

Natascha Nething-Radnor and Travis Radnor, wife and husband ("Radnor"), are the purchasers under a certain real estate purchase agreement dated on or about April 13, 2004, for the purchase of Lot 26 of College Heights Addition from Brent A.
