

MODIFICATION OF RESTRICTIVE COVENANTS

WHEREAS, on September 29, 1966, the undersigned, Robert L. Marquardt and Dorothy M. Marquardt, husband and wife, and owners of Lots One to Twenty-two (1 to 22) inclusive, of Marquardt's Hillcrest Addition to the City of Blair, Washington County, Nebraska, entered into a restrictive covenant agreement concerning said lots, which said agreement was recorded in Deed Book 71 at pages 102-106 of the records of Washington County, Nebraska, and whereby the undersigned are still the owners of said lots and desire to change paragraph "G-1" of said agreement,

It is hereby agreed and understood by and between said parties in ownership that paragraph "G-1" of said agreement which provided "a) 1,600 square feet for one story dwelling facing on 24th Avenue, 25th Avenue to Elm Drive and on Elm Drive. b) 1,400 square feet for one story dwelling." be deleted and that the following paragraph be substituted therefor " a) 1,600 square feet for one story dwelling facing on 24th Avenue, 25th Avenue to Elm Drive and on Elm Drive. b) 1,100 square feet for one story dwellings on Lots 1 thry 7 facing on 25th Street. c) 1,300 square feet for one story dwellings on Lots 8 and 9 facing on 25th Street. d) All other lots 1,400 square feet for one story dwellings."

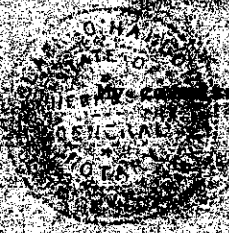
