Jan 22, 2008 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors met in the Supervisor's Room at the Courthouse, Blair, Nebraska, in open and public session on Tuesday, Jan 22, 2007. Proof of Publication of Notice of Meeting is on file in the Office of the County Clerk as part of this record. The agenda for the meeting, along with the minutes of the previous meeting had been mailed to all Board members in advance. The following proceedings took place during the convened meeting.

Chairman, Duane Wilcox declared the meeting was in session. Chairman made note that the Open Meetings Law is posted and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Wilcox, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Jeff Quist absent. Also present, County Clerk Merry Truhlsen.

It was moved by Miller and seconded by Kent Wilcox that the rules be suspended and that the minutes of the Jan 8, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Upon roll call vote Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Jeff Quist absent. Chairman declared motion carried.

Jeff Quist present.

It was moved by Abariotes and second by Miller that correspondence and reports be placed on file. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Cheryl Parsons, Road Supt, addressed the Board regarding designating an engineering firm to perform consulting services on Road Project P35A. Five bids were received: HWS Consulting Group \$48,000; JEO Consulting Group Inc \$109,995; Mainelli Wagner Option 1-\$83,500, Option 2-\$86,500, Option 3-\$84,000; Schemmer Assoc Inc \$66,300; Thompson Dreessen & Dorner Inc \$55,000. The Road Committee had studied the bids and recommended accepting the bid of Schemmer. Motion by Rohwer second by Kent Wilcox to accept the bid from Schemmer Assoc Inc for \$66,300. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Road Supt discussed placing a guard light at the junction of Hwy 91 and Co Road 15 and another at the junction of Hwy 30 and Co Road 15. Chairman also asked about placing a light at Hwy 30 and P30. Parsons said she would put it on the next agenda. The cost is \$12 per month for electricity. Motion by Thomsen second by Quist to install quard lights on Co Road 15 at Hwy 91 and Hwy 30. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Nebr-Iowa Supply Co Inc had sent a letter to Jeff Quist asking if they could provide a portion of the fuel business for the County Road Dept. Greg McIntosh and Eric Stark from Nebr-IA were present. This letter had been discussed at the Road Committee meeting. The Board discussed using all fuel companies in the County. Motion by Kent Wilcox second by Abariotes to award fuel supply at County Shop to Nebraska-Iowa Supply Co Inc. starting February 1. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Chairman Wilcox said he was planning on attending the NIRMA meeting in Kearney, Feb 6, and asked if any other Board members would be there. Rohwer and Quist said they are planning on attending.

Sheriff Mike Robinson had Lease Agreements signed by the City of Fort Calhoun and the Village of Arlington regarding the vehicles they provide for Sheriff Deputies. Motion by Quist second by Miller to approve lease agreements and authorize the Chairman to sign. Upon roll call vote Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Thomsen abstained as she was on the Arlington Village Board when this agreement was set up. Chairman declared motion carried.

County Treasurer, Marj Hoier, was present with Tax Exemption Applications for Motor Vehicles owned by Tax Exempt organizations. Motion by Miller second by Kent Wilcox to approve the exemption applications. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Paul Piotrowski of Goracke, Ritterbusch & Piotrowski LLP was present to review with the Board the current audit for July 06 – June 07 which their firm had recently completed. He stated that generally everything went well and the County again had a good, clean audit. It was a smooth transition with new officers and the financials look good. Pam Daly questioned who is management. It was moved by Miller and seconded by Kent Wilcox to receive the audit report and place on file. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

At 11:00 AM a Public Hearing was held on the application for a Class C Liquor License for Blair Yacht Club Hall. It was moved by Abariotes seconded by Miller to open Hearing. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. Greg Drew, Drew Law Firm, Benjamin and Evelyn Rogge were present. Clerk read application for Blair Yacht Club Hall, address 9970 Marina Lane, Blair, NE. Application states applicants, Evelyn & Benjamin Rogge, are buying Pop & Doc's Too and that they intend to open March 1. This license is for a building to be available for receptions etc. The Board questioned the need for a Class C license for this facility. It was moved by Quist seconded by Abariotes to close hearing. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. Motion by Thomsen second by Quist that the Board go on record as recommending Blair Yacht Club Hall verify the need of a Class C license with the Liquor Control Comm then come back to the Board. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

A Public Hearing was held on the application for a Class CK Liquor License for Blair Yacht Club. It was moved by Abariotes seconded by Quist to open Hearing. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. Greg Drew, Benjamin and Evelyn Rogge were present. Clerk read application for Blair Yacht Club, same information as previously stated. This license is for the restaurant and bar area. It was moved by Quist seconded by Abariotes to close hearing. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. It was moved by Kent Wilcox seconded by Quist that the Board go on record as recommending issuance of this license. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

Board of Equalization: Jean Ray, Deputy Co Assessor and Ann Therkelsen were present. Motion was made by Miller and seconded by Abariotes to enter in Board of Equalization. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. Motion was made by Abariotes and seconded by Rohwer to approve Corrections #6422 through #6423. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried. Motion was made by Miller and seconded by Abariotes that the

Board adjourn from Board of Equalization and reconvene in regular session. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.

The Board recessed for lunch.

Bill Lux and Melissa Rice, RE: County's Animal Control, cancelled and asked to come to the next meeting.

County Clerk, Merry Truhlsen, was absent. Deputy Robin Miller was present.

Kevin Hall and John Rickert with Schemmer Assoc Inc were present to discuss the Washington County East (Eagles Bldg) renovation. They explained in detail the General Contractor RFP Summary. Questions were made by the Board. Dennis McCormick asked if the General Contractors would subcontract out for bids. Joyce Graybill asked if the local contractors would have a chance to bid. Mr Ricker explained that the General Contractors would do their own subcontracting and a preference for Blair area subcontractors was requested. After lengthy discussion it was motioned by Miller and seconded by Quist to accept the proposal and continue with the Project. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays, none. Chairman declared motion carried.

Comments from Public:

Sheriff, Mike Robinson and Randy Wildman were present to voice their desire to acquire the refrigerator and freezer from the Eagles Building that is on the Auction Sale Bill for the jail services. They didn't feel the need to purchase them at the auction when the County already owns them. Discussion was had and it was mentioned that if they wanted to place a bid on those items they could.

Joyce Graybill was present and asked the question, why wasn't the salary litigation increase put back on the agenda for discussion? The Board said the salaries for 2008 were set.

Claims were received and reviewed, following which it was moved by Miller and seconded by Rohwer that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Upon roll call vote Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer voted aye. Nays none. Chairman declared motion carried.
