April 8, 2008 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, April 8, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Kent Wilcox, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Also present, County Clerk Merry Truhlsen.

It was moved by Quist and seconded by Miller that the rules be suspended and that the minutes of the Mar 25, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

It was moved by Abariotes and seconded by Kent Wilcox that the regular Monthly Fee Reports of the following Officials be received and placed on file: Co Clerk \$11,100.66, Reg of Deeds \$19,713.00, Co Court \$20,701.74, Co Plan Comm \$10,895.00, Clk Dist Crt \$1,265.25, Co Sheriff \$2,376.33 Road Dept \$1,260.20. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The Clerk had no correspondence for the Board.

Mike Smith updated the Board on spring activities with the Weed Dept. He discussed mowing and spraying and hopes to start working on repairing and installing the fence with the Sheriff's Office next week.

Abariotes gave an update on the Washington East Building. Work is progressing on schedule. Floor has been sanded and they are working on drywall. The signs and landscaping were discussed.

Road Supt Parsons updated the Board on several items. The Road Dept was awarded a grant of \$14,830 from the State for tire recycling to enable Wash Co residents to dispose of old tires. The Board tentatively set the date for Sat, June 21 from 8:00 am to 1:00 pm. Parsons discussed road conditions and the amount of rock and gravel that has been hauled in the last 2 weeks. The Road Dept rented a machine and is sealing the cracks on the asphalt roads. Parsons will be attending an erosion and sediment control seminar in Omaha tomorrow.

At 10:00 am, Road Dept bids were received for a tandem truck cab & chassis with dump body & hydraulic system, snow plow and sand spreader. The bids quoted a purchase price with or with out a trade in. Three bids were received: Omaha Truck Center- 2009 Freightliner \$100,618, or allow\$5,500 on '95 Ford trade-in for a purchase price of \$95,118. Cornhusker International Trucks- International Model 7500, \$104,077.80, or allow \$6,000 on '95 Ford trade-in for a purchase price of \$98,077.80. Wick-Sterling Trucks- 2009 Sterling LT 8511, \$109,882, or allow \$9,500 for '95 Ford trade-in for a purchase price of \$100,322. Chris Grass from Omaha Truck Center and Rob Roane from Cornhusker International were present to answer questions. Board discussed

keeping the '95 Ford truck, instead of using it as a trade-in. Motion by Quist second by Abariotes to refer the bids to the Road Committee and have them make a recommendation to the Board at the next meeting. Vote-Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Board had received a letter from Goldenrod Hills Community Action Inc asking for a letter of support for their weatherization program. Motion by Kent Wilcox second by Abariotes to authorize Chairman to sign the letter of support for Goldenrod Hills Grant Application for Weatherization Program. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Motion by Abariotes second by Quist to receive and place on file the annual Burt/Washington Drainage District Report. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Mike Robinson addressed the Board regarding LB371, which makes changes on the Sheriff's Deputies County retirement plan. Robinson said a big problem in retaining trained Sheriff personnel is the lack of good retirement benefits. Robinson also spoke on the specialized nature and hardships a Sheriff's Deputy job entails. One change in LB371 is the County's retirement contribution would increase from 7.75% to 9.25%. Robinson calculated this increase would cost the County \$13,000. Another change would be a switch to a defined benefit retirement plan. Chairman Wilcox said in talking with NACO, this bill isn't going to come up in this Legislative Session but thinks it will in the next session. Jon Reeves spoke in support of LB371 and read a letter to the Board. Pam Daly spoke in favor of LB371 and of the importance of the Sheriff's Office and the need to provide funding necessary to enable them to retain well trained Officers. Dennis McCormick spoke in support of LB371.

Mike Robinson told the Board he wasn't ready to discuss the Sheriff's Office remodel bids. Motion by Kent Wilcox second by Rohwer to table action on the Sheriff's Office remodel. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Becky Versch, with the Washington County Extension Service introduced Steve Tonn, who will be the new Ag Educator for Washington County.

Steve Mencke, Co Assessor, submitted a quote from Chris Poulsen to provide technical support for the GIS program. The quote, covering the next 3 months, is for 12 days of service @ \$42.00 per hour. Phil Green and Nate Dougherty, with Blair City, said GIS is a very important part of what the City of Blair does and wanted to encourage the Board to move forward in hiring Chris Poulsen. Motion by Quist second by Kent Wilcox to approve 12 days of service from Chris Poulsen. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Phil Brazelton discussed the need for the County to have it's own IT/GIS person. He had figures for the past two years showing various computer technician expenses and encouraged the Board to consider creating this position in the next budget year. He handed out a job description for this position and asked the Board for their input. Brazelton will get figures together regarding the cost of the salary/benefits package and provide that to the Board.

Steve Mencke, Co Assessor was present. Mencke said he had no corrections or valuation changes for the Boards approval today. Chairman stated there would be no Board of Equalization today.

Legislative bills were discussed. LB880 won't be heard this session. LB777 passed and Co Assessor discussed this with the Board.

Clerk discussed Resolution 2008-08 authorizing Co Treas to transfer money from the Public Safety Communication Bond Fund to the Courthouse Bond Fund. The overall levy for the bond fund was correct, but the split between the two was transposed on the Amended Levy Resolution #2007-26. The Treasurer will change the fund table on their posting field to correct this for future posting of the 2007 taxes. Motion by Miller second by Abariotes to adopt Resolution 2008-08 authorizing Co Treas to transfer money from the Public Safety Comm Bond Fund to the Courthouse Bond Fund and authorize Treasurer to change the fund table on their posting field to correct this for future posting of the 2007 taxes. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Kent Wilcox absent. Motion carried.
