Apr 22, 2008 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, April 22, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Absent: Kent Wilcox. Also present, County Clerk Merry Truhlsen. Kent Wilcox was absent all day.

It was moved by Miller and seconded by Rohwer that the rules be suspended and that the minutes of the Apr 8, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The following correspondence had been received: Two Letters from Dept of Roads, Feb Lodging Tax total from Dept of Rev and an unsigned letter about junk cars. It was moved by Abariotes and second by Miller that correspondence be placed on file. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Julie Ogden, JEO, discussed the alignment of CR P16 & P18. At a recent meeting, the Road Committee discussed having JEO prepare a third option for this curve. This plan would straighten the road, move the road away from the creek and increase the speed limit. Pat Edwards, with Huntel, asked whether the fiber optic cable buried along the road would be impacted. Motion by Quist second by Duane Wilcox to authorize JEO to prepare preliminary set of plans on Alternate 3 for \$3,650.00. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: Abariotes. Motion carried.

Cheryl Parsons, Road Supt, discussed the armor coat on CR32 and the urgent need for repairs. Mike Tidball, with Western Engineering discussed problems encountered the last two years and presented a proposal to stabilize the road and preserve the life of the armor coat. Motion by Rohwer second by Quist to accept the proposal from Western Engineering Co Inc for \$58,654.00 and to also have the Road Dept clean out the ditches. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Road Supt Parsons and Road Foreman Maslowsky had studied the Dump truck bids, noted the exceptions and presented their findings to the Road Committee. Maslowsky was present to answer questions. Parsons said the Road Committee is recommending the bid from Cornhusker International Trucks for a 2008 International tandem dump truck, plow and sander. Motion by Quist second by Rohwer to accept the bid from Cornhusker Trucks International for \$104,077.80, as it met all the specifications of the bid. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons stated the County had received a grant to replace and install curve signs and posts for Federal Aid Project #STWD (079). In conjunction with this program, the State of Nebraska is requiring the County to sign a Right of Way Certificate Motion by Quist second by Miller to authorize chairman to sign the Right of Way Certificate. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons mentioned several other road items: a large wash out on east end of CR34 has appeared, this will be an emergency road project; a couple other wash outs need to be seeded; and Road Dept got the Right of Way for CR P41.

Sarah Chatt, Washington County Bank, discussed the issuance of Hospital Revenue Bonds for Memorial Community Hospital Corporation Project. MCH had planned on completing their financing in 2008 with public bonds. However, the public bond market pricing for 2008 has changed significantly in a negative way for the Hospital. MCH came back to Washington County Bank and First National Bank for financing to see what they could do. To use Bank financing, MCH needs what is called bank qualified status, which is an IRS status. The bonds get issued through the County and only \$10 million can be issued in a year. Last year, MCH used \$9.25 million, leaving \$750,000 for the County to use for capital leasing or bond financing. This year, MCH would like to use \$9 million, leaving \$1 million for the County to use for any capital leasing or bond financing. The Board will check into projected expenses and take action on this at the next Board meeting. Motion by Abariotes second by Quist to put this back on the May 12th agenda. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Miller, who is on the Visitor Promotion Committee, went through the 4 claims being submitted. Motion by Quist second by Rohwer to approve the Committee's recommendation and pay the claims submitted. Vote-Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Abariotes gave a brief update on the Washington County East building and said the Board could do a quick walk through at noon if they wanted. This project will be discussed again after lunch.

A large group was in attendance for the discussion on the draft of the County Board Meeting Policies and the Resolution covering recording the meetings. Chairman Wilcox went through the policies, discussing different points. Sentence in the "Agenda" section "Distribution of the tentative agenda to the public at this time shall be at the discretion of the board chair" will be removed. Under "Meetings", the sentence "Persons wishing to make public comments shall sign in with his or her name" was changed to "Persons wishing to make public comments shall sign in with his or her name" was changed to "Persons wishing to make public comments shall state his or her name". Chairman opened the meeting up to the public. Gary Petersen went through his notes on the Board Policies. Daniel Daly read a letter from Don Preister. Paul Cerio wondered why the Board needed a resolution about Board policies. Robbin Jeffrey questioned some wording used in the policies. Joyce Graybill said she thought all records should be saved. Chairman Wilcox read the Resolution about recording meetings. The cost was discussed. Marcia McGill discussed how she makes copies and mails them. Paul Cerio spoke about the Open Meetings Law. Robbin Jeffrey spoke about the Clerk being the custodian of the records. Motion by Abariotes second by Miller to take this back to Committee for further revisions. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The remaining morning agenda items will be heard at 1:00. The Board recessed for lunch.

Board of Equalization: It was moved by Quist and seconded by Miller to enter in Board of Equalization. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Steve Mencke, Co Assessor, Jean Ray and Ann Therkelsen were present. Mencke explained the proposed valuation changes he brought before the Board. It was moved by Abariotes and seconded by Miller to approve Valuation Changes. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Motion was made by Quist and seconded by Miller that the Board adjourn from Board of Equalization and reconvene in regular session. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Steve Mencke had a quote from ESRI to provide maintenance from 5/10/2008 to 5/9/2009. ESRI is the software the Assessor's Office uses for their GIS program. This agreement provides maintenance and also provides updates to the program. Motion by Quist second by Thomsen to pay the maintenance contract for \$2,200. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Sheriff Mike Robinson discussed a remodeling project in the Sheriff's Office. Robinson said he would like the Bldg & Grds Committee to come see what changes they wanted to make. Motion by Quist second by Miller to authorize Bldg and Grds to look at project and approve Sheriff's Office spending up to \$2500 on the project. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Clerk read a letter from Blair Area Chamber of Commerce requesting to hold the Gateway to the West Craft Show on the Courthouse lawn on June 14, from 8:00 am to 5:00 pm. Board requested Clerk to check on insurance coverage for the event. Motion by Quist second by Abariotes to approve this request contingent on checking on insurance coverage with the Chamber Office. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Cindy Sullivan, with Nebr Health & Human Services, was present to discuss the move to the new building. Sullivan wondered about plans for the move, who is going to move them, are the offices moving on different dates and wanted the three offices to meet with the Committee to work out these details. Motion by Quist second by Abariotes to refer this to Bldg & Grds Committee to coordinate the move to Wash Co East building. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Doug Cook, Planning Administrator, was present with the following agenda items.
