The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Monday, May 12, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Kent Wilcox, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Also present, County Clerk Merry Truhlsen.

It was moved by Rohwer and seconded by Abariotes that the regular Monthly Fee Reports of the following Officials be received and placed on file: Co Clerk \$13,352.68, Reg of Deeds \$20,965.75, Co Court \$22,928.25, Co Plan Comm \$16,205.00, Clk Dist Crt \$1,079.20, Co Sheriff \$2,078.95 Road Dept \$620.70. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The following correspondence had been received: Report from Best Care Emp Assistance Program. It was moved by Kent Wilcox and seconded by Miller that the report be received and placed on file. Vote-Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, informed the Board the wrong sander was priced with the dump truck at the last meeting, a larger sander is needed for the truck. The Northern Truck Equipment Co sander cost \$37,394.00, bringing the dump truck, plow and sander total to \$106,696. Motion by Rohwer second by Quist to correct bid to include price of the bigger sander, making the total bid \$106,696.80 and authorize Chairman to sign new Contract Agreement. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The Road Committee had discussed Project #C89(455), removing & replacing existing surfacing. It was their recommendation and the engineer's recommendation to get a dowled concrete surface bid and not take a bid for asphalt. The County's portion is estimated to be \$500,000, with an extra \$60,000 for engineer costs. Mike Tidball from Western Engineering Co Inc was present. Motion by Quist second by Kent Wilcox to concur with Road Committee's recommendation and get a dowled concrete bid for Project #C89(455). Vote- Aye: Thomsen, Quist, Kent Wilcox, Miller and Rohwer. Nay: Duane Wilcox and Abariotes. Motion carried.

Armor coat proposals for 2008 were received at 9:45. Only one bid was received, and that was from Sta-bilt Construction Company. Bid was as follows: Item 1: Prime Coat \$0.48 sq yd, need 14,080 sq yds, Item 2: Single Armor Coat \$0.70 sq yd, CRS-2, need 116,160 sq yd Item 3: Single Armor Coat \$0.84 sq yd, MC-3000, need 160,512 sq yd. Total cost of bid was \$222,900.48. Rick Burchett from Sta-bilt was present. He discussed the increase in asphalt prices. Motion by Quist second by Kent Wilcox to accept bid from Sta-bilt Const Co for \$222,900.48 and authorize Chairman to sign contract. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Gary Tinkham, Surveyor, addressed the Board about closing a road that was platted for the town of Fontanelle but never put in. Delford and Beverly Brandt were present. The Brandts own the property on both sides of the platted road, and would like to build a home close to this platted road. The north half of Georgia Street, along with other roads not developed, were vacated in the 1930's. Parsons read Resolution 2008-10. Motion by Abariotes second by Thomsen to adopt Resolution 2008-10, which sets the public hearing date for May 27<sup>th</sup> at 10:00 AM for the vacation of the South ½ of Georgia Street, in the original Town of Fontanelle, running through Tax Lot #44 Section 17-18-9, property owned by Delford & Beverly Brandt. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Sarah Chatt, Washington County Bank, discussed Memorial Community Hospital Corporation Project's financing using bank qualified status through the County for \$8 million. There was no paperwork to sign as the County had entered into this agreement last year. Motion by Quist second by Kent Wilcox to approve MCH for \$8 million in bank qualified financing through the County. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Abariotes gave an update on the Washington County East building. The three offices have met to coordinate the move. The final inspection should be the week of May 19<sup>th</sup>. The Board discussed what the building should be called and also discussed having Judy Rohwer, who designed the County Flag, design the seal to be displayed on the building. Once the name is finalized, a sign will be ordered and placed at the building.

Board of Equalization: It was moved by Miller and seconded by Thomsen to enter in Board of Equalization. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Steve Mencke, Co Assessor and Ann Therkelsen were present. Mencke went over the Valuation Changes. The Board discussed the interior finish of out buildings and when a building permit is needed. It was moved by Kent Wilcox and seconded by Quist to approve Valuation Changes. Board received correspondence from Paul & Becky Meyer questioning Greenbelt Policy that was passed in 2000 and asking for a waiver on the policy so they can apply for greenbelt. The policy listed events that disqualified agricultural property previously greenbelted. Property that is in subdivisions was one of the disqualifications. Two other properties in the subdivision have greenbelt. The two properties had the greenbelt before the Resolution was passed, so were grandfathered in. Motion by Miller second by Quist to deny the request for a waiver of greenbelt policy. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller and Rohwer. Nay: Abariotes. Motion carried.

Motion was made by Kent Wilcox and seconded by Miller that the Board adjourn from Board of Equalization and reconvene in regular session. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Craig Nelson & Larry Pelan were present to discuss extending the County's NIRMA Insurance Policy through June 09. The County's initial three year contract will expire in Sept 1, 2008. NIRMA insures 78 Nebraska counties and the bulk of these Counties renew on July 1, to coincide with the budget year. Pam Daly asked questions about dividends and requested a total of all claims paid. Motion by Abariotes second by Kent Wilcox to extend the County's NIRMA Insurance Policy through June 2009 with Resolution 2008-11. Vote-Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

#### **SECTION 5.02 FINAL PLAT REQUIREMENTS**

- 1. The subdivider shall have prepared at least 20 copies of a final plat, at the same scale as the preliminary plat, and shall submit the plat to the County Planning
  - Department, in addition to the original reproducible drawing on tracing cloth or similar material bearing the original signatures for the required certifications. These documents shall be submitted to the County Planning Department not less than 17 days prior to a scheduled Commission meeting at which time the plat will receive consideration. The final plat will contain and show the following:
  - a. Name of subdivision, scale, north arrow and date.
  - b. Location of control points and descriptions and "ties" to such control points, to which all dimensions, angles, bearings, and similar data on the plat shall be referred. The controls shall be referred to permanent section or quarter section corners.
  - c. Tract boundary lines, right-of-way lines of streets, roads, easements and other rights-of-way and property lines of residential lots and other sites; with dimensions, bearings or deflection angles, and radii, arcs, and central angles of all curves.
  - d. Name and right-of-way width of each street, road, or other right-of-way.
  - e. Location, dimensions and purpose of any easements.
  - f. Number to identify each lot or site.
  - g. Minimum building setback line on all lots.
  - h. Location and description of monuments.
  - i. Certification by a registered land surveyor.
  - j. A notarized certification signed and acknowledged by all parties having any titled interest in, or lien upon the land to be subdivided consenting to the final plat including the dedication of parts of the land for streets, easements, and other purposes.
  - k. A certification signed by the County Treasurer stating that there are no regular or special taxes due or delinquent against the platted land.
  - 1. A certification for the approval of the Commission.
  - m. A certification for the approval of the Board to be signed by the Board Chairman and attested to by the County Clerk.
  - n. Location description of the subdivision by the section, township, range, County and State and including metes and bounds description for the boundaries of the subdivision.
  - o. Lot area.
  - p. Lots and blocks numbered numerically.
- 2. Not less than 10 days prior to a scheduled Commission meeting at which time a final plat will receive consideration, the following shall have been provided to the
  - County Planning Department: correspondence from the County Surveyor,
  - County Highway Superintendent and Building Inspector (regarding the subdivision wide perc tests).
- 3. After consideration and review by the Commission the final plat and the Commission's recommendation will be submitted to the Board within sixty days of the Planning Commission public hearing.
- 4. The Board will consider the final plat at a public hearing.

I. Subdivision Regulation Revision

## SECTION 2.05 REPLAT OF A SUBDIVISION

#### 2.05.01 Replat Defined

For the purpose of this Section, a replat is defined as the act of: increasing the number of lots; changing the boundaries of an approved outlot or green space area; or changing the configuration of a platted street or public right-of-way; all in a recorded subdivision to achieve a reconfiguration of an existing subdivision.

#### 2.05.02 Replat of a Subdivision

In the event that a proposed replat of a subdivision does not involve a change in subdivision type or a change in zoning district, an applicant (owner) shall apply for a replat under the provisions of this Section. The utilization of a replat does not relieve the applicant (owner) of the obligation to comply with standards and improvements in these Regulations. The necessity of establishing and dedicating easements for utilities shall not bar the utilization of a replat.

#### 2.05.03 Replat Submission Requirements

Application for a replat shall be made to the Planning Department under the procedures as outlined for a final plat.
