

**May 27, 2008 Minutes**

The Washington County Board of Supervisors of Washington County, Nebraska, met in Regular session at 9:30 a.m. on Tuesday, May 27, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Daryl Miller and Ernest Abariotes. Absent: Kent Wilcox and Marvin Rohwer. Also present, County Clerk Merry Truhlsen. Chairman announced Kent Wilcox and Marvin Rohwer will be gone all day.

It was moved by Abariotes and seconded by Miller that the rules be suspended and that the minutes of the May 12, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

It was moved by Abariotes and seconded by Miller that the rules be suspended and that the minutes of the May 20, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

The following correspondence had been received: Letter from Dept of Revenue-March Lodging Tax was \$1240.88, NIRMA Quarterly Loss Report, Letter from Wash Co Bank offering their services with permanent financing for the former Eagles building and a letter from Co Atty's office regarding the probation office space. It was moved by Abariotes and second by Quist that correspondence and reports be placed on file. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, was present with the following items: Bill and Celeste Lux were present. Lux received a building permit for an outbuilding and needs a new driveway to reach the building. Parsons read a Restricted Driveway Access waiver prepared by the Dep County Attorney. The sight distance on this driveway is restricted. The Board discussed a lack of communication between County Departments in allowing the building permit where a second driveway was needed. Motion by Miller second by Thomsen to approve the driveway approach, with the County and the Luxs signing the waiver. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Stalp Gravel Co and Lyman-Richey Sand & Gravel Co Inc submitted Gravel bids for Fiscal Year 2008-2009. Parsons read the bids. Glen Schuetze from Stalp Gravel discussed hauling charges and said the south end of the County was hard for them to haul to with the cost of fuel. Board decided to use both companies as they have in the past. Motion by Quist second by Abariotes to accept both Gravel bids to be used at the discretion of the Road Supt, using Stalp Gravel in the northern part of the County and Lyman-Richey in the southern part of the County. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Please contact the Road Dept for specific prices quoted.

One Rock bid for Fiscal Year 2008-2009 was received from Cemex. Parsons read the bid. Motion by Miller second by Thomsen to accept Rock bid of Cemex. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Please contact Road Dept for specific prices quoted.

At 10:00 AM, a public hearing to close the South ½ of Georgia Street in Fontanelle located in TL 44, Sec 17-18-9 was held. Motion by Miller second by Abariotes to open public hearing. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Delford and Beverly Brandt, owners of the property were present. Road Supt Parsons read the results of the Road Study which recommended closure and abandonment of the Road. Parsons next read Resolution 2008-15. There were no comments from the public. Motion by Abariotes second by Quist to close public hearing. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Motion by Abariotes second by Quist to adopt Resolution 2008-15 closing road. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

ROAD STUDY ON THE SOUTH ONE-HALF OF  
GEORGIA STREET

A study regarding the possible closure or abandonment of the South One-Half of Georgia Street in the original Town of Fontanelle, Washington County Nebraska, located between an existing North-South Road running through Tax Lot #44 in Section 17, Township 18 North, Range 9 East of the 6<sup>th</sup> P.M. in Washington County, Nebraska.

After careful study of this area, I found that Georgia Street has not been maintained by Washington County Road Department for many years and no physical evidence of this road exists. Georgia Street is not part of the road system that is currently under the Village of Fontanelle's maintenance schedule. In fact, the road in question is farm land and an area of large trees & a ravine.

I, notified five (5) adjacent property owners by certified mail and all responded with return certified mail regarding the scheduled public hearing. If there are no valid objections, I therefore, recommend the closure and abandonment of the South One-Half of Georgia Street in the original Town of Fontanelle, Washington County, Nebraska.

At 10:15 proposals for Culvert purchases for Fiscal Year 2008-2009 were opened. Five bids were received: B's Enterprises Inc, Contech Construction Products Inc, Metal Culverts Inc, Midwest Service and Sales Co and Ace Irrigation. After bids were opened and read, Road Supt asked to study the culvert proposals, check the figures and report back to the Board later in the day. Motion by Quist second by Abariotes to have Road Supt check the figures and report back to Board. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Wayne Landen, Bill Lux, and Melissa Rice were present to give the Board the Animal Control Committee Report. Figures reflect the time period of October 2007 to May 27, 2008. Thirteen dogs were received by the Blair Animal Shelter and 11 were adopted. The County has paid out \$2,030.00, collected \$561.00 for a net cost of \$1,469.00. Motion by Abariotes second by Thomsen to receive Animal Control Report and place on file. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Landen requested the Animal Control receive the same budget allowance for next year. The Board said they would keep this request in mind and asked them to submit their request in writing. Thomsen thanked Mr Landen and Committee for the extensive time and work they have put into this project.

Road Supt Parsons had received a request from Mitch McGowan to remove dirt from the existing Right of Way along CR P32 to help provide a bus loop. Parsons contacted the Nebr Dept of Roads and was told the applicant would be dealing with both the NDOR and the Fed Gov and there would be fees involved. The NDOR e-mail stated "The County is required to protect and maintain the project as it was designed and built, per the Program

Agreement. Removal of any of the engineered fills is not permitted or advisable, unless properly justified.” Motion by Abariotes second by Miller to receive information and place on file. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Parsons came back to the Board with confirmed figures on the culvert bids. Motion by Quist second by Thomsen to accept the low bid of Midwest Service and Sales for Spiral Pipe and Bands and accept the low bid of B’s Enterprises for Riveted Pipe. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Bid tabulations available for Public Inspection at Road Supt Office.

At 11:00 bids were received to prepare the 2007-2008 annual audit for Washington County. Bidders were requested to set forth audit options for one year, two years or three years. Three bids were received: Countryman Assoc, PC; Dana F Cole & Co LLP; and Goracke, Ritterbush & Piotrowski, LLP. Clerk read the bids. Motion by Miller second by Thomsen to refer bids to budget committee to review and give Board a recommendation at the June 10<sup>th</sup> meeting. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Terry Hansen, PC Services, presented a proposal to the Board for the County’s Computer System called Virtual Administrator Proposal. PC Services has software to monitor and track critical functions of our computer system. Hansen had previously presented this to the County Officials and they recommended he address the County Board. Phil Brazelton was present and said there is a similar contract with Interact for the Communications equipment. Motion by Miller second by Abariotes to refer this to the IT/GIS committee and have them make a recommendation to the Board. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Board of Equalization: It was moved by Miller and seconded by Thomsen to enter in Board of Equalization. Steve Mencke, Co Assessor and Jean Ray were present. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Motion by Abariotes second by Quist to approve Corrections #6427 through #6431 as presented by the county Assessor. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

It was moved by Quist and seconded by Abariotes to approve Valuation Changes as presented by the County Assessor. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Motion was made by Miller and seconded by Thomen that the Board adjourn from Board of Equalization and reconvene in regular session. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

Motion by Quist second by Thomsen to recess for lunch. All members present voted aye.

Phil Lorenzen, with DA Davidson & Co, has been working with the Board to secure a permanent loan for the Washington County East Annex building, formerly known as Eagles Bldg. Lorenzen recommended at the June 10<sup>th</sup> meeting, the Board authorize renewal of the note held by Two Rivers State Bank and also authorize a Reimbursement Resolution relative to the Washington County East Annex financing. Lorenzen will meet with the finance committee.

Jeff Burianek, has applied for a One Day Liquor License on June 28<sup>th</sup>, a fundraiser for Arlington Youth Sports, for a tractor pull at the County Fairgrounds. All their paperwork was in order. Clerk read Resolution 2008-16. Motion by Miller second by Thomsen to adopt Resolution 2008-16. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.

WHEREAS, Arlington Youth Sports, has filed an application for a Special Liquor Permit to dispense alcoholic beverages at the Washington County Fairgrounds, Arlington, Nebraska:

BE IT RESOLVED THAT the Washington County, Nebraska, Board of Supervisors hereby approves the application of Arlington Youth Sports, and grants permission to use the specific area designated in said application for the hours of 12:00 o'clock P.M. on June 28, 2008 to 1:00 o'clock A.M. on June 29, 2008 for the purpose of dispensing of the alcoholic beverages on said premises; provided however, applicant or its agents shall not enter the premises or dispense alcohol until a Release and Hold Harmless Agreement is executed and delivered in form satisfactory to Washington County and a Certificate of Insurance is on file with the Washington County Clerk showing that Applicants have a commercial general liability insurance policy with limit of liability not less than \$1 Million of combined single limit per occurrence and showing Washington County, Nebraska, as an additional insured.

Abariotes had gotten an estimate from The Sign Depot for the following signs: County Seal for building peak= \$174.63, Sign by road= \$414.57, Probation Office sign= \$65.44, Vinyl door graphics= \$26.66, for a total of \$681.30. Motion by Quist second by Miller to authorize Abariotes to order signs from The Sign Depot. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. The Extension Office is moving in. The Health and Human Services have requested the County move them to the new building and this is being discussed with the Fremont office and the Co Atty office. Roger Gilliland was present to discuss custodial aspects of the new building. Motion by Quist second by Thomsen to have Gilliland line up people to clean the building and get trash service started. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried. Mowing was also discussed.

The Clerk had a question about the amount of insurance the County's Resolution states for One Day Liquor Permits. Clerk had talked to Larry Pelan with NIRMA as to whether \$1 million or \$2 million should be required and wanted to check with the Board. Board instructed Clerk to ask NIRMA to clarify wording and amount of insurance needed on the Resolution.

Clerk asked what dates would work for the Board to meet for Board of Equalization. After discussion, June 30, July 18 and July 24 were picked as possible dates, should the Board need extra days.

Claims were received and reviewed, after which it was moved by Miller and seconded by Thomsen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Thomsen, Quist, Wilcox, Miller & Abariotes. Nay: None. Motion carried.
