The Washington County Board of Supervisors of Washington County, Nebraska, met in Regular session at 9:30 a.m. on Tuesday, June 24, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Kent Wilcox, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Also present, County Clerk Merry Truhlsen.

It was moved by Miller and seconded by Quist that the rules be suspended and that the minutes of the June 10, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The following correspondence had been received: Letter from Dept of Revenue-April Lodging Tax was \$1332.16, letter of resignation from Michael Dwyer, received new Open Meetings Act poster and notice of Public Hearing from Saunders County. It was moved by Rohwer and second by Miller that correspondence and reports be placed on file. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, was present with the following items: At the Road Committee meeting, the road to the quarry, CR P30, is needing repairs. CEMEX had discussed using shale to build the road up. The Road Committee asked HWS Engineering to give an estimated cost for the engineering for CR P30 improvements. HWS did not recommend using shale on this road. Motion by Quist second by Rohwer to table action on this until the afternoon and discuss with Julie Ogden. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons had contacted JEO Engineering regarding a problem with a culvert extension on CR P17 (South of CR4) and read through the Scope of services and proposed fees Ogden submitted for this project. Motion by Abariotes second by Quist to table this agenda item until afternoon to discuss with Julie Ogden, JEO. Vote-Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Parsons had been asked to do a speed study on CR9 between CR32 and Bell St, Arlington. As a result of the study, Parsons proposed the following Resolution, placing a 45 mph Speed Limit on CR9. Parsons read Resolution 2008-19. Motion by Kent Wilcox second by Thomsen to adopt Resolution 2008-19. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons discussed setting the Townships' Cost Per Mile Rate for 2008-2009. Last year's rate was \$1,340 per mile and Parsons proposed a 5% increase.  Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller and Rohwer. Nay: Abariotes. Motion carried.

Next, Cook reviewed the Resolution Providing for Individual Lot Erosion Control. Julie Ogden, engineer, was present. Recommendation from the Planning Commission was that the resolution be approved with the following change: "applies to any residential structure, including manufactured, modular, stick-built and relocated homes throughout the County; and to greater than 576 square feet accessory buildings in platted subdivisions. The following would be exempt: residential additions and accessory buildings not in a platted, named subdivision." County Attorney Graeve was present and went through some changes to clarify the wording. Ogden explained aspects of the Resolution. Eileen Stamp spoke about the Planning Commission action and the concerns of soil erosion. Board said they thought this Resolution would apply to regulating property in platted subdivisions, where most of the problems have occurred, but didn't want it to pertain to agricultural areas. Ogden said as it is written now, these restrictions apply to any new residential structure in the County. Cook suggested a compromise, and proposed this Resolution would apply to platted subdivisions only and if in the future there are problems in rural areas, this could be expanded. Paul Cerio asked if this compromise would be consistent with the Stormwater Policy or are we subverting the Stormwater Policy in lieu of making a compromise so the resolution can be passed. Chairman Wilcox said we need this Resolution to enforce the Stormwater Policy. Pam Daly said since the concern is protecting water from run off, why not make this applicable to any home built within a certain distance of surface water. Cook suggested Resolution be continued to the July 8th Board meeting to allow time for this to be redrafted, then sent through the County Attorney's Office and Ogden for clarification, and the Board as to where this applies. Cook then restated his compromise position and proposed this Resolution would apply only to: new homes in platted named subdivisions and new accessory buildings that exceed 576 square feet in size located in platted named subdivisions. Motion by Thomsen and second by Quist to continue this to the July 8th meeting to allow time for Resolution to be redrafted with Cook's compromise position and changes in wording and that document be approved by County Attorney and Julie Ogden, engineer. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller and Rohwer. Nay: Abariotes. Motion carried.

Cook next discussed the Resolution Providing for the Review of Drainage Studies, Erosion Control Plans and a Schedule of Fees. This has been approved by the Planning Commission. The fees could be adjusted on an annual basis. It was determined there was a need for clarification in the wording in this document also. Motion by Thomsen second by Quist to continue this Resolution to the July 8th meeting to allow Planning Administer time to make the suggested changes and work with County Attorney and Julie Ogden, engineer. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Board discussed the morning agenda item that was tabled in regard to the HWS Engineering on CR P30 improvements. Ogden agreed with HWS that she would not recommend using shale on CR P30. Motion by Abariotes and second by Kent Wilcox to have Road Supt Parsons and Quist contact HWS Engineering for further discussion on road improvements for CR P30 and bring it back to the Board. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Board next discussed the culvert extension on CR P17 that was tabled earlier. Ogden discussed proposed repairs and recommended re-establishing the ditch to stop further erosion. Ogden stated bidding this project at the same time as CR P26 would save costs. The estimated proposed fees are: Final Design-\$5,180 (hourly), Bidding & Negotiation-\$1,975(hourly), Construction Phase (including RPR)-\$2775(hourly), Post-Construction Phase-\$390. Estimated total=\$10,320. Motion by Quist and second by Abariotes to hire JEO to do engineering on this project on CR P17 and try to coordinate this with the engineering on CR P26. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Abariotes reported on the Wash Co East Annex and handed out information from Schemmer that outlined the LEED consideration items that were incorporated into the construction. Abariotes also discussed landscaping. Dennis McCormick was pleased with the LEED report on the WCE Annex and wondered if the Maintenance Dept had received bids to switch to energy saving lighting at the Courthouse. Pam Daly asked if McCormick's question on ballasts for the Courthouse had been answered. Motion by Kent Wilcox second by Quist to have Bldg & Grds committee work with Maintenance Dept to get written proposals for energy efficient lighting for the Courthouse. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Pam Daly stated she wanted to record the vote on video camera but didn't have a chance to do that. Board revoted and she was able to video the vote tally board.

Comments from public: Paul Cerio asked what the status was of the Public Resolutions that he and Pam Daly had drawn up. Pam Daly asked if they were going to be put on the July 8th Board meeting. Pam Daly and Eileen Stamp discussed the problem of musk thistles.

Board of Equalization: At 3:00 P.M., it was moved by Miller and seconded by Quist to enter in Board of Equalization. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Steve Mencke, Co Assessor and Jean Ray were present. See separate Board of Equalization minutes. At 4:00 P.M., motion was made by Miller and seconded by Quist that the Board adjourn from Board of Equalization and reconvene in regular session. Vote- Aye: Thomsen, Quist, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Claims were received and reviewed, following which it was moved by Miller and seconded by Quist that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same.
