The Washington County Board of Supervisors of Washington County, Nebraska, met in Regular session at 9:30 a.m. on Tuesday, July 22, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Daryl Miller and Marvin Rohwer. Absent: Ernest Abariotes and Kent Wilcox. Also present, County Clerk Merry Truhlsen. Chairman stated Abariotes will be gone all day and Kent Wilcox will be present for the afternoon session.

It was moved by Quist and seconded by Thomsen that the rules be suspended and that the minutes of the July 8th 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer Nay: None. Motion carried.

The following correspondence had been received: Letter from Dept of Revenue-May Lodging Tax was \$1275.35, Letter from Daniel Evans, Field Rep for Jail Standards Division confirming August 20 inspection, and letter from Rebecca Versch, Ext Office. It was moved by Thomsen and second by Quist that correspondence and reports be placed on file. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer Nay: None. Motion carried.

Cheryl Parsons, Road Supt, discussed improvements on Co Road P30 (Quarry Road). Dan Nixon, Cemex, was present. Parsons read a letter from HWS Consulting Group with their recommendations. At the Road committee meeting Quist said they discussed repairing the areas of failure this fall, let them stabilize and reassess the situation in the spring. Motion by Rohwer second by Thomsen to approve necessary repairs on Co Road P30. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, had been working with the Road Committee and Cargill on Project C89 (455), on Co Rd P35A, Cargill Road. Dep Co Atty Talbot, Ron Woracek and Kevin Hall, Schemmers, and Scott Larsen, Cargill, were present. Talbot discussed the changes that had been made on the Cost Sharing and the Temporary Easement Agreement. Paul Cerio asked questions about the ownership of the road and the cost of the project. Motion by Quist and second by Rohwer to approve cost sharing agreement on C89(455) between Cargill and Washington County and authorize Chairman to sign, subject to receiving a signed copy from Cargill. Vote-Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. Motion by Quist second by Miller to approve a temporary easement between Cargill Corp and Washington County and authorized Chairman to sign, subject to receiving signed cost sharing agreement and signed easement agreement from Cargill. Vote-Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer Nay: None. Motion carried. The next item was awarding the contract for Road Improvements on C89 (455) Cargill Road. Motion by Quist and second by Thomsen to award the contract for road improvements on C89 (455) and authorize Chairman to sign, subject to receiving the signed cost sharing agreement and temporary easement from Cargill. Vote-Aye:

Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. (Later in the meeting, this motion was clarified to specify the contract was awarded to the low bidder of Chas. Vrana and Son Construction Company for \$599,761.50.) Paul Cerio asked about the length of the road and the portion owned by County and Cargill. In rechecking the figure, the total footage in the cost sharing agreement was incorrect. Motion by Rohwer second by Thomsen to amend the cost sharing agreement, page 1, item 1, to correct the distance of the road from 2,823 feet to 2,843 feet. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. The final document in regard to this project was an amended engineering agreement. Motion by Quist second by Miller to approve Supplemental Agreement with Schemmer & Assoc for Construction Engineering on C89 (455) Cargill Rd and authorize chairman to sign, subject to receiving signed copy of the cost sharing and temporary easement agreement from Cargill. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

County Treas, Marj Hoier discussed using credit cards at their office. She had talked to Dave Johnson, with First Nat Merchants, Washington County Bank. Hoier determined, because the County would be responsible for the fee, using a debit/credit card is not feasible at this time. Doug Cook, Planning Dept, stated he would also be interested in being able to offer the service. Motion by Miller second by Quist to table using credit/debit cards at the Treasurers' Office at this time. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

Board had agreed to extend agreement with City of Blair regarding animal control (dogs) in the County. City sent the new agreement and Clerk read the changes. Motion by Miller second by Quist to refer the new contract to the Animal Control Committee for their approval before the County Board acts on the contract. Vote-Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

Chairman read a letter from the Deputy County Attorney in regard to the public resolutions submitted by Pam Daly and Paul Cerio. First resolution discussed was in regard to having night meetings, submitted by Daly. Robbin Jeffrey asked if the resolution was approved what the next step would be. Rohwer stated many of their committee meetings are at night and the scheduling is based on what the requirements are. Paul Cerio stated the resolutions were submitted because both ideas were presented earlier to the Board and met with resistance. Pam Daly talked about South Dakota county board meetings and went over statements given at a previous meeting. Chairman Wilcox stated they were not going to have a lengthy discussion about the pros and cons of night meetings again and that the only thing the Board was acting on today was to adopt or not adopt the resolution. The Board may choose when to hold meetings and this vote is not saving they can't hold night meetings if they choose. Motion by Rohwer and second by Miller to not adopt "A Resolution Providing For Evening Board Meetings" as submitted by Pam Daly. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. The next item discussed was a resolution in regard to the County's website. Rohwer stated the idea to improve the website is good and said progress is being made but didn't feel a broad resolution was needed. Cerio repeated the reason these resolutions were submitted because he felt the Board was dragging their feet. Mike Ryan suggested forming a committee with computer intelligent people. Robbin Jeffrey spoke about Fort Calhoun City's website. Dennis McCormick asked a question. Pam Daly commented about the Board not approving the resolutions. Motion by Rohwer and second by Quist to not adopt "A Resolution Providing for More Complete Government Information And Transaction Capability Via The Internet County Website" as submitted by Paul Cerio. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

At 11:00 AM, a Public Hearing on two erosion resolutions was held. Doug Cook, Planning Administrator gave opening remarks. Cook first addressed the Resolution Providing for the Review of Drainage Studies, Erosion Control Plans and a Schedule of Fees Relating to Subdivision Development. Resolution says the County's hired engineer firm will review and provide comments on a developer's drainage study with the cost of that being paid entirely by developer. If approved today the Planning Dept will send notice to developers notifying them of this change. Cook is asking this Resolution go into effect as soon as possible. Cook next addressed the Resolution Providing for Erosion Control on Lots in Platted, Named Subdivisions. Briefly stated, building

permit applicants will be responsible for erosion control on lots in platted, named subdivisions, and those plans will be part of the building permit application process, with the cost being paid by the building permit applicant. Cook is asking this Resolution go into effect September 1, to allow time for the Planning Dept to notify home builders of this change and increased costs and to allow them time to figure the costs into their bidding process. Cook stated the Planning Commission, Planning Administrator, County Attorney's Office and County's engineer all ask that you adopt these Resolutions. Quist questioned the fees involved and suggested reevaluating the fees periodically. Motion by Miller and second by Thomsen to open public hearing. Vote-Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. Mike Ryan said he is enthused this County is taking the first steps to implement the Stormwater Policies which the committee drafted. He stated organizations and individuals are taking note of the County's commitment to use low impact development. Robbin Jeffrey discussed estimated fees and penalties involved for violations. Kevin Probst thanked the Board for bringing the resolutions forward. Jeff Mabry wondered if these Resolutions could apply to subdivisions already in place and penalties be retroactive. Dep Co Atty Talbot stated the policies are proactive. Mabry discussed the problem of run off in his yard and asked the Board to contact the NDEQ to come assess his situation. Pam Daly stated she felt the Resolutions should both go into effect immediately. Mabry asked if the resolutions would apply to new paving on the roads in a previously approved subdivision. Ogden stated if there were previously approved plans and the developer deviated from them, that is a separate question. Mabry asked Planning Dept and Co Atty's Office to look into the original plans for the subdivision to see if they were followed. Cook and Talbot said they would look into it. Paul Cerio asked the Board to have Planning Dept, Co Atty and engineer look into this matter. Chairman stated they have already agreed to do this. Robbin Jeffrey was concerned about the cost involved to the County to mail out notices and asked the County, once again, to sue the NDEQ. Cook stated these resolutions will be posted on their website and Cook again stated the reason for the Sept 1 effective date was to allow home builders time to figure the increased costs this resolution carries into their bidding process. Pam Daly disagreed. Quist questioned the method used to measure run-off. Ogden stated she used the calculation method used by the City of Omaha. Motion by Quist second by Miller to close public hearing. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried. Motion by Quist and second by Thomsen to approve Resolution 2008–24, A Resolution Providing For The Review Of Drainage Studies, Erosion Control Plans And A Schedule Of Fees Relating To Subdivision Development. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller and Rohwer. Nay: None. Motion carried.

FINAL DRAFT 07-22-2008 RESOLUTION NO. 2008 - 24

A RESOLUTION PROVIDING FOR THE REVIEW OF DRAINAGE STUDIES, EROSION CONTROL PLANS AND A SCHEDULE OF FEES RELATING TO SUBDIVISION DEVELOPMENT

The Board of Supervisors of Washington County, Nebraska, hereinafter the 'Board', recognizes that:

- 1. It is in the interest of the public's general welfare that County construction activity minimize soil erosion and that County erosion and sediment control regulation is appropriate.
- 2. The Board through Resolution # 2007-21, that among other items, employs the services of a Nebraska Licensed Professional Engineering Firm to review National Pollution Discharge Elimination System (NPDES) Permit Applications, Erosion Control Plans, Storm Water Pollution Prevention Plans (SWPPP), as well as onsite reviews of developers implementation of those plans.
- 3. All of the costs incurred by the County's hired Nebraska Licensed Professional Engineering Firm are necessary to verify compliance with Resolution # 2007-21 and this Resolution; and on Exhibit A, which is attached to and incorporated herein, are listed estimated fees for the costs of such services performed by the County's hired Nebraska Licensed Professional Engineering Firm based on the number of acres involved. The Board will review these fees on an as needed basis for any adjustments that may be necessary.
 - 4. The fees referenced in paragraph 3 are to be paid by the developer. These fees are estimates

and the developer will be responsible for paying any additional cost. Only the actual cost of the reviews outlined in this Resolution will be charged to the developer. Any un-used fees (principal only) as determined by the County's hired Nebraska Licensed Professional Engineering Firm will be refunded to the developer. The County Planning Department will collect the estimated fees at the time a final plat application is submitted to the County Planning Department.

- 5. There is to be no construction activity, such as dirt moving or grading until the County's hired Nebraska Licensed Professional Engineering Firm has provided written approval to the County Planning Department on the subdivision development and all requirements have been satisfied and all fees have been paid as specified in this Resolution.
- 6. A one-time lot split, as per the Zoning and Subdivision Regulations, is not considered a subdivision development.
- 7. It is the developer's responsibility to notify the County Planning Department when initial (before grading) controls are in place. The County's hired Nebraska Licensed Professional Engineering Firm will then be notified to perform an initial site visit. The County's hired Nebraska Licensed Professional Engineering Firm will then notify the County Planning Department in writing if initial inspection passes and if grading can commence and building permits can be issued.
- 8. The County Planning Department and the County's hired Nebraska Licensed Professional Engineering Firm shall use a Drainage Study and Erosion Control Plan Checklist, based on the current subdivision regulations and the Douglas County Washington County Stormwater Management Policies, in order to assist the County's hired Nebraska Licensed Professional Engineering Firm and each developer regarding the County's requirements.
- 9. The County's hired Nebraska Licensed Professional Engineering Firm shall provide written comments to the County Planning Department regarding the drainage study, a minimum of 10 working days prior to the County Planning Commission meeting at which the final plat is on the Commission's agenda.
- 10. The County's hired Nebraska Licensed Professional Engineering Firm shall provide written comments to the County Planning Department stating their agreement with the SWPPP and the NPDES permit prior to any construction activity at the site.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA, that this Resolution #2008-24 and Exhibit A (attached hereto and incorporated by this reference) is hereby adopted and shall be in full force and effect from and after its adoption, publication, and filing as provided by law and all resolutions or parts of resolutions in conflicts herewith are hereby repealed.

FINAL DRAFT 07-22-2008 RESOLUTION NO. 2008 - 25 The Board of Supervisors of Washington County, Nebraska, hereinafter the 'Board', recognizes that:

- 1. It is in the interest of the public's general welfare that County construction activity minimize soil erosion and that County erosion and sediment control regulation is appropriate.
- 2. Soil erosion can occur on construction activity sites of any size, be it less than an acre or more than an acre.
- 3. Erosion and sediment control during construction activity is important and that Best Management Practices (BMP's), as defined by the Douglas County Washington County Stormwater Management Policies, shall be implemented by the building permit applicant to protect natural resources.
- 4. In order to regulate construction activity regarding erosion and sediment, an Individual Lot Notice of Intent (NOI) Form, obtained from the County Planning Department, shall be completed by the building permit applicant.
- 5. Building permit applicants must file such NOI Form as part of the building permit application process. No building permit will be issued until the applicable NOI fees have been paid and the NOI has been approved by both the County Planning Department and the County's hired Nebraska Licensed Professional Engineering Firm.
- 6. In order to enforce the NOI requirements and to verify that erosion control measures are properly installed and maintained throughout a construction activity project, the County has hired a Nebraska Licensed Professional Engineering Firm to conduct site visits to verify compliance with the NOI.
 - 7. Storm water is defined as water that originates during precipitation events.
- 8. The costs incurred by the County's hired Nebraska Licensed Professional Engineering Firm for erosion control review on a lot in a platted, named subdivision shall be paid by the building permit applicant. This Individual Lot Erosion Control Fee (ILECF) is \$200 per visit with 4 visits being the estimated minimum number. Should more visits be necessary, the building permit applicant is responsible for paying such fee. The County Planning Department will collect the \$800 ILECF at the time the NOI is applied-for. This \$800 (minimum 4 visits) is detailed as follows: (1) before grading; (2) interim, after a storm water event; (3) interim, after a storm water event; (4) at end to verify ground cover established. A home will not be granted occupancy, or a non-residence a passed final inspection by the County Building Inspector \ Planning Department until all County permit requirements have been met and the County's hired Nebraska Licensed Professional Engineering Firm has provided written approval to the County Planning Department that all requirements have been satisfied and all fees have been paid. Any un-used fees (principal only) as determined by the County's hired Nebraska Licensed Professional Engineering Firm will be refunded to the building permit applicant.
- 9. It is the building permit applicant's responsibility to contact the County Planning Department when initial (before grading) controls are in place. The County's hired Nebraska Licensed Professional Engineering Firm will then be notified by the County Planning department to perform a field check (visit (1) above before grading). The County's hired Nebraska Licensed Professional Engineering Firm will then notify the County Planning Department in writing that the initial inspection passes and grading and building permit inspections can commence.
- 10. In addition to the County's hired Nebraska Licensed Professional Engineering Firm inspections as listed above, the County's designated Building Inspector shall review the erosion control

measures when performing building inspections. The Building Inspector shall report to the County Planner any problems.

- 11. The Board deems that this Resolution shall apply only in the following situations:
- a. any residential structure, including manufactured, modular, stick-built and relocated homes in platted, named subdivisions;
- b. accessory buildings (barns, sheds, pole buildings, etc.) in platted, named subdivisions and only when the accessory building exceeds 576 square feet in size.
- 12. The Board deems the following shall be exempt from this Resolution:
- a. additions to homes (residential additions);
- b. accessory buildings (sheds, barns, silos, etc) not in a platted, named subdivision; and
- c. any residential structure, including manufactured, modular, stick-built and relocated homes not in a platted, named subdivision.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA, that this resolution is hereby adopted and shall be in full force and affect from and after its adoption, publication, and filing as provided by law and all resolutions or parts of all resolutions in conflict herewith are hereby repealed.

Washington County Subdivision Regulation Text Amendment

Article 4: Preliminary Plat, Section 4.02 Preliminary Plat Requirements Revise Section 4.02 to read as follows:

SECTION 4.02 PRELIMINARY PLAT REQUIREMENTS (revised 08-28-2007)

1. The subdivider shall have prepared at least 20 copies of a preliminary plat at a scale of 1-inch equal's 200 feet and preferably at 1 inch equals 100 feet and shall submit the plat to the County Planning Department not less than 17 days prior to a scheduled Commission meeting at which time the plat will receive consideration. If an application is submitted to the County Planning Department less than 17 days (not including the date submitted or the date of the Planning Commission meeting) prior to a scheduled Commission meeting, it shall not be placed on the Commission's agenda. The application can be resubmitted to the County Planning Department for Commission action when the application deadlines are met.
