### August 26, 2008 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, August 26, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Wilcox, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Jeff Quist absent. Also present, County Clerk Merry Truhlsen. Chairman stated Jeff Quist will be gone all day.

It was moved by Miller and seconded by Abariotes that the rules be suspended and that the minutes of the August 12, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The following correspondence had been received: Dept of Rev, June Lodging Tax = \$1,530.47 and information from the Nebr Emergency Management Agency (NEMA) updating County Boards on efforts being made to improve local and regional emergency communications systems. Chairman said he had received a letter from the City of Blair saying the lawsuit on the Industrial Tract had been dropped. Motion by Rohwer and second by Kent Wilcox to receive correspondence and place on file. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Judge John Samson, was present to request Washington County's participation in the District 16 Drug Court. Also present were Co Atty, Shurie Graeve, Robert Denton and Patty Lyon. Drug Court is a criminal justice response to non violent crimes which occur because of drug and alcohol abuse. The components of drug court are intensive supervision, frequent drug testing and accountability. Drug court is the step between supervision and the penitentiary and is not for violent offenders. This program was started in December 2007, is funded by the Supreme Court and typically is an eighteen month program. The cost to the County would be a prorata share of the defense Attorney fees and occasional mileage for Co Atty. Samson stated the drug court has exceeded his expectations on how successful it has been since December. Denton stated Washington County needs to enter into an Interlocal Agreement with the Probation Office. Graeve asked the Board to wait to sign the Interlocal Agreement but did ask the Board for their vote as to whether they supported Washington County's participation. Graeve stated she is generally in favor of the Drug Court but was disappointed it wouldn't be held in Washington County. Dennis McCormick spoke in support of this. Motion by Kent Wilcox and second by Miller to vote in favor of the concept of Drug Court with further details to be worked out. Vote-Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Cheryl Parsons, Road Supt. and Julie Ogden were present with the following items: Two Bids were received for Project C89(408), which is the extension of the culvert under CR P26 at the 90 degree curve the County will be working on to lengthen and make safer. The bid from ME Collins Construction Co. was \$45,061.00. The bid from Gus Construction Co. Inc. was for \$80,822.50. Motion by Abariotes second by Kent Wilcox to have Ogden review bids, check figures and report back to Board. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Next, the Board accepted Sealed Bids for culvert Project C89(479) on CR P17 to repair erosion and a crack in the culvert pipe. The bid from ME Collins was for \$41,250.50. The bid from Gus Construction was \$63,532.75. Motion by Abariotes second by Rohwer to have Ogden review bids, check figures and report back to Board. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons discussed a change order she had received for Project C89(455) CR P35A. Parsons stated the change order is to lower and replace an underground power line that was hit as the concrete was being removed from the road. The power line was right under the concrete slab. Bill Krebs, Project Manager for Vrana Construction, said typically OPPD likes the power line 24" below finish grade but this was directly underneath the concrete. Board asked if this was our cost and Parsons said she is contacting the State and OPPD about receiving help on the cost. Motion by Kent Wilcox and second by Abariotes to approve the change order in the amount of \$3,073.20. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Parsons discussed other matters with the Board: a letter to Glen Oaks Subdivision, an incident on Co Rd P41 and bridge inspections.

Ogden returned, she had checked the bids for Project C89(408) on CR P26 and the totals were correct. Motion by Kent Wilcox second by Thomsen to refer the bids to the Road Committee for their recommendation. Vote-Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Next, Ogden said in checking the bids on Project C89(455) on CR P35A, she did find a difference: total for ME Collins' bid is \$41,254.50, total for Gus Construction Co Inc \$64,352.75. Since this is an urgent matter, motion by Kent Wilcox second by Rohwer to accept the bid of ME Collins for \$41,254.50. Vote-Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

It was moved by Kent Wilcox and seconded by Miller to adopt Resolution 2008- 32, transferring \$5,125.00 from the Juvenile Intake Program fund #2500 to the Juvenile Services Grant Fund #2506. Vote- Aye: Thomsen, Kent Wilcox, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.
