The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, Sept 9, 2008 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall and that pamphlets are available. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Daryl Miller, Ernest Abariotes and Marvin Rohwer. Kent Wilcox, absent. Chairman announced Kent Wilcox will be absent all day. Also present, County Clerk Merry Truhlsen.

It was moved by Miller and seconded by Abariotes that the rules be suspended and that the minutes of the August 26, 2008 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Quist abstained. Motion carried.

It was moved by Abariotes and seconded by Rohwer that the rules be suspended and that the minutes of the August 18, 2008 industrial tract meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Quist abstained. Motion carried.

It was moved by Thomsen and seconded by Quist that the rules be suspended and that the minutes of the Sept 2, 2008 budget study meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

It was moved by Miller and seconded by Quist that the regular Monthly Fee Reports of the following Officials be received and placed on file: Co Clerk \$11,334.50, Reg of Deeds \$18,761.25, Co Court \$23,856.86, Clk Dist Crt \$1189.25, Sheriff \$8918.03 and Road Dept \$13,566.71. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Weed Dept. Supt. Mike Smith updated the Board on Weed Dept matters. He has sprayed along the river, checked and trimmed trees, and organized and worked at the Nebr Weed Assoc Booth at the State Fair.

Cheryl Parsons, Road Supt was present with the following items: At the Road Committee meeting, the arch culvert bid, which was referred to that committee, was discussed. Road Committee recommended the Board bid the culvert and the dirt work together. Board requested Parsons have Julie Odgen, engineer, phone so they could discuss this with her.

Parsons discussed equipment for the Road Dept. The Board discussed purchasing a new motorgrader, or a new and a used motorgrader, or perhaps purchasing two used motorgraders. Parsons will advertise and have the specs ready to mail as they are requested. Motion by Quist and second by Thomsen to receive bids on

motorgrader(s) at the October 14th Board meeting, at 10:00. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Ogden phoned the Board. After discussion, motion by Quist and seconded by Rohwer to reject the bids submitted August 26th, on the Arch Culvert Ext Project C89 (408). Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Board next discussed rebidding the project. Motion by Quist and seconded by Abariotes to rebid Project C89(408) to include the Arch Culvert and the Grading of Curve. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The following correspondence had been received: Letter from E&A Consulting Group recommending payment of \$100,000 for road improvements, letter from Dept of Roads correcting County's portion on Ft Calhoun S.W. Project, e-mail from Bob Denton about the probation officer trainee position and a letter from NIRMA regarding insurance. It was moved by Abariotes and seconded by Rohwer that the correspondence be received and placed on file. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

County Treasurer, Marj Hoier presented the Board with a listing of all the delinquent real estate taxes in Washington County (listing also includes special assessments). The Board received the list and placed on file in the Clerk's Office. Hoier also presented a Motor Vehicle Exemption application for St Paul's Lutheran Church. Motion by Miller and second by Thomsen to approve the exemption application. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

The Board discussed the agreement trash service transporters must sign to haul trash in the County. These agreements are effective Sept 1, 2008 through August 31, 2009. The County also requires a yearly fee, monthly tonnage reports and proof of insurance. Motion by Abariotes and second by Rohwer to authorize Chairman to sign, receive and place Solid Waste Disposal Agreements on file. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Mike Robinson, Sheriff, informed the Board of an accident involving a patrol car and discussed leasing a replacement unit. Robinson discussed the bids he had received. Motion by Quist and second by Miller to approve lease purchase of a 2008 Dodge Ram to include a 100,000 mile warranty. Vote- Aye: Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: Thomsen. Motion carried.

The annual agreement with MAPA, to administer the County's Revolving Loan Fund was discussed. Motion by Quist and second by Abariotes to approve the Annual Revolving Loan Admin Agreement for 7-1-08 to 6-30-09, at a cost of \$2,500, and authorize Chairman to sign. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Abariotes talked about the upcoming open house at the East Annex and asked how to dispose of ten interior doors left from the Eagles building remodel. Chairman phoned County Attorney's Office, they suggested they be put on a Sheriff's sale.

Jeremy Lange, member of Arlington Village Board, was present to discuss the ATV Ordinance Arlington Village passed in March 2008. Lange stated he hunts a few miles south of Arlington, but as the present laws read, ATV's can't be driven along county roads unless it is being used for farm purposes. Lange stated the ordinance has worked well in the Village. He went through some of the requirements in the statute and asked the Board to look into this statute and consider adopting similar wording for the County. The Board said they would check with the County Attorney's Office. No action was taken.

At 11:30 the Board convened as Board of Equalization. See separate minutes. Board adjourned from Board of Equalization at 11:40 and reconvened in regular session.

Sheriff, Mike Robinson was present to say the previously discussed vehicle purchase warranty was for 3 year/36,000 miles. Quist amended his motion to approve purchase of the 2008 Dodge Ram with a 3 year warranty/36,000 miles, second by Miller. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Robinson discussed financing for the vehicle. Motion by Miller, second by Thomsen to accept financing with Washington County Bank. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, and Rohwer. Nay: Abariotes. Motion carried.

At 1:00 a public hearing was held regarding the County's Cable TV Franchise Agreement. American Broadband representatives Joe Jetensky and Mike Storjohann were present. Motion by Miller second by Quist to open public hearing. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. The County's Cable TV Franchise Agreement originated in 1983, was renewed in 1998 and was scheduled to be renewed this year. After discussion with American Broadband and the County Attorney's Office, a new agreement was drawn up to be in effect for 15 years and shall automatically renew unless either County or Company give a written notice of termination. Jetensky went through the agreement. There were no comments from the public. Motion by Quist second Miller to close Public Hearing. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried. Motion by Abariotes and second by Miller to adopt Resolution 2008-36, renewing the Cable TV Franchise Agreement with American Broadband. Vote- Aye: Thomsen, Quist, Duane Wilcox, Miller, Abariotes and Rohwer. Nay: None. Motion carried.

Resolution 2008-36

A Resolution of the County of Washington, Nebraska, to establish a franchise for cable television systems in the County of Washington, Nebraska, setting forth conditions accompanying the grant of franchise, providing for County regulation and use of the cable television systems, repealing all resolutions or parts of resolutions in conflict herewith, and providing when this resolution shall be in full force and effect.
