The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, May 12, 2009 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall.

Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Clausen, Jeff Quist, Mary Alice Johnson, Ernest Abariotes and Ronald Hineline. Also present, County Clerk Merry Truhlsen.

It was moved by Abariotes and seconded by Quist that the rules be suspended and that the minutes of the April 28th meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Quist and seconded by Abariotes that the regular Monthly Fee Reports of the following Officials be received and placed on file: Co Clerk \$10,579.25, Reg of Deeds \$19,348.25, Co Court \$21,608.60, Co Plan Dept \$9,588.00, Clk Dist Crt \$1,316.33, Sheriff \$3,017.68 and Road Dept \$586.25. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Mike Smith, Weed Supt gave the Board an update on mowing and inspections..

State of Nebraska recently informed the County that Bridge C89-01510 is in need of repair or replacement. Repairing this Bridge will have a high priority as CR 15 is heavily traveled. Cheryl Parsons, Road Supt, has mailed RFPs for the engineering fees. The replacement cost, estimated at \$325,000, and the funding for the project was discussed.

Parsons reported the Road Committee recommended awarding the armor coat bid to Sta-Bilt Const. Co. Clausen stated 3 determining factors were: single pass application, no raised area in middle of road and every load of gravel is weighed. Motion Clausen second Hineline to award armor coat bid to Sta-Bilt construction Company for \$231,639.25. Vote- Aye: Thomsen, Clausen, Wilcox, Johnson and Hineline. Nay: Quist and Abariotes. Motion carried.

The State of Nebraska, in applying for federal funding, is asking for the County's approval regarding changes to three intersections on Blair South Project, Hwy 133. The intersections are on CR33, CR34 and CR36. Co Atty's Office drew up Resolution 2009-21. Motion Clausen and second Thomsen to adopt Resolution 2009-21 and authorize Chairman to sign the contract. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVIOSRS OF WASHINGTON COUNTY, NEBRASKA:

At 10:00 corrugated metal pipe proposals from B's Enterprises, Inc; Midwest Service & Sales; Metal Culverts, Inc and Contech Construction Products Inc were opened. Parsons read through the prices quoted and asked the Board if she could check the figures then return with her recommendation.

Phil Brazelton, Sheriff Communications Deputy, discussed leasing an Aeroflex Radio Test Set from Sprint Nextel to check the radio frequencies and go forward with the rebanding process. Motion Quist and second Clausen to lease the Aeroflex Radio Test Set for \$7,200, with the County being reimbursed that same amount from Sprint Nextel. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Shurie Graeve, Co Atty and Ed Talbot, Dep Co Atty were present to continue discussion of the Juvenile Diversion and Detention Program from the April 28 Board meeting. The grant money is in place to pay for the diversion-detention coordinator. The pretrial monitoring program utilizing an ankle bracelet was discussed. State Statutes provide for the diversion-detention programs once the County has a 3 year comprehensive plan. Graeve hopes this voluntary program would be a more effective criminal deterrent and educational process for first time offenders and would keep the juveniles at home rather than treating the youth in the adult criminal justice system. Motion Abariotes and second Thomsen to adopt Resolution 2009-23. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

RESOLUTION NO. 2009-23

BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS, WASHINGTON COUNTY, NEBRASKA:

WHEREAS, pursuant to <u>Neb. Rev. Stat.</u> 29-3601, et seq., the County Attorney may establish diversion-detention programs with the concurrence of the County Board;

WHEREAS, the Washington County Attorney has advised the Washington County Board of Supervisors that the establishment of a first time offender juvenile program utilizing a diversion-detention coordinator would be a more effective criminal deterrent and educational process for first time offenders rather than treating the youth in the adult criminal justice system.

WHEREAS, the County Attorney has provided the County Board with an outline of the proposed diversion-detention program.

NOW, THEREFORE, BE IT RESOLVED THAT the Washington County Board of Supervisors concurs that the first time offender juvenile diversion-detention programs as proposed by the Washington County Attorney utilizing a diversion-detention coordinator in beneficial to the juvenile justice system in Washington County, Nebraska, and hereby consents to the establishment of the first time offender juvenile diversion-detention program recommended by the Washington County Attorney. All previous diversion programs established shall merge into the program established by this Resolution.

At 11:00 Clerk opened and read the bids for Courthouse mowing and snow removal. Bids were received from Advantage Lawn Care, Tom Warren and Smithers Inc. Parsons recommended accepting B's Enterprises proposal for the riveted and spiral culvert and contact Metal Culverts to see if they would provide the bands only. Board asked Parsons to contact Metal Culverts before a decision is made.

Doug Cook, Planning Administrator, discussed moving their office to the first floor. Cook stated it would be nice to have all their maps, files and signs in one office, instead of three locations. Rick Weidner, Architect, had drawn up a preliminary floor plan. Cook went through the proposed changes of moving the door, removing some walls, new floor covering and paint. Weidner said they tried to duplicate the present office layout. Motion Hineline second Thomsen to refer plans to Building and Grounds Committee. Parsons returned to the Board meeting stating Metal Culverts declined the offer to supply the bands only. At 11:40 the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 11:50 and reconvened in regular session.

Chairman Wilcox briefly discussed LB 160. No action was taken on legislative bills.

Clerk discussed NACO's BCBS disability insurance offer. Virginia Manley, payroll clerk, had been in contact with National Insurance Services and gave the Board information about the plan. The basic plan would be funded by the County and the option to buy up would be the employee's cost. Motion Clausen and second Hineline to reject the disability insurance offer. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Notification from Nebr Tax Equalization & Review Commission that the levels of value of real property in Wash Co for tax year 2009 are satisfactory, e-mail from NACO on Revenue Committee amendments to LB213 that would change several issues related to BOE and the protest process, e-mail from Sen Rogert thanking Board for the e-mail on LB160, Ext Office Annual Report and letter from Gerald Brooks and Michael Childers regarding a bridge on CR P43. It was moved by Hineline and seconded by Clausen that the correspondence be received and placed on file. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Hineline and seconded by Quist that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Abariotes and Hineline. Nay: None. Motion carried.
