December 22, 2009 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, December 22, 2009 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Clausen, Jeff Quist, Mary Alice Johnson and Ron Hineline. Ernest Abariotes was absent. Chairman announced Abariotes would be absent all day. Also present, County Clerk Merry Truhlsen.

It was moved by Quist and seconded by Clausen that the rules be suspended and that the minutes of the December 8, 2009 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Dept of Rev October lodging tax is \$1,800.55, Letter from NIRMA awarding Wash Co a \$500 grant towards the purchase of AED-Defibrillator for the Courthouse and letter from Nebr. Loess Hills- yearly recap of 2009. Motion Clausen and second by Thomsen to receive correspondence and place on file. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, had put proposed changes on County Road P14 on the agenda as recommended by the Road Committee. Richard Hansen, Surveyor, representing Ben Rogge, stated Rogge would like to extend CR P14 and will give approximately 2 acres to the County for right of way and a cul-de-sac. Additionally, Rogge agreed to pay for the engineering, grading, rock and pay \$5,000 toward asphalt. Parsons had received an estimate of \$28,000 for asphalting the road. Parsons and Rogge discussed the option of putting a gravel road in at this time. Motion by Hineline and second by Clausen to proceed with extending CR P14, accept Rogge's property to be used for the cul-de-sac and right of way and accept the \$5,000 deposit to be put toward the cost of asphalt. Additionally, Rogge agreed to pay for the engineering of the road, grading and rock, with the County hauling the rock. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried. Motion by Thomsen second by Hineline to proceed with the vacation of approximately 1000' of the current easement and dedicate approximately 1170' of new right-of-way, with Hansen providing the legal descriptions of both. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

Motion was made by Clausen and seconded by Thomsen to designate the Enterprise and Pilot Tribune as the Official Newspapers for County Publications for 2010. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

William Burdess commented on the road meeting of December 15 concerning safety hazards on County Road P39. A copy of his comments were given to the Clerk and will also be provided to the Road Supt and Julie Ogden, engineer. Chairman thanked him for his comments.

At 10:00 a public hearing was held to hear testimony regarding the vacation/abandonment of an old county road beginning at First Street from eastern edge of Kennard to County Road 27. Motion Hineline second Thomsen to open public hearing. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried. Several people were in attendance for the public hearing. Merle Andersen commented he thought the road went beyond CR 27. David Drew, Attorney for Lance and Christy Ott, landowners to the north of the road the railroad is requesting the County vacate, addressed the Board. The Otts were working with the railroad and agreeable to the preliminary negotiations but now are objecting to the latest proposal received just last Thursday. Also, yesterday Drew received information that the railroad believes the Ott's fence is encroaching on railroad property lines. Drew requested the Board either table action on this until they have time to research property lines and work on an agreement or deny the request. Danielle Allen, Manager of Real Estate Acquisition for Union Pacific, stated she has been working with Susan Donaldson in acquiring properties in the area as part of a second main line project. Allen asked the Board what is the standard procedure for vacating right of way and stated this new information is a matter of the facts and what they found as they researched the property. Donaldson had a survey showing the property lines and gave the survey to Drew. Motion Quist second Clausen to close public hearing. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried. Motion by Clausen and second by Thomsen requesting the railroad survey, set flags and provide an aerial view on this property and table action on this until the parties reach an agreement. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

Rebecca Versch, Washington County Extension Educator, submitted a letter informing the Board of the individuals who have agreed to fill vacancies on the County Extension Board effective January 1, 2010. Dave Ruwe and Lisa Nielsen have served 2 three year terms and are not eligible for re-appointment. Tom Jackson and Marilyn Voss resigned their positions due to conflicts which prevent them from serving out the remainder of their terms. Motion by Hineline and second by Clausen to appoint Randy Jensen, Bryttni Westlake and Don Helms for 3 year terms and Connie Dunn to a 2 year term. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.

At 11:30 the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 11:35 and reconvened in regular session.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Johnson and seconded by Hineline that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Wilcox, Thomsen, Clausen, Quist, Johnson and Hineline. Nay: None. Motion carried.
