The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 11:30 A.M. on Tuesday, November 9, 2010 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. It was moved by Abariotes and seconded by Hine to approve Correction #6516 and #6517 as presented by the Assessor. Vote-Aye: Thomsen, Clausen, Wilcox, Hine and Abariotes. Nays: None. Motion carried. It was moved by Abariotes and seconded by Clausen to approve Valuation Changes for Nov 9, 2010 as presented by the Assessor. Vote-Aye: Thomsen, Clausen, Wilcox, Hine and Abariotes. Nays: None. Motion carried.

At 11:32 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Clausen and second by Hine to adjourn meeting until the next regular Board of Equalization meeting date, Nov 23, 2010. All members present voted aye, Chairman declared meeting adjourned.
