The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, April 27, 2010 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Clausen, Jeff Quist, Mary Alice Johnson, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen.

It was moved by Jeff Quist and seconded by Kent Clausen that the rules be suspended and that the minutes of the April 13, 2010 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Mike Smith reviewed the process he is using for weed enforcement. Clerk discussed moving the Weed Fund to be a function in the General Fund.

Cheryl Parsons, Road Supt, requested an emergency item be placed on the agenda. The overlay bid was let on April 13th, with one bidder, Western Engineering. Three more areas in the County have gotten bad and are in need of patching. Parsons requested the overlay patching of these areas be put on as an emergency item. 2010 Armor Coat Proposals were received at 10:00 for various locations in Washington County. One bid was received from Sta-Bilt Construction Company, Harlan, Iowa. Parsons read the bid: Prime Coat .39¢ per sq yd; Single Coat .945¢ per sq yd; Aggregate Stabilization \$3.40 per sq yd, for a total of \$150,024.96 for 10½ miles. Board discussed the bid. Rick Burchett, Sta-Bilt and Robbin Jeffrey spoke. Motion by Clausen and second by Thomsen to accept bid subject to verifying the accuracy of the numbers. Vote-Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Parsons had received a letter from Chuck Hall, Transportation Director of Blair High School requesting a traffic study of the intersection of Kings Drive and March Hare Lane, at the entrance of Looking Glass Hills, to see if a stop sign was needed. Parsons read the Traffic Study which determined stop signs were needed. Parsons next read Resolution 2010-14. Motion by Clausen and second by Quist to adopt Stop Sign Resolution 2010-14. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Parsons stated they were receiving bids for micro-surfacing 2 miles of CR15 and 3miles of CR P30. Rick Burchett, Sta-Bilt explained microsurfacing. Three proposals were received at 10:15- Sta-Bilt Construction Co \$218,070; Monarch Oil Company, Omaha \$213,397; and Ballow Construction Co Inc, Kansas \$458,410. Parsons stated the County hasn't done microsurfacing before but due to the high cost of maintenance on hard surfaced roads, they researched this, drove roads that have used this process and decided to try it. Richard Kubie spoke. Board moved on to next item while figures were being checked.

Parsons read the letter she received from Union Pacific Railroad requesting authorization to lower the hill on County Road 28 beginning 20 feet west of railroad track going west for approximately 880 feet and install warning devices. Mike Black, Union Pacific discussed the specifics of the plan. Bob Smith, Road Dept foreman stated this will improve the road. Doug Wolfe, OPPD, asked if the utility companies had been notified. Jerry Kruse spoke. Parsons said this will need to be added to the 1&6 Year Road Plan. Motion by Clausen and second by Thomsen to approve request. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Micro-surfacing bid figures were checked and verified. Burchett, Sta-Bilt and Robbin Jeffrey spoke. Motion Clausen second Thomsen to refer these bids to the Road Committee. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

The Resolution for a Stop Sign at the intersection of County Road 21 and County Road P20 was held over to the next meeting.

Marisa Ring, Manager, International Business Development for the Omaha Chamber of Commerce and Paula Hazelwood, Gateway Development discussed an opportunity to include Washington Co in the Greater Omaha Foreign-Trade Zone No. 19 Service Area. As grantee the Greater Omaha Chamber hopes to change the structure of the FTZ to the Alternative Site Framework. An FTZ is an area that is considered outside the U.S. Customs and Border Protection territory. Duty on goods imported into the zone can be reduced, deferred or eliminated. At present, any company wishing to have an FTZ designation at their facility must become a subzone, which is a lengthy, expensive process. The Foreign-Trade Zone's board has implemented a new option to streamline the process for a company to get FTZ designation. This is known as the Alternative Site Framework. This streamlined provision would be available to companies located in FTZ 19's "service area". The Omaha Chamber is working with officials in Burt, Cass, Douglas, Dodge, Sarpy, Saunders and Washington and proposing that these counties make up the FTZ service area. This would allow any business located in this territory to be eligible for the ASF streamlined process. All that is required for a County to be part of the FTZ is a letter saying they want to be included in the service area. Wilcox stated he had talked to the County Attorney's Office and she suggested they form a committee to evaluate this further. Motion by Quist and second by Clausen to form a committee consisting of Hineline, Abariotes and Johnson to evaluate the County's participation in the Service Area of Foreign-Trade Zone No. 19. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Motion carried.

Phil Brazelton, Communications Deputy, requested changing the County's 911 Service Provider from American Broadband to Qwest. Qwest handles the 911 Calls in eastern Nebraska. This change will give our Communications Dept the ability to transfer calls to other Counties. The initial cost will be \$2400 and monthly rates will be about the same as current costs. Board discussed the upgrade. Motion by Clausen and second by Thompsen to authorize changing to the Qwest 9-1-1 Service Agreement. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, and Abariotes. Nay: Hineline. Motion carried.

Arlington Youth Sports applied for a Special Designated One Day Liquor License for a Tractor Pull fund raising event at Washington County Fairgrounds. Clerk read Resolution 2010-15. Motion by Thomsen and second by Clausen to adopt Resolution 2010-15. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

RESOLUTION NO. 2010-18

A RESOLUTION APPROVING AN AMENDMENT TO SERVICE AGREEMENT BETWEEN THE COUNTY OF WASHINGTON IN THE STATE OF NEBRASKA AND THE WASHINGTON COUNTY PUBLIC SAFETY COMMUNICATIONS AGENCY, AND AUTHORIZING THE EXECUTION AND DELIVERY OF SUCH AMENDMENT BY THE CHAIRMAN AND BOARD OF SUPERVISORS ON BEHALF OF THE COUNTY.

BE IT RESOLVED by the Chairman and Board of Supervisors of The County of Washington, in the State of Nebraska, (the "County") as follows:

Section 1. The Chairman and Board of Supervisors hereby find and determine that it is necessary and advisable for the County to enter into an Amendment to Service Agreement with the Washington County Public Safety Communications Agency (the "Agency") amending that Service Agreement dated as of November 15, 2004 (the "Original Service Agreement") between the County and the Agency, relating to public safety communications systems and services and to the outstanding bonds of the Agency issued for such purposes; that an Amendment to Service Agreement for has been prepared and submitted for approval by the Chairman and Board of Supervisors; that it is necessary and advisable that said Amendment to Service Agreement be approved, including the terms provided for undertaking payments and for the levying of taxes pursuant to Section 86-416, R.R.S. Neb. 2008; and that the execution and delivery of said Amendment to Service Agreement should be authorized.

Section 2. The form of said Amendment to Service Agreement is hereby approved and the Chairman and other members of the Board of Supervisors are hereby authorized to execute and deliver for and on behalf of the County the Amendment to Service Agreement with the Agency in substantially the form presented but with such changes as shall be deemed appropriate for and on behalf of the County.

Section 3. The Chairman and Board of Supervisors hereby state that it is the intention of the County that the interest on \$2,565,000 of Public Safety Communication System Revenue Refunding Bonds, Series 2010, proposed to be issued by the Agency shall be excludable from gross income under Section 103 of the Internal Revenue Code of 1986, as amended (the "Code") and the Chairman and Board of Supervisors hereby authorize the Chairman, Vice Chairman, County Treasurer and County Clerk (or any one or more of such officers of the County) to take any and all actions necessary or appropriate to carry out said intention and for the obtaining of such interest exclusion. Said Series 2010 Bonds are hereby determined to be obligations issued by the Agency on behalf of the County. Designation of said Series 2010 Bonds by the Agency as "qualified tax-exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Code by and for the County and the Agency is hereby authorized and confirmed and the County hereby covenants and warrants that it does not anticipate issuance directly by it or on its behalf of taxexempt bonds or other tax-exempt interest bearing obligations in an amount in excess of \$30,000,000 in calendar 2010, excluding for such purposes any bonds or other obligations issued to refund (other than to refund in advance) any bonds or other obligations to the extent that the amount of the refunding bonds or other refunding obligations does not exceed the amount of the bonds or other obligations refunded. The Agency is hereby determined to be a subordinate entity issuing bonds on behalf of the County within the meaning of Section 148(f)(4)(D)(iv) of the Code and the County hereby irrevocably allocates \$2,565,000 in principal amount of bonds for the calendar year 2010 to the Agency pursuant to said Section 148(f)(4)(D)(iv) and determines that the County will receive substantial benefits from the issuance of said Series 2010 Bonds. It is understood that said Series 2010 Bonds shall constitute an obligation of the Agency payable only from the sources specified in the authorizing resolution of the Agency, including amounts payable by the County under the Original Service Agreement as amended by said Amendment to Service Agreement.

Section 6. Execution and delivery of the agreement as herein authorized shall be sufficient and effective to bind the County so long as made by the Chairman and attested by the County Clerk. This resolution shall be in force and take effect from and after its adoption as provided by law.
