The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, May 10, 2010 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Jeff Quist, Mary Alice Johnson, Ernest Abariotes and Ronald Hineline. Kent Clausen was absent all day. Also present, County Clerk Merry Truhlsen.

It was moved by Abariotes and seconded by Hineline that the rules be suspended and that the minutes of the April 27, 2010 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Quist and seconded by Thomsen that the regular Monthly Fee Reports of the following Officials be received and placed on file: County Clerk \$365.83, Register of Deeds \$24,014.25, County Court \$18,173.20, County Planning Department \$8,989.00, Clerk of District Court \$2472.16, Sheriff \$2,949.80 and Road Department \$169.96. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence has been received: Invitation to Chamber After Hours for Cargill's new office building in Hayden Place and a letter from Clay County Board of Supervisors regarding the Nebr Environmental Trust. It was moved by Quist and seconded by Abariotes that the correspondence be received and placed on file. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Road Superintendent, Cheryl Parsons had the following items: As discussed at the 4/27 Board meeting, Parsons reported the Road Committee recommended awarding the microsurfacing bid to Sta-Bilt Construction Company. Sta-Bilt's bid of \$218,070 and Monarch Oil Co bid of \$213,397 were discussed. William Burdess spoke on accepting the lowest bid. Quist stated he talked to a County where Monarch had worked and the County had some issues with their performance. Parsons said she called the State to get another reference for Monarch Oil Co but they refused to comment. Thomsen stated Sta-Bilt has performed well for several jobs in the County and that is why the Road Committee recommended Sta-Bilt. Motion by Thomsen second by Quist to receive recommendation of Road Committee. Vote- Aye: Wilcox, Thomsen, Quist, Johnson and Abariotes. Nay: Hineline. Motion carried. Chairman discussed the wording on the agenda. Clerk apologized for the confusion and said usually the recommendation is stated then the bid is awarded and that is how the agenda read. Chairman then asked Thomsen and Quist if they would withdraw their motion, they agreed. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Previous motion to receive Road Committee recommendation by Johnson second by Hineline to award bid to Monarch Oil for \$213,397. Vote- Aye: Wilcox, Johnson, Abariotes and Hineline. Nay: Thomsen and Quist. Motion carried.

At 9:45 Board received Rock & Gravel Proposals for Fiscal Year 2010/2011. No rock bid was received. Motion by Hineline and second by Abariotes to authorize Parsons to rebid rock proposals. Vote- Aye: Wilcox,

Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried. Gravel bids were received from Stalp Gravel Company and Lyman-Richey Sand & Gravel Company. Lyman-Richey's bid was \$8.90 per ton for gravel and armor coat gravel and Stalp Gravel was \$7.25 per ton for gravel and armor coat gravel. Board has accepted both bids in the past as Parsons uses both companies for different areas in the County. Motion by Abariotes to accept bids from Stalp Gravel Co, to be used in the north part of the county and Lyman-Richey Sand & Gravel to be used in south part of county with Hwy 91 to be used as dividing line. Glen Schuetz, Stalp Gravel, said in the past both bids have been approved for Road Supt to use to county's benefit. Abariotes withdrew his original motion and made a motion to accept both bids from Stalp Gravel Co and Lyman-Richey Sand & Gravel Co for Road Superintendent to use at her discretion, second by Johnson. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

At 10:00 AM culvert proposals for fiscal year 2010/2011 were received. Three bids were submitted: B's Enterprises Inc; Metal Culverts Inc and Midwest Service & Sales. Bids were read, please check with Clerk's office for specific prices as many figures were read. Parsons will check figures and report back.

Parsons read a traffic study done at the intersection of County Road P20 & 21. Parsons had received a letter from Chuck Hall, Transportation Director for Blair Schools, requesting a stop sign at CR P20. Tim Baxter with Nebr Intergovernmental Risk Management Assoc also recommended a stop sign at CR P20. Board discussed the intersection. Motion by Hineline and second by Quist to refer the Stop Sign Resolution back to the Road Committee. Vote- Aye: Wilcox, Thomsen, Quist, Abariotes and Hineline. Nay: Johnson. Motion carried.

Robbin Jeffrey read part of Nebr Revised Statute 39-810 into the record concerning the bidding process.

Parsons read a Resolution to the Board of Public Roads Classifications & Standards for the addition of Union Pacific's project on CR28, lowering of the hill, to the One & Six Year Road Plan. Motion by Hineline and second by Quist to adopt/table Resolution 2010-19. Vote- Aye: Wilcox, Thomsen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

BE IT RESOLVED THAT THE COUNTY BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA:

Hereby, request the Board of Classifications & Standards to grant a Revision of our "One Year Road Plan," to include Project No. C89 (522), which is to improve the configuration of County Road No. 28 by lowering the hill from the railroad crossing going west for 880 feet. This construction would allow The Union Pacific Railroad to construct an additional railroad track & the installation of active warning devices at this location.

The Road Improvement is located in the Southeast ¼ of Section 28 & the Northeast ¼ of Section 33, Township 18 North, Range 11 East, Washington County, Nebraska.

Kip Kissinger, UNICO Group, Inc was present to give the Board an overview of first quarter figures for the County's United Healthcare insurance plan. Sheriff Mike Robinson, Pam Daly and Dep Co Atty Ed Talbot were present. Kissinger had several handouts: showing the ratio of claims paid out for each plan versus the amount of premium being paid, discussed renewal scenarios/plan design changes and also discussed highlights of the healthcare reform bill.
