June 8, 2010 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, June 8, 2010 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Clausen, Jeff Quist, Mary Alice Johnson, Ernest Abariotes and Ronald Hineline. Also present, County Clerk Merry Truhlsen.

Wilcox stated a correction needed to be made in the May 25 minutes on Resolution 2010-22. It was moved by Hineline and seconded by Abariotes that the rules be suspended and that the minutes of the May 25, 2010 meeting be approved with a correction made to Resolution 2010-22, but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Hineline and seconded by Quist that the regular Monthly Fee Reports of the following Officials be received and placed on file: Co Clerk \$383.50, Reg of Deeds \$26,746.00, Co Court \$18,369.81, Co Plan Dept \$6,515.00, Clk Dist Crt \$1,793.35, Sheriff \$3,342.24, and Road Dept \$16,343.11. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

No correspondence had been received.

Doug Cook asked the Board to appoint 3 members to the Planning and Zoning subcommittee of six. Chairman Wilcox appointed Linda Thomsen, Jeff Ouist and Kent Clausen.

Cheryl Parsons, Road Superintendent, advertised the sale of a used 1991 Chevy Corsica car. Clerk received 8 bids. Bids ranged in price from \$358 to \$1005. Motion by Clausen and second by Quist to accept the bid from Troy Mencke for \$1,005.91. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Julie Ogden, JEO Consulting Services, handed out information on the intersection redesign of County Road 39 & CR28. At the last Road Committee meeting, Ogden said initially when they talked about this intersection they estimated about 8' of fill, but when they started laying in the vertical alignment they found in order to increase the speed limit to 35 or 45 mph, the amount of fill needed increased to 20' to 25', which would significantly increase the cost and is significantly different than what was initially discussed. Another option the Board could look at would be placing a higher culvert in, down stream, which would bring the flow line up and allow the ditch to partially silt in. This would make the ditch more shallow by the road, which the whole point of the redesign was safety, due to the sharp drop off by the road. Motion by Hineline second by Abariotes to refer this project back to the Road Committee. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried. JEO promised the County money back if they got the survey done before the leaves popped out, which they did. Ogden asked the Board to amend the agreement for the study and preliminary design of CR 39 & 28 Project #C89(515) in order to give the county a refund. Motion by Abariotes and second by Hineline to amend agreement reducing the engineering fees in the amount

of \$2,620.00. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Proposals were received for a new trench drain system for the county road department building. Two bids were received: Henton Trenching \$35,605.00 and Tom's Well Service \$44,100.00. Parsons and Bob Smith discussed items included in this bid: 12' heavy duty grates, build a sand/oil separator outside the building, construct a catch basin and replace 10'x100' floor drains. The present drain is failing and the floor is caving in. Hineline made a motion to award bid to Henton Trenching. Motion died for lack of a second. Motion by Quist and second by Thomsen to refer this bid to the Road Committee. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Clerk had received 5 proposals for the bridge replacement project C89-02605 (240) on County Road 26, north of Arlington. Darren Brown, with Schemmer, read the following bids: Commercial Construction \$259,518.69; JMN Construction \$355,184.10; Dixon Construction \$245,123.90; Hawkins Construction \$242,59.16; MCC \$293,655.10. Jim Gregory from Hawkins Construction stated their starting date would depend on when the inverted T beams were available. Motion by Thomsen and second by Clausen to award bid to Hawkins Construction, in the amount of \$242,590.16, for bridge replacement project C89-02605 (240), contingent on verification of figures by Brown. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Ogden discussed the engineering study for a stop sign at the intersection of County Road 39 and 28, and stated she feels the stop sign is in the correct place. Parsons said this was discussed at the Road Committee meeting and read a letter from Tim Baxter, Road Safety & Loss Prevention Specialist with NIRMA. In the letter Baxter commented the stop sign was installed through the appropriate process of an engineer study and Board resolution. If this sign were to be removed and an accident occurs the County could be liable because the engineering study said the stop sign was installed as per the study. Chairman stated he had talked to the County Attorney's office and they agreed if the engineers' recommended stop sign is removed, the county would be liable. William Burdess stated he thinks the stop sign creates a traffic hazard and makes the intersection more dangerous. Motion by Clausen and second by Quist to leave the stop sign as is and review in one year. Vote-Aye: Wilcox, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: Thomsen. Motion carried.

Ogden had discussed a drainage study for both the Thone and McBride bridges, in the northern part of the County, with the Road Committee. These bridges are on the list to be replaced. The study would be done to verify that the bridges could be replaced by box culverts and give the Board an idea of what these projects would cost. The cost for the study would be \$19,950. If the County waited until December when the crops are out and the leaves are off the trees, Ogden would deduct \$3,900 from the cost. Motion by Quist and second by Clausen to approve a drainage study be done of the Thone and McBride bridges by JEO in December. Vote-Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, and Abariotes. Nay: Hineline. Motion carried.

The next agenda item was an agreement with JEO for the Arlington north bridge C89-02403. Ogden stated the agreement was not ready at this time. No action was taken.

Darren Brown came back to the Board and verified the Hawkins Construction figure of \$242,590.16 for bridge replacement project C89-02605 was correct.

Roger Gilliland, Courthouse Maintenance had requested the Board consider purchasing a new carpet cleaning machine. Emily Mahnk, Egan Supply and Mark Phillips, with Advance were present. Board discussed the AquaClean 18 FLX at a price of \$2,841.95 and asked about the price of a multi-surface adapter to clean hard surface floors also. Gilliland said they would get the price of an adapter. Motion by Clausen and second by Quist to table until a price is received for hard surface floor cleaner. Vote- Aye: Wilcox, Thomsen, Clausen, Ouist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Sheriff Deputy Robert Bellamy brought an addendum to extend the existing agreement between the County of Washington and the Fraternal Order of Police Lodge #36, which terminates on June 30th. Motion by Quist and second by Clausen to approve the FOP contract extension. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Sheriff Mike Robinson brought a renewal of the Village of Herman's contract with Washington County to provide law enforcement services. Motion by Clausen and second by Thomsen to approve the law enforcement contract with the Village of Herman. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Phillips reported the cost of a hardsurface adapter was \$642. Motion by Quist and second by Clausen to authorize the purchase of a carpet cleaning machine with the hardsurface adapter for a total price of \$3,483.95. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Rebecca Versch, Extension Agent, and Steve Tonn had requested bids for a new van for the Extension Office as their present van is needing repairs. Clerk stated she had not received any bids. This will be placed on the June 22 meeting agenda.

Paula Hazelwood, with Gateway Development discussed a Resolution authorizing Community Development Block Grant Revolving Loan Funds be used for a Process Operations Training Facility at 1844 Washington Street, Blair. Hazelwood stated they have been working on this for six years. The Facility would meet the training needs of the businesses on the Blair Biorefinery Campus, the Ft Calhoun Nuclear Power Station, water/waste water employees and any other business in Washington County that utilizes the process controls skill set. Metropolitan Community College has worked closely with these businesses to develop the curriculum for a Process Operations Technology Degree. The money in the County's CDBG Revolving Loan Fund came from the federal government and has been loaned out to area businesses but is slated to be returned to the State as no new loans have been made in the past two years. Gateway met with the Nebr Dept of Economic Development representatives to work out the details of \$120,000 in the Rev Loan Fund going towards this project. Action on a resolution and a public hearing on this will be June 22, 2010 at 11:00 a.m.

Hazelwood next discussed the American Recovery & Reinvestment Act of 2009 which created a new category of bonds, Recovery Zone Bonds. Hazelwood requested the Chairman appoint a committee to work with her to determine if the County would want to authorize this bonding for a business in the county. Chairman appointed Abariotes, Johnson and Dep Co Atty Talbot, with Quist as an alternate, to the committee.

At 11:53 a.m. the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 12:02 pm and reconvened in regular session. The Board then recessed for lunch.

Senator Scott Lautenbaugh discussed the redistricting of the Nebraska Legislative Districts which happens every 10 years. New district lines will be drawn in 2011 based on the 2010 Census figures. Lautenbaugh and the Board agreed the present districts, which were drawn in 2001, were not beneficial to Washington County as we went from one legislative district to three districts. Lautenbaugh discussed the advantages and disadvantages of 3 representatives as opposed to 1. Jon Stewart stated there may be advantages to having more representatives. Lautenbaugh also discussed the similarities Washington County has to the surrounding Counties and the fact our County isn't big enough to have it's own district. Clerk had prepared a letter requesting the legislature consider putting the county into one legislative district as we were prior to 2001. Motion by Hineline and second by Quist to authorize Chairman to sign a letter to Senators. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Chairman discussed a letter of support to Goldenrod Hills, Home Preservation Grant Review Committee, for the Weatherization Program which allows them to rehabilitate homes for low income families and the elderly.

Motion by Clausen and second by Thomsen to authorize Chairman to sign letter of support for Goldenrod Hills weatherization program. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

MAPA had submitted their annual Revolving Loan Fund Administrative Agreement. Motion by Quist and second by Clausen to authorize Chairman to sign annual agreement. Vote- Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Public Comment: Jon Stewart spoke about the need for a light at Highway 75 and North 28th Avenue.

Claims were received and reviewed, following which it was moved by Quist and seconded by Clausen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Wilcox, Thomsen, Clausen, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.
