The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, June 22, 2010 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Duane Wilcox declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Duane Wilcox, County Board Members, Linda Thomsen, Kent Clausen, Jeff Quist, Mary Alice Johnson, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen.

It was moved by Quist and seconded by Clausen that the rules be suspended and that the minutes of the June 8, 2010 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. The following correspondence had been received: Dept of Rev, April lodging tax for \$990.90. Motion Abariotes and second by Clausen to receive correspondence and place on file. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Hineline and Abariotes. Nay: None. Motion carried.

Mike Smith, Weed Supt gave an update on his department. Smith introduced the Region 3 Director Dave Boscult who handed out a copy of the score sheet from the Dept of Agriculture for the Weed Supt and the County's Noxious Weed Program. Smith and the County's Weed program scored above average.

Road Supt Cheryl Parsons was absent as she was attending LPA Basic Civil Rights training sessions in Lincoln. Quist stated the Road Committee recommended awarding the bid for the trench drain system for the Road Dept Building to Henton Trenching. Motion Hineline second Quist to award bid to Henton Trenching for \$35,605. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Hineline and Abariotes. Nay: None. Motion carried.

At 11:05 a public hearing was held to consider authorizing Community Development Block Grant Revolving Loan funds for a Processing Operations Training Facility at 1844 Wash St., Blair. Motion Clausen second Thomsen to open public hearing. Vote- Aye: Thomsen, Clausen, Quist, Wilcox, Johnson, Hineline and Abariotes. Nay: None. Motion carried. Paula Hazlewood, Gateway Development, who had appeared at the May 25<sup>th</sup> and June 8<sup>th</sup> meeting briefly reviewed the funding request. Gateway Development Corp. along with Metropolitan Community College, the City of Blair and industry partners, has been working for the past several years to develop a process operations training program. The Facility would meet the training needs of the businesses on the Blair Biorefinery Campus, the Ft Calhoun Nuclear Power Station, water/waste water employees and any other business in Washington County that utilizes the process controls skill set. Students that achieve the 96 credit hour requirement will leave the program with an Associate in Applied Science Degree. Funding is close to being completed. The County's CDBG Revolving Loan Fund Committee met on June 2 and recommended approval of Gateway's request for funding in the amount of \$120,000. Pam Daly and Dennis McCormick spoke. Motion Clausen second Thomsen to close public hearing. Vote- Ave: Thomsen, Clausen, Quist, Wilcox, Johnson, Hineline and Abariotes. Nay: None. Motion carried. Clerk read Resolution 2010 – 28. WHEREAS, according to the Reuse Plan the application was submitted to Washington County's Community Development Block Grant Revolving Loan Fund Advisory Committee for review and recommendation; and

NOW THEREFORE BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS, WASHINGTON COUNTY, NEBRASKA that the Chairman and County Clerk of Washington County, Nebraska be authorized and directed to proceed with the formulation of any and all contracts, documents or other memoranda between Washington County and the other partners to provide \$120,000 grant funds from Washington County's CDBG Reuse Fund for said project.

WHEREAS, Washington County, Nebraska has received information regarding an allocation of the national Recovery Zone Economic Development Bonds pursuant to the American Recovery and Reinvestment Tax Act of 2009, codified in Title 26 of the United States Code and Internal Revenue Service, Notice 2009-50, issued on June 12, 2009 (collectively, the "Allocations"); and

WHEREAS, the Board of Supervisors for Washington County, Nebraska understand that any allocations are to be used for the issuance of Recovery Zone Economic Development Bonds and Recovery Zone Facility Bonds pursuant to Section 1400U-2 or 1400U-3, respectively, of the Internal Revenue code 1986, as amended (the "Code"), such bonds referred to collectively as "Recovery Zone Bonds"; and

WHEREAS, the Board of Supervisors for Washington County, Nebraska understands that the Recovery Zone Bonds are to be issued with respect to/or to finance certain expenditures located in or attributable to an area within the jurisdiction of Washington County that the Washington County Board of Supervisors has determined has a significant level of one or more of the following factors: poverty, unemployment, home foreclosures, or general distress (such factors referred to herein as the "Distress Factors"); and

WHEREAS, the Board of Supervisors for Washington County, Nebraska has determined that the Distress Factors have been caused by one or more of the "Underlying Conditions of Distress" described in Section 1 hereof; and

WHEREAS, the Board of Supervisors for Washington County, Nebraska desires to designate the area described in Section 3 as a "Recovery Zone" (pursuant to the correspondence from Curtis L. Christensen, dated June 21, 2010, indicating that the proposed Project will qualify as a "project" within the meaning of the act that is "Recovery Zone property") to provide for the possible issuance of Recovery Zone Bonds (such area being referred to herein as the "Recovery Zone"):

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE WASHINGTON COUNTY BOARD OF SUPERVIOSRS, AS FOLLOWS:
