

**February 8, 2011 Minutes

The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 11:30 A.M. on Tuesday, February 8, 2011 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Steven Kruger, Ernest Abariotes and Ron Hinline. Chairman announced Jeff Quist would be absent all day due to illness. Also present, County Clerk Merry Truhlsen, Deputy County Attorney Ed Talbot and County Treasurer Marj Hoier. It was moved by Clausen and seconded by Kruse to enter into Board of Equalization. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

Motion by Clausen and second by Kruse that the rules be suspended and that the minutes of the January 25th, 2011 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

Marj Hoier, County Treasurer, went over the Motor Vehicle Exemption application for First Christian Church and Memorial Community Hospital Auxiliary. Motion Clausen second Kruger to approve the motor vehicle exemptions. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

Steven Mencke, Assessor and Jean Ray, Deputy Assessor were present. Mencke discussed the Tax Corrections. It was moved by Abariotes and seconded by Clausen to approve Tax Corrections #6534 through #6537 as presented by the Assessor. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

At 11:40 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Abariotes and second by Hinline to adjourn meeting until the next regular Board of Equalization meeting date, February 22, 2011. All members present voted aye, Chairman declared meeting adjourned.
