February 8, 2011 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, February 8, 2011 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Steven Kruger, Ernest Abariotes and Ron Hineline. Chairman announced Jeff Quist would be absent all day due to illness. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot.

It was moved by Abariotes and seconded by Clausen that the rules be suspended and that the minutes of the January 25, 2011 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Clausen and seconded by Kruse that the regular monthly fee reports of the following Officials be received and placed on file: Co Clerk \$343.22, Reg of Deeds \$19,527.50, Co Court \$23,472.26, Co Plan Dept \$3,771.00, Clk Dist Crt \$1,260.50, Sheriff \$2,871.44 and Road Dept \$27,003.44. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Letter from Kirkham Michael for a public funding workshop March 10, State DOR Nov lodging tax \$779.74, e-mail from Senator Christensen regarding letter of support on LB487, information from Papio Missouri River NRD about 5 cost share programs and e-mail from Shawn Melotz regarding a senator's luncheon and info about the 2011 Leg Session bills. Kruger motioned, seconded by Clausen that the correspondence be received and placed on file. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Mike Smith discussed the Weed Fund Year End Reports and noted revenue and expense figures were corrected. Hineline motioned, seconded by Clausen to authorize chairman to sign year end reports. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Road Supt, gave the Board a department update. Parsons handed out a report summarizing the work that was completed in 2010 and the cost of that work. Board received a map of the fracture critical bridges. Parsons went over the progress that has been made since the State's reclassification of bridges in 2008/2009. Parsons next gave the Board a map of scour bridges, bridges which have the potential to cause problems with water damage. Parsons discussed various equipment problems. William Burdess brought the intersection of County Road P38 and 39 to the Board's attention as a dangerous intersection. Board asked Parsons to put it on the next agenda for discussion.

Talbot discussed the annual Juvenile Justice Grant the Board approved at the last meeting. This grant is administered through the Crime Commission, who allocates certain amounts of money to each county. Washington County is allocated \$17,000 per year, plus our matching funds, which totals approximately \$23,000. This money is in Fund 2506, Juvenile Services Grant Fund. The County Attorney hopes to hire a part-

time coordinator, who will be paid from the grant money, to expand and help monitor the juvenile diversion program. At the present time, the money was spent on office furniture in preparation for the coordinator. Talbot thanked the Board for approving the grant.

Rick Weidner, architect, had been contacted by Abariotes to give the Board direction for updating the jail kitchen. The Board looked at several kitchen layouts. Weidner stated some facilities have moved to a prep kitchen with a microwave and refrigerator and some are full service kitchens. The first thing to decide is what kind of a kitchen would best meet present and future needs. Weidner said after evaluating the kitchen, he had concerns about enlarging the kitchen into the sally port with the sloping floor and other issues, but stated the kitchen needs updating and the lack of storage, with the refrigerator being in the sally port was another area of concern. Captain Randy Wildman discussed the food preparation for the jail. Hineline made a motion to refer this to the Bldg & Grounds committee but then withdrew his motion. Board discussed going to a prep kitchen which uses prepackaged meals and other options. Clausen motioned, seconded by Kruse for Bldg & Grds Committee to work with the Sheriff's office to look into prep kitchen costs and feasibility. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Deputy Ben Scherer asked that the committee meet next week so Sheriff Robinson, who is attending school until Friday, could be there.

Clerk discussed the Revolving Loan Fund and the report MAPA prepared stating the ending balance on Dec 31 was \$27,446.51. Report will be mailed to Nebr Dept of Economic Development. Kruse motioned, seconded by Clausen, to authorize Chairman to sign MAPA Program Income Report. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The Board recessed to visit three offices: County Clerk, Register of Deeds and Planning & Zoning. The officials gave a brief overview of their duties and introduced employees.

Ty Christensen with Family Heritage Cancer Insurance introduced himself and the company. Christensen requested permission to send a memo to employees asking if they were interested in talking to him. This insurance does not go through payroll deduction as the premiums are returned to the policyholder if unused after a period of time. Board agreed to allow the memo be sent to employees as long as no meetings were held during business hours.

At 11:30 the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 11:40 and reconvened in regular session.

Comments from public: Scott Japp, who is on the Papio Missouri River NRD Board, reminded the Supervisors of an NRD subcommittee meeting at 6:30 P.M. this evening. Japp had given the Board a copy of the policy revisions he is proposing at this meeting and would appreciate the Board's support. Several Board members stated they would be there. Doug Cameron discussed information he gave to the Board regarding probate proceedings in County Court.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Kruse that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote-Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
