The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, May 24, 2011 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairperson, Mary Alice Johnson declared the meeting was in session and that the meeting was being recorded. Chairperson made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairperson, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot.

It was moved by Kruger and seconded by Quist that the rules be suspended and that the minutes of the May 10, 2011 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Nebr Safety Center Advisory Council letter asking for county representatives to serve on the council. Hineline had received a response from the Three Rivers Health Dept regarding a \$10,000 payment to Petersen Real Estate. Motion Abariotes and second Quist to receive correspondence and place on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Road Superintendent, Cheryl Parsons, had several items to come before the Board. Culvert proposals were advertised at 9:30 for fiscal year 2011-2012. Clerk received three bids from: B's Enterprises, Inc; Midwest Service & Sales and Metal Culverts, Inc. Parsons read the culvert bids. As there were many prices quoted, Board agreed to have Parsons compare the prices, then report back later today who had the low bid.

At 9:40 proposals were received for gravel for fiscal year 2011-2012. Clerk received three bids from: Lyman-Richey Sand & Gravel Co Inc., Stalp Gravel Company and KMG Partners LLC. Parsons read the bids: Lyman-Richey \$8.65 per ton, Stalp \$7.50 per ton, KMG \$7.50 per ton. Motion Clausen second Quist to accept the bids from Stalp Gravel Co and KMG Partners LLC, both at \$7.50 per ton, for Road Superintendent to use at her discretion. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Clerk received one proposal for rock for fiscal year 2011-2012 from Martin Marietta. Parsons read the bid- 1"& 1½" screened \$11.95, 1" & 1½" crusher run \$10.45, 5/8" X #8 chips \$13.70. Kruger motioned, seconded by Clausen, to award the bid to Martin Marietta. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Clerk received 3 proposals for the replacement of a box culvert located on County Road 31 Project No. C89 (472). Julie Ogden, engineer for JEO who prepared the bid documents, read the bids: Investors for Infrastructure \$48,523.10 & rock stilling basin \$9,850.00; M.E.Collins Contracting Co., Inc. \$78,997.20 & basin \$18,055.50; Vrana Construction \$122,019.65 & basin \$16,337.50. Ogden stated all the bidders are on the Nebr Department of Roads qualifying list. Scott Wiekhorst with Investors for Infrastructure answered questions from the Board. Abariotes motioned, seconded by Kruger to award the bid to Investors for Infrastructure, pending verification of figures by Ogden. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. (Ogden reported later that the figures were correct)

Clerk received 7 proposals for Bridge Replacement C89-02020, County Project #C89 (457). Ogden read the bids: Investors for Infrastructure, LLC-\$193,539.00; Norfolk Contracting, Inc-\$243,648.00; Theisen Construction, Inc-\$245,323.80; McC, LLC-\$247,649.40; Commercial Construction, Inc-\$260,146.54; Dixon Construction Co-\$263,445.00; Vrana Construction-\$355,400.20. Board discussed the bids. Abariotes motioned, seconded by Hineline to award the contract to the low bidder, Investors for Infrastructure, LLC, pending Ogden's verification of calculations. Vote- Aye: Clausen, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: Kruse. Motion carried. (Ogden reported later that the figures were correct)

Road Committee had discussed the bids for two new motor graders at the Road Committee meeting on 5-23-2011 but had not reached a consensus. Clausen discussed buying two machines would put the graders in a 5 year cycle so they would be under warranty and this would eliminate expensive repair bills. After further discussion, Clausen motioned, seconded by Quist to purchase two motor graders. Vote- Aye: Clausen, Kruse and Quist. Nay: Johnson, Kruger, Abariotes and Hineline. Motion failed. Hineline motioned, seconded by Clausen to throw out both motor grader bids from Murphy Tractor Co and Nebraska Machinery Co. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Mike Smith, Weed Dept, cancelled his agenda item for renting an ARM boom mower.

Chairman asked for reports on the following committees: Finance, Assistance, Insurance, Personnel Manual Update-meet May 26, FOP Negotiations, Appointed Official Evaluation Procedure, Joint Co Board/Co Planning, Subcommittee of Fort Calhoun drainage issues- meeting with City at 4:00; and Building & Grounds- talked about new flag pole Gayle Maine is ordering and the law enforcement roof will be needing repairs.

Parsons reported back to the Board, the company that had the low prices on the culvert bids was Metal Culverts Inc. Clausen motioned, seconded by Kruger to award the culvert bid to Metal Culverts Inc. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. See Clerk's office for a detailed listing of the prices.

Clerk received 2 proposals for the 2010-2011 fiscal year audit report of Washington County: Goracke, Ritterbush & Piotrowski, LLP and Hayes & Associates, LLC. The proposals included bids for a one year, two year and three year audit. Board looked at the three year bid: Goracke= 2011 \$14,520; 2012 \$14,900; 2013 \$15,400. Hayes= 2011 \$11,500; 2012 \$12,000; 2013 \$12,500. Kruse motioned, seconded by Clausen to award the three year audit bid to Hayes & Associates, LLC for the above quoted prices. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 11:13, motion was made by Clausen and seconded by Kruger to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman stated the reason for the closed session was for the protection of public interest regarding Nebraska Intergovernmental Risk Management Association Courthouse safety audit. At 11:50, motion by Quist and second by Clausen to end closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was for the protection of the public interest regarding NIRMA Courthouse safety audit. No action was taken.

At 11:50 the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 12:00 and reconvened in regular session.

Board received a copy of the letter from the Washington County Veterans' Service Committee recommending Dennis Cordle be appointed the new Veterans Service Officer for Washington County. The County has received a copy of the letter from the State Department of Veterans' Affairs approving Cordle's appointment. Clausen motioned, seconded by Kruger to appoint Dennis Cordle as the Washington County Veteran's Service Officer. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Nile Johnson addressed the Board regarding an accident that occurred on County Road 39 and a roadside memorial that had been placed at the site, located by the George Krauss property. Johnson is representing the Krauss' and they want the memorial removed. Johnson stated the County's Zoning Ordinances bans "signs" in the public right of way. Mark Hodson spoke to the Board about the accident that took the life of his daughter, Ashley, and Brandon Tomcak. Hodson stated he had received permission from the County to place the memorial there. Doug Cook, Planning and Zoning Administrator, discussed the ordinance and what falls under the heading of "signs". Board sympathized with Hodson and said this was a tough decision to vote on. After much discussion, Hineline motioned, seconded by Clausen, to follow Zoning Regulations and not allow signs in the right of way. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Hineline. Abariotes abstained. Nay: None. Motion carried. Board stated people have 60 days to remove memorials from the county road right of way, this does not apply to state highways.

Doug Cook, Planning & Zoning Administrator had the following agena item:

1. Conditional Use Permit request of Dam's Farms, Inc., % Dwight Dam

To allow for the application of processed sludge cake as a fertilizer substitute and soil conditioner, such product processed and distributed by the City of Omaha Wastewater Treatment System. The product will be applied on the S1/2 of Section 5-Township 19 North-Range 9 East of the Sixth P.M. (general location: north side of County Road 8, between County Road 3 and County Line Road). Clausen motioned, seconded by Kruger, to open the public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Gordon Anderson, City of Omaha discussed the permit.

Kruger motioned, seconded by Clausen to close the public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Quist motioned, seconded by Kruger to concur with the Planning Commission recommendation to approve with the allowance for the sludge to be placed within 1280' of an existing residence and with a review in one year. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board recessed at 1:40 P.M. to visit the Communications Office and the Veterans' Service Office. Board went back into session at 2:20 P.M.

At 2:20 P.M., motion was made by Kruger and seconded by Clausen to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman stated the reason for the closed session was to discuss a personnel matter, the prevention of needless injury to the reputation of an individual - discussion on pending litigation issues, Sheriff's Office. At 2:28, motion by Clausen and second by Quist to end closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was to discuss a personnel matter, the prevention of needless injury to the reputation of an individual – discussion on pending litigation issues, Sheriff's Office. No action was taken.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Hineline that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
