The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:30 a.m. on Tuesday, August 23, 2011 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the Office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairperson, Mary Alice Johnson declared the meeting was in session and that the meeting was being recorded. Chairperson made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairperson, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot.

Quist moved, seconded by Kruse, to approve the agenda for August 23, 2011. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruger and seconded by Kruse that the rules be suspended and that the minutes of the August 9, 2011 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Hineline. Abariotes abstained. Motion carried. Johnson said in September, County Board meetings will start at 8:30 A.M.

The following correspondence had been received: Lodging Tax remitted for June \$2,163.29, e-mail from Pam Daly regarding the budget, information on Northstar Wind regarding a small wind farm west of Blair and letter from Social Security requesting monthly reporting on inmates. Motion Clausen and second Kruse to receive correspondence and place on file. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Road Superintendent, gave the Board a listing of the sites in Washington County that sustained flood damage. Parsons discussed heavy rainfall recently received and the damage resulting from that. Ben Rogge talked about the procedure to open roads that have been closed due to flooding. Rogge said people from the Cottonwood Corp would like to be able to get into their houses to start cleaning-up. Board discussed opening roads and said Parsons can work with the emergency flood subcommittee to make that determination. Johnson said FEMA has set up a disaster recovery center in the Courthouse. Parsons said the Road Dept is running behind on other projects due to the flood repairs.

Hineline moved, seconded by Abariotes to authorize Chairman to sign letter of support for the Goldenrod Hills Community Action's application regarding the weatherization program. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Kruger moved, seconded by Kruse to receive the Sheriff's Office July fee report and place on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

William Burdess read a multiple page complaint regarding his property valuation protest with the Board of Equalization and submitted it for the record. Quist motioned, seconded by Kruger, to refer Burdess' letter to the County Attorney. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Paul Mullen and Paul Hunt, Metropolitan Area Planning Agency, had prepared three proposals for equalizing the population in Supervisor Districts based on the 2010 Census figures. Kruse moved to accept the option called the Proposed Supervisor Districts. Motion died for lack of second. Board discussed the maps and said they would like to study these options further and would like more county roads shown on the maps. Public comment was heard from Pam Daly, Darrel Boesiger and Scott Japp. MAPA will prepare another proposal and put more road/street detail on the maps. Kruger moved, seconded by Hineline, to discuss this again at the Sept 13th meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Mullen also asked the County to show their support for Heartland Vision 2050 – a regional visioning process for the eight counties around the Omaha/Council Bluffs area, that MAPA proposes to undertake with a Sustainable Communities Regional

Planning grant from HUD. Mullen gave the Board handouts on Heartland Vision 2050 and is asking the County sign a Memorandum of Understanding. Board discussed the time involved for the Planning Dept. Kruse motioned, seconded by Kruger, to talk with the Planning Dept and discuss this further at the Sept 13th meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Phil Green, Assistant Blair City Administrator, gave the Board an update on the Holling Hall flood relief housing. At this time there are 9 family units, about 25 people, still staying at Holling Hall, but they anticipate everyone moving out by the end of the month. In early July the numbers peaked with 115 people staying there. Green thanked the County for their help and said the people who stayed there were also very appreciative for all the support and donations. Green had a handout outlining the steps to take for individual assistance from the Federal Emergency Management Agency. Green stressed the importance of people and businesses impacted by flooding to register with FEMA and go through the process. FEMA also works with the Small Business Administration to provide loans for families and businesses. Green stated the committee coordinating the emergency flooding needs are now organizing to help meet long term recovery needs, and they are looking for more people to get involved.

Sandy Kucera, Too Far North, has applied for a special liquor permit for the Harvest Moon Festival, to be held at Santa's Woods on Sept 25. Quist moved, seconded by Kruger to adopt Resolution 2011- 36. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 11: 35 the Board convened as Board of Equalization, see separate minutes. Board adjourned from BOE at 11: 40 and reconvened in regular session.

Clerk had received the County Official's Annual Inventory Reports for 2011, except the Sheriff's Office inventory, which will be approved Sept 13. Clausen moved, seconded by Quist, to receive the County Officials' Inventories and place on file. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board discussed the job description for the Courthouse maintenance position and will advertise four times, with a September 12th deadline for receiving applications at the Clerk's office. Other maintenance issues were addressed: Quist moved, seconded by Kruger to give the Building and Grounds Committee authority to spend up to \$4,500 to have the County Court's fire counter window repaired. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Board discussed the old refrigerator at the jail and asked Abariotes to work with Sheriff's office to get that replaced. Kruger moved, seconded by Clausen to approve a proposal from Control Services for computer maintenance at a cost of \$360 and provide pump maintenance to find problems that are occurring internally at a cost of \$1,536. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Board recessed for lunch. Jerry Kruse was absent in the afternoon.

At 1:00 Board convened as Washington County Public Safety Communications Agency, see separate minutes. Board adjourned from PSCA at 1:10 and reconvened in regular session.

Following adjournment of the Washington County Public Safety Agency Board, at which meeting, actions were taken to call for prepayment the outstanding \$340,000 principal balance of the Agency's Series 2006 Bonds and to authorize issuance of \$350,000 of the Agency's Refunding Bonds, Series 2011. Phil Lorenzen, the County's bond underwriter advised the Board that it was necessary to amend the Service Agreement between the Agency and the County to enable the adjustment in the payment schedule to reflect the revised lower cost payment schedule resulting from the bond refunding. Dennis McCormick made a

comment. Kruger moved, seconded by Clausen to adopt Resolution 2011-39 amending the Service Agreement between the County of Washington and the Washington County Public Safety Agency. Vote- Aye: Clausen, Quist, Johnson, Kruger, Abariotes and Hineline. Kruse absent. Nay: None. Motion carried.

RESOLUTION NO. 2011 - 39

A RESOLUTION APPROVING A SECOND AMENDMENT TO SERVICE AGREEMENT BETWEEN THE COUNTY OF WASHINGTON IN THE STATE OF NEBRASKA AND THE WASHINGTON COUNTY PUBLIC SAFETY COMMUNICATIONS AGENCY, AND AUTHORIZING THE EXECUTION AND DELIVERY OF SUCH AMENDMENT BY THE CHAIRPERSON AND BOARD OF SUPERVISORS ON BEHALF OF THE COUNTY.

BE IT RESOLVED by the Chairperson and Board of Supervisors of The County of Washington, in the State of Nebraska, (the "County") as follows:

Section 1. The Chairperson and Board of Supervisors hereby find and determine that it is necessary and advisable for the County to enter into a Second Amendment to Service Agreement with the Washington County Public Safety Communications Agency (the "Agency") amending that Service Agreement dated as of November 15, 2004 (the "Original Service Agreement"), previously amended by an Amendment to Service Agreement dated as of June 1, 2010, (the "First Amendment" and together with the Original Service Agreement, the "Existing Service Agreement") each between the County and the Agency, relating to public safety communications systems and services and to the outstanding bonds of the Agency issued for such purposes; that a Second Amendment to Service Agreement has been prepared and submitted for approval by the Chairperson and Board of Supervisors; that it is necessary and advisable that said Second Amendment to Service Agreement be approved, including the terms provided for undertaking payments and for the levying of taxes pursuant to Section 86-416, R.R.S. Neb. 2008; and that the execution and delivery of said Second Amendment to Service Agreement should be authorized.

Section 2. The form of said Second Amendment to Service Agreement is hereby approved and the Chairperson and other members of the Board of Supervisors are hereby authorized to execute and deliver for and on behalf of the County the Second Amendment to Service Agreement with the Agency in substantially the form presented but with such changes as shall be deemed appropriate for and on behalf of the County.

Section 3. The Chairperson and Board of Supervisors hereby state that it is the intention of the County that the interest on \$350,000 of Public Safety Communication System Revenue Refunding Bonds, Series 2011, proposed to be issued by the Agency shall be excludable from gross income under Section 103 of the Internal Revenue Code of 1986, as amended (the "Code") and the Chairperson and Board of Supervisors hereby authorize the Chairperson, Vice Chairperson, County Treasurer and County Clerk (or any one or more of such officers of the County) to take any and all actions necessary or appropriate to carry out said intention and for the obtaining of such interest exclusion. Said Series 2011 Bonds are hereby determined to be obligations issued by the Agency on behalf of the County. Designation of said Series 2011 Bonds by the Agency as "qualified tax-exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Code by and for the County and the Agency is hereby authorized and confirmed and the County hereby covenants and warrants that it does not anticipate issuance directly by it or on its behalf of tax-exempt bonds or other tax-exempt interest bearing obligations in an amount in excess of \$10,000,000 in calendar 2011, excluding for such purposes any bonds or other obligations issued to refund (other than to refund in advance) any bonds or other obligations to the extent that the amount of the refunding bonds or other refunding obligations does not exceed the amount of the bonds or other obligations refunded. It is understood that said Series 2011 Bonds shall constitute an obligation of the Agency payable only from the sources specified in the authorizing resolution of the Agency, including amounts payable by the County under the Existing Service Agreement as amended by said Amendment to Service Agreement.

Section 4. Execution and delivery of the agreement as herein authorized shall be sufficient and effective to bind the County so long as made by the Chairperson and attested by the County Clerk. This resolution shall be in force and take effect from and after its adoption as provided by law.
