All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Mary Alice Johnson, declared the meeting was in session and that the meeting is being recorded. Johnson made note that the Open Meetings Law is posted on the door and the north wall. # **RESOLUTION 2011 - 40**

BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS OF WASHINGTON COUNTY, NEBRASKA:

WHEREAS, the Washington County Board of Supervisors agree that funds in the amount of \$16,600 should be transferred from the Washington County Building Fund #4050 to the Road Reconstruction Bond Fund #3700 until levied taxes are collected. Additionally, these monies are to be repaid to the Washington County Building Fund #4050 within the current budget year.

## **COUNTY CLERK**

Jessica Finkel, Atty for Jim Olsen, asked for clarification of intention of Resolution 2011-35 from August 9<sup>th</sup>, 2011 meeting in reference to lowering a hill on County Road 28 west of the intersection with County Road 29. Finkel said they plan to start lowering the road tomorrow which will hinder Olsen from taking his crops to market if they don't leave the road open. Talbot said the only thing the Board did with the Resolution 2011-35 was to lift the tabling from the January 25, 2011 meeting and let the Union Pacific Railroad Company proceed with the project and negotiations. The Board already approved the UPRR Co's design for the road and the Board and Road Supt have the supervision of this road. Olsen said he is worried the road will be closed and he and his neighbors will not be able to take their crops out. Olsen said the design is flawed and will create a snow trap. Olsen asked the Board to wait for one month, till after harvest, to start the work and to take time to look at the design again.

Cheryl Parsons, Road Supt, was present to discuss Road Matters and give a flooding update. Parsons met with Alan & Laura Schmidt and Steve Lovercheck to obtain permission to pump water out of a field and off of County Road P14. They may need to use Jim Realph's property also. Parsons will meet with the contractor to discuss the project. County forces will dig deeper ditches on that road also. Parsons will submit these costs to FEMA. So far, Parsons estimated emergency response costs are \$175,000.00 and FEMA is expected to come soon. In the southern part of the County, barricades on Co Rd 34 were moved to give access to the Ft Calhoun treatment plant. OPPD wanted to know the status of Co Rd 49, Road Dept is waiting for it to be dry enough to inspect, hopefully by the end of the week. Barricades have been moved on several roads that had been closed due to flooding. Parsons gave the Board a listing of the Bridge Inspections completed by Peggy Smith, Burt County Road Supt. Board received listing and placed on file.

Dan Norman with Civil Solutions discussed the engineering agreement for the repair and extension of a culvert on Co Rd 3. Norman said they will need to do a 404 Permit with the Corp of Engineers, wet land delineation, survey, design and plan preparation. Parsons felt her crew could do this project. Motion was made by Hineline second by Kruger to accept the engineering contract for \$5,885.00. Vote Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Road Committee will meet Monday, September 19<sup>th</sup>.

It was moved by Kruger and seconded by Abariotes to accept the Sheriff's Inventory and place on file. Vote Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 10:00 A.M. the Board received bids on a new 2012 tandem truck cab and chassis with a dump truck body, snow plow and sander-spreader with a 1996 dump truck for a trade in. Bids were received from: Cornhusker International Trucks Inc \$120,894.00; WiseMack \$125,892.00; Omaha Truck Center \$120,841.00; Volvo Truck - Kenworth \$138,055.00; Volvo Truck - Volvo \$145,502.00. Motion Clausen second Kruger to refer the bids to the Road Committee. Vote Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Wash Co Ext Office, Steve Tonn was present to discuss the landscape project at the east annex of putting up some kind of structure, using grant funds and donations. Dave Wulf, representing Riverside Grange, offered \$3,000.00 to put up a structure. Tonn asked for permission to pursue their offer. Motion was made by Kruger second by Clausen to give permission to proceed and come back with project plans. Vote Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

County Clerk Merry Truhlsen was present. Motion by Abariotes second by Hineline to open the public hearing on the 2011-2012 Budget and County Levy. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman gave a brief overview and stated the levy is slightly lower than last year. Public comment was heard from Wes Stamp, Pam Daly and Dennis McCormick. Gary Pavel, CPA who assists with budget preparation spoke. Board discussed different aspects of the budget and a situation that may involve refunding money to Cargill. Motion by Clausen second by Kruger to close public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman stated the next agenda item was the adoption of Resolution 2011-41 approving the 2011-2012 Budget. Clerk read the Resolution. Motion Kruse and second by Quist to adopt Resolution 2011-41. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Abariotes. Nay: Hineline. Motion carried.
