March 13, 2012 Minutes Washington County Board of Equalization Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 8:30 A.M. on Tuesday, March 13, 2012 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen, County Assessor Steven Mencke, Deputy Jean Ray, Kris Husk and Deputy County Attorney Ed Talbot. Motion by Kruse and second by Clausen that the rules be suspended and that the minutes of the Feb 14th meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Motion by Kruger second by Kruse to open a public hearing on all applications for tax exemptions for properties. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Mencke gave the Board a listing of the 2012 Form 451 applicants and information on the Dana College properties. Mencke stated he had approved all the applications except for Dana College. Mencke said the reason he didn't recommend approval was because the applications weren't filled out correctly and Dana didn't submit copies of leases with the original applications. Mencke said he wouldn't consider the corrections and new information unless new applications were filed. Dana would need to submit a letter to the Board requesting a waiver that would allow Mencke to reconsider the applications. Board discussed the information. Several representatives for Dana College were present. Mark Wagner, Cordes & Company, who was appointed as receiver of the assets for Dana College, said they noted there were some initial errors in the applications that were submitted and did submit additional information on the use of the facility, with copies of leases to the County Attorney and the County Assessor as the Board requested at the Feb 14th meeting. Wagner said they could resubmit the applications, but said it is a bit of an administrative process to resubmit the information with all the entities involved. Board discussed the Dana properties and asked Talbot for for an opinion on how to proceed. Talbot asked the Board not consider the additional information that was submitted but said if Dana would file supplemental applications they could be filled out correctly and could include the lease information for the Assessor to reconsider. Wagner asked that the initial applications for Dana College be withdrawn and said they will resubmit the applications to the Assessor. Motion by Clausen second by Kruger to close public hearing. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Quist second Clausen to approve the 2012 Form 451 Exemption Applications for Property Permissive Exemptions as presented by the Assessor, excluding the 14 Dana College properties, which were withdrawn at this time. Vote- Aye: Clausen, Kruse, Ouist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
