January 10, 2012 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County met in regular session at 8:30 AM on Tuesday, January 10, 2012 in the Supervisor's Room at the Courthouse, Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

County Clerk, Merry Truhlsen, declared the reorganizational meeting for 2012 was in session and that the meeting is being recorded. Clerk made note that the Open Meetings Law is posted on the door and the north wall. Present: Mary Alice Johnson, Kent Clausen, Jerry Kruse, Jeff Quist, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, Deputy County Attorney Ed Talbot.

The first order of business was that of electing a chairperson. Clerk requested nominations for Chairman. Abariotes nominated Johnson. Quist moved, seconded by Kruger, that nominations cease. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Mary Alice Johnson is the Chairperson of the County Board. Clerk next requested nominations for Vice-Chairman. Kruger nominated Quist. Kruse moved, seconded by Kruger that nominations cease. Vote- Aye: Clausen, Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: None. Quist abstained. Motion carried. Quist is Vice-Chairman of the County Board. Chairperson Johnson presided over the meeting.

Abariotes moved, seconded by Kruse to approve the agenda for January 10th, 2012. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Next item of business was to designate depositories for County funds. It was moved by Kruger and seconded by Abariotes that all of the banks in Washington County and the Nebraska Public Agency Investment Trust (NPAIT) be designated as depositories for County Funds in 2012. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Abariotes and seconded by Kruger to authorize County Treasurer, Marj Hoier, to invest County Funds in any of the designated depositories. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Quist made a motion to approve the minutes, but withdrew his motion. Pam Daly asked that corrections be made to the Dec 27th minutes regarding officials raises and a flood update. Board discussed the minutes. Hineline made a motion to correct the minutes, but then rescinded his motion. Kruger moved, seconded by Kruse that the minutes of the Dec 27, 2011 meeting where it said "*Motion by Clausen second by Hineline to go back to the earlier flood update agenda item and amend it*" be corrected to read "*go back to the earlier flood update discussion and amend it*" and that minutes be approved with aforementioned correction but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Kruger, Abariotes and Hineline. Nay: Johnson. Motion carried.

Kruse moved, seconded by Quist to approve monthly fee reports: Co Clerk \$243.00, Reg of Deeds \$66,301.00, Co Court \$16,192.25, Co Plan Dept \$5,697.00, Clk Dist Crt \$1877.00, Co Sheriff \$3,384.92, and Road Dept \$175,917.06. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. The following correspondence had been received: the Pesticide & Noxious Weed Newsletter, Nebr Assoc of Co Officials 2020 Co Gov Committee Report, NIRMA quarterly loss report, letter from Insurance Services Office regarding the evaluation of building code enforcement and letter from Federal Emergency Management Agency revalidating the determination for 5 properties in the County as described in the Letters of Map Change previously issued. Abariotes moved, seconded by Quist that the correspondence be received and placed on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Marj Hoier, County Treasurer, had submitted the Semi Annual Statement to the Board, showing the summary of collections, disbursements and balances of various funds for July 1, 2011 through December 31, 2011. Motion Clausen second Quist to receive the semi-annual statement and place on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Motion Kruger second Clausen to designate the notice of meetings will be published in the local newspaper: Enterprise and Pilot Tribune, on the County's website <u>www.co.washington.ne.us</u> and for emergency situations will post a notice at the

Courthouse. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. At 8:46 AM, Abariotes moved, seconded by Kruse to convene as Board of Equalization. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. See separate minutes. Board adjourned from BOE at 8:50 AM and reconvened in regular session.

Cheryl Parsons, Hwy Supt, Road Dept, had given the Board a letter from the Department of Roads saying they are in the process of reviewing local Federal-Aid files. Six inactive projects were listed and for a limited time, NDOR is requesting the County to voluntarily pass a resolution to withdraw its inactive Federal-aid projects. In return, NDOR will waive all State-incurred expenses relating to those projects, which amounts to \$7,174.73. Parsons suggested a couple Board members and herself go to the NDOR and talk to Mr. Wilkinson about several issues. This will be discussed further at the Road Committee meeting on January 16, at 7:00 PM, in the Board room.

Parsons had received correspondence from Cargill asking the County to explore the possibility of vacating their easement for the existing road known as South 4th Street. Bryan Wrightson with Cargill was present. Board briefly discussed closing this road. Clausen moved, seconded by Kruse, to direct Hwy Supt to do a road study on South 4th Street, outside the Blair City limits. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Julie Ogden, JEO Consulting Group, gave the Board additional punch list information and pictures on Bridge C89 2020. Ogden went through the update. Board questioned Ogden on several issues and expressed their displeasure with the bridge deck, grouting, sealant, guard rail and the need of an additional plate among other things. Quist expressed his displeasure with the bridge and wondered if the Board should have another engineer inspect the bridge. Quist moved, seconded by Kruger, to contact the Dept of Roads to have an engineer inspect Bridge C89 2020. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Ogden next discussed the box culvert on County Road 31, which is over 20 days past the completion date. Board discussed the bridge further. Scott Wiekhorst, Investors for Infrastructure, contractor on both projects, gave a quick update on the box culvert and asked to meet with a couple Board members to go over the delays encountered on Bridge C89 2020, which was scheduled for completion on 10/4/2011. Wiekhorst stated for the record they would give the County a ten year warranty on the bridge.

Talbot said the Emergency Flood Sub-Committee met and approved issuing blanket conditional building permits for unincorporated residents that were affected by the Missouri River flood. The Committee met prior to January 6th, which is the date the new FEMA flood maps went into effect. The conditional building permits were adopted as a means to give people time to appeal the substantial damage report they receive on their property. Parameters and policies will be set up as to how the Board will review the permits prior to making a final decision. Kruse moved, seconded by Abariotes to ratify the conditional building permits, approved by the Emergency Flood Sub-Committee, to offer an appeal process to those properties affected by the Missouri River flood. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 9:45, motion was made by Clausen and seconded by Quist to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman stated the reason for the closed session was for the prevention of needless injury to the reputation of an individual regarding employee evaluations. At 10:03 AM, Kruger motioned, seconded by Abariotes to end the closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was for the prevention of needless injury to the reputation of an individual regarding employee evaluations. Kruse, Ruse, Ruse,

Jeffrey Hofer won the annual Fort Calhoun High School, Youth Engaged Speech Award. Hofer gave his presentation, entitled "From Ghost Towns to Growth Towns", on ways the Board can attract and retain young people to the County. Hofer discussed several ways to help the youth in our county, one of which was a need for a county wide community center. Board thanked Hofer for the presentation.

There were no comments from the public. Clerk commented on the large amount of mail the Board is receiving from the Fundamentalist Latter-day Saints Church.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Quist that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
