The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 9:05 a.m. on Tuesday, March 13, 2012 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Mary Alice Johnson, declared the meeting was in session and that the meeting is being recorded. Johnson made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Steve Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot.

Motion Abariotes second Kruger to approve agenda for March 13th, 2012. Vote-Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Hineline and seconded by Abariotes that the rules be suspended and that the minutes of the February 28, 2012 meeting be approved with the following correction "Pam Daly described alleged Open Meeting Act violations regarding the Board's minutes and information available to the public at the Board meetings.", but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Kruger and seconded by Kruse that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$206.00, Reg of Deeds \$21,582.00, Co Court \$18,727.13, Co Plan Dept \$3,189.00, Clk Dist Crt \$1106.00, Sheriff \$2,729.41 and Road Dept \$27,560.00. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Holstein Veterinary Clinic Open House Friday, March 16, information on a Stormwater Regulation seminar, Board is invited to join Leadership Washington County for Government Day in Lincoln and open house for Walmart on Wednesday. It was moved by Quist and seconded by Kruse that the correspondence be received and placed on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Phil Lorenzen, DA Davidson & Co, had information on bond issuances for highway projects, talking about possible funding for the Fort Calhoun West road paving project. Lorenzen discussed low interest rates, the County's current bond issues, and had several scenarios for the Board to consider. Once the County is ready to bid the project, Lorenzen would discuss this further.

Cheryl Parsons, Road Supt, submitted a partial payment for Project C89(472) box culvert on CR31 to Investors for Infrastructure. There are still a couple of unresolved issues regarding a cut cable and the extra days it took to complete the project. Motion by Abariotes, second by Kruse to pay \$8,187.31 to Investors for Infrastructure for Project C89(472) Box culvert on Rd 31. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Dennis McCormick had asked the Board to support LB976. Kruse moved, seconded by Hineline to send a letter of support to State Senator Lydia Braesch and the Revenue Committee on LB976, which would exempt social security benefits from Nebraska income tax. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Hineline. Nay: Abariotes. Motion carried.

Jesse Gonzalez spoke to the Board about the Safety Committee recommendation to install awnings over the doors connecting the Courthouse buildings and electrical heat tape on the gutters above those doors to prevent icicles from forming. Board discussed making the door by the Treasurer's office the handicap entrance to the Courthouse and closing the current handicap entrance, which would eliminate the need of an awning. Kruger moved, seconded by Kruse that the Building and Grounds Committee work with Gonzalez to move forward getting bids for a concrete ramp to make the west door by the Treasurer's office handicap accessible. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Board will discuss the awning and heat tape at a later date.

Clerk had advertised a Notice of Amended Budget Hearing to amend the previously adopted budget. Abariotes moved, seconded by Hineline to open the public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Clerk said the changes made are a reduction of valuation in the amount of \$131,600,416.00 due to a Personal Property Exemption of Cargill Inc and Cargill Polyols that was first denied then granted by the State Department of Revenue. The General Fund total requirement originally was \$8,429,375.97, the amended amount is \$7,914,390.85. The Proposed 2011 Tax Rate remained the same at .391325 but the Unused Budget Authority changed to \$1,005,504.72. Kruger moved, seconded by Clausen to close the public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Kruger moved, seconded by Quist to adopt the amended budget as presented. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

County Assessor Steven Mencke had given the Board preliminary information regarding Metropolitan Area Planning Agency's Nebraska Iowa Regional Orthophotography Consortium project. Every three years MAPA works with agencies to coordinate a plan for having aerial photography done. Mencke recommended participating in this and said besides the aerial photos being beneficial to the Assessor's office, the Sheriff's Office and Planning and Zoning also use them. Motion Quist second Clausen to participate in the NI-ROC project with the cost not to exceed \$25,000. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Julie Ogden, JEO Consulting Group, discussed updating the engineering plans for the Ft Calhoun West road paving project, known as JEO Project #980173.00 (089p3) Ft Calhoun II dated October 1995 and Project #000161 (089gr3) Kennard Southeast dated February 2000, to get them ready to go out for bids. The Board had talked about this at the Road Committee meeting. Ogden gave the Board information on amending the existing engineering agreement and a tentative timeline to update project plans, at an estimated cost of \$59,500. Ogden said bidding both projects at the same time would save money on permits, etc. The first step in moving forward on this would be to have a site visit, to see how many changes need to be made to the plans. Ogden also said design standards have changed since the plans were drawn up. Board requested this be put on the March 27th meeting agenda. Abariotes left the meeting.

Clerk reported she received a list of 2012 Tax Sales from the County Treasurer. On March 5th, 44 bidders bought 123 properties for \$216,696.44. Kruger moved, seconded by Hineline to receive the list of 2012 Tax Sales from Marj Hoier, County Treasurer, and place on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Hineline. Abariotes absent. Nay: None. Motion carried.

Chairperson Johnson discussed appointing Board members to a Jail Review Subcommittee. This standing subcommittee hasn't been active for a couple years. Sheriff Robinson said it would be helpful to have the committee to talk to when issues arise. Chairperson appointed Abariotes, Kruse and Johnson to the committee.

Comments from public: Dennis McCormick spoke.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Quist that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Clausen was absent. Nay: None. Motion carried.
