July 24, 2012 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, July 24, 2012 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Mary Alice Johnson declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot. Chairman said there would be no Board of Equalization at 8:30, but BOE would convene at 10:30.

Motion Quist second Kruse to approve the agenda for July 24, 2012. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Clausen and seconded by Quist that the rules be suspended and that the minutes of the July 10, 2012 meeting be approved. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion by Kruger second by Kruse that the minutes of the July 12, 2012 budget workshop meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Hineline. Nay: None. Abariotes abstained as he wasn't at the meeting. Motion carried.

The following correspondence had been received: Nebr Dept of Roads Surface Transportation Program book and letter from FEMA regarding an August 10th meeting with the Wash Co Planning & Zoning Dept. Motion Kruger and second Clausen to receive correspondence and place on file. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Highway Superintendent, gave a brief update on road issues.

At 8:45 A.M., motion was made by Kruse and seconded by Kruger to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman stated the reason for the closed session was a discussion with legal counsel and possible action RE: Bridge Litigation, for the protection of the public interest. At 9:05 A.M., motion by Kruger and second by Hineline to end closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was discussion with legal counsel and possible action RE: Bridge Litigation, for the protection of the public interest. Johnson said the only action taken was to say a subcommittee consisting of Hineline, Johnson and Quist, may meet with Parsons and Talbot if necessary, before the next regular Board meeting.

At 9:15, Board considered a Substantial Damage Assessment appeal from John Wooden. Board had requested Wooden provide papers showing ownership of the property previously leased by Jeri Hoffman. Quist said the ownership papers were provided. Motion Clausen second Kruse to approve the SDA appeal from John Wooden. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger and Abariotes. Hineline abstained. Nay: None. Motion carried.

The Board room was filled with people for the public hearings on conditional use permits. Barb Brazelton, Interim Planning and Zoning Administrator, had the following items:

1. Conditional Use Permit application for Jerome & David Sperling % Monke Brothers Fertilizer/Tom Monke - To construct an Anhydrous Ammonia Plant on the SE1/4 SE1/4 in Section 17-Township 17 -Range 10 (general location: corner of County Roads 36 and 15). Motion by Kruse, second by Clausen to open a public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Brazelton discussed the CUP and went through the Planning Board recommendation to approve with the following conditions: 1) That County Road 36 is paved 100 foot past the last entrance into the plant. 2) That Co Rd 15 has a paved turning and passing lane at the intersection of Co Rd 36, to be paved at the expense of the applicant. 3) No access off of County Road 15. 4) A site plan must be available before going to the County Board. 5) Any upgrade to the shoulder must be cement. Kruse asked to see the site plan. Tom Monke apologized

for not having the site plan completed. Monke said modifications were made, after meeting with the Road Dept, to the entrance, exit and other changes as requested and it did not get completed. Chairman stated the CUP would not be voted on today as the site plan was not completed but public testimony would be heard. Those speaking in opposition to the CUP were Mary Thompson, Amy Vermeleen- who also handed in a petition requesting denial of the CUP, Bob Pfeiffer, Sara Hasenauer and Ted Henkenius, Tom Christensen spoke in support of the CUP. Motion by Kruger second by Kruse to close the public meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion by Hineline second by Abariotes to refer this back to the Planning Commission to get all the applicable information before bringing it back to the Board. Vote- Aye: Kruse, Johnson, Kruger, Abariotes and Hineline. Nay: Clausen and Quist. Motion carried. 2. Conditional Use Permit application for Scott and Linda Swanson- To allow the operation of a private recreation area on Tax Lot 10 all in Section 6-Township 17 -Range 12 (address: 6817 County Road P35). Motion Kruger second Kruse to open a public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Brazelton discussed the CUP and the Planning Commission's recommendation to deny this. Greg Drew, Atty for Swansons, discussed the CUP, spoke of the conditions that have been met and stressed this would be good only until November 4, 2012. Several people spoke in support of Swanson's CUP: Brenda Orr, Cindy Mailloux, Nick Swanson and John Wakefield. Board discussed the CUP. Motion by Kruse second by Kruger to close the public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Abariotes second Hineline to approve the Conditional Use Permit to allow for the operation of a private recreation area on Tax Lot 10 in Section 6- Township 17 -Range 12 as long as they meet the conditions set forth by the State Fire Marshall and County Building Inspector and said permit to be in effect until November 4, 2012. Vote- Ave: Clausen, Kruse, Ouist, Kruger, Abariotes and Hineline. Nay: None. Johnson abstained as she has a property in Blair for the same purpose. Motion carried.
