The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, November 27, 2012 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Mary Alice Johnson declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Mary Alice Johnson, County Board Members, Kent Clausen, Jerry Kruse, Jeff Quist, Ernest Abariotes and Ron Hinline. Steven Kruger was absent. Also present, County Clerk Merry Truhlsen and Deputy County Attorney Ed Talbot.

Chairman said there was no Board of Equalization today. Motion Kruse second Clausen to approve the agenda for November 27, 2012. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. It was moved by Kruse and seconded by Clausen that the rules be suspended and that the minutes of the Nov 13, 2012 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Motion Kruse second Clausen to accept the monthly fee report from Planning Dept for \$6,745. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. There was no correspondence.

Cheryl Parsons, Hwy Supt, read a resolution to change a portion of County Road 38 from Rural Local to minimum maintenance (Co Rd 38 east of Co Rd P25) as discussed at the November 13 meeting. Motion Abariotes second Kruse to adopt Resolution 2012 - 34 changing a portion of County Road 38 to minimum maintenance. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.

**RESOLUTION NO. 2012-34**

**BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS, WASHINGTON COUNTY, NEBRASKA:**

That a change in classification be made to a portion of County Road 38, measuring approximately 990 feet in length, on the east end of said road between Sections Twenty-One (21) and Section Twenty-Eight (28), Township 17 North, Range 11 east of the 6<sup>th</sup> PM in Washington County, Nebraska and particularly described below:

That part of road number 38 lying in the southwest quarter of section 21, and lying in the northwest quarter of section 28, township 17 north, range 11 east of the 6<sup>th</sup> p.m. Washington County, Nebraska, said road having a width of 66.0 feet and lying 33.0 feet on each side of a centerline that is described as follows:

Beginning at the southwest corner of section 21, thence easterly on the quarter section line between section 21 and section 28, a distance of 990.0 feet, more or less, to the center of the Big Papillion Creek, said point being of termination. Containing 1.50 acres.

NOW, THEREFORE, BE IT RESOLVED BY THE WASHINGTON COUNTY BOARD OF SUPERVISORS as follows: pursuant to Neb. Rev. Stat. 39-2103 Article (8), this portion of County Road 38 be designated as "Minimum Maintenance," and be signed as such, located between Section 21 & 28, Township 17 North, Range 11 East of the 6<sup>th</sup> PM Washington County, Nebraska.

Parsons set the Road Committee meeting for December 4, 2012 at 7:00 PM.

Parsons next discussed a fracture critical bridge on the Douglas County line. When the State had these bridges inspected in 2008, they closed this bridge. The Road Dept did repairs, then lowered the tonnage and were allowed to open the bridge, which is the only means of access for 5 or 6 families. Federal funding was applied for and the County did sign an agreement with Douglas County to replace the bridge. That funding was denied and now Douglas County is looking to replace the bridge, doing a cost share with Washington County. Parsons had a supplemental interlocal agreement with Douglas Co where they will be the lead on this project, using County dollars, and Washington County will pay half. Talbot had looked the supplemental agreement over and made some changes. Motion Clausen second Kruse to approve and authorize Chairman to sign the supplemental agreement with Douglas County. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.

Parsons handed the Board a listing of projects the Road Dept has completed this fall and projects yet to be completed. Parsons went over the information with the Board.

Clerk read Resolution 2012-35. Motion Abariotes second Kruse to adopt Resolution 2012-35 regarding Courthouse Holidays for 2013. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.

Tanna Wirtz, Planning and Zoning Administrator, had the following items:

Conditional Use Permit application for Rhea Cattle Company % William Rhea. To stockpile ProCal 40 SE1/4 NW1/4 in Section 10-Township 17 North-Range 10 East of the Sixth P.M. (general location: 5935 McCall Lane). Motion Clausen second Kruse to open a public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried. Wirtz discussed the request, saying the Planning Commission approved the CUP with the condition to follow all current 7.18 corn milling/bio solids regulations but the current Bio-solids Regulation 7.18 does not address stockpiling. Wirtz recommended including stockpiling as a condition of the CUP. Board had a lengthy discussion with Bill Rhea, Kathy Rhea, Talbot and Parsons, on the zoning regs regarding spreading and stockpiling ProCal40 and the need to amend the zoning regulations to address these issues. Motion Clausen second Kruse to close public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried. Motion Clausen second Hineline to approve the conditional use permit based on the current regulations, to include land application, then go back to update the zoning regulations concerning stockpiling and gypsum byproducts and then amend Rhea's CUP to include stockpiling. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried.

Washington County Zoning Regulations text amendment, Article 6 Conditional Use Permits Section 6.03: Authority to Initiate and Section 6.15: Scope of Approval. Motion Kruse second Clausen to open public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hineline. Nay: None. Motion carried. Wirtz read the CUP Amendment Draft: 6.03 Authority to Initiate; A request for a conditional use permit, or modification of a conditional use permit, may be initiated by a property owner, the owners authorized agent, a lessee with the authorization of the land owner, the Planning Commission or the Board of Supervisors. 6.15 A CUP granted pursuant to this section applies to a specific parcel of land. A CUP does not automatically transfer with ownership. It becomes null and void upon the change of ownership unless one of the following procedures is utilized. 6.15.01 Transfer of Ownership or Lease, Existing CUP; An existing conditional use permit will transfer with lease or property ownership as long as all terms, conditions and uses remain exactly as stated in the original permit. The new lessee or property owner must notify the Planning Administrator upon transfer. The new lessee or new owner must sign an affidavit stating that they are aware of all conditions and will comply by those conditions of the existing CUP. The transferred CUP will

be reviewed after one year. 6.15.02 Transfer of Ownership, New CUP; In the event that a potential buyer intends or proposes a land use that requires a conditional use permit, the property owner and a potential buyer may apply for a new conditional use permit contingent upon receiving the CUP. The permit will be conditioned upon the transfer by deed of the property. Upon transfer, all land use, practices, terms and conditions of the permit will be granted to the buyer as approved. Board discussed the changes. Motion Kruse second Clausen to close public hearing. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Motion Kruse second Clausen to concur with the Planning Commission recommendation to approve the Washington County Zoning Regulations text amendment, Article 6 Conditional Use permits Section 6.03: Authority to Initiate and Section 6.15: Scope of Approval. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Wirtz next discussed various issues with the Board, including 911 addressing, requests from flood victims and contractor permits.

Johnson said the budget committee had met with Wirtz and recommended changing Mary Shearer's employment classification to a full time employee. Quist spoke of the work load and the need to have someone answering the phone. Motion Quist second Clausen to hire Shearer as a full time employee. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.

At 10:30 AM motion was made by Clausen and seconded by Abariotes to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Chairman stated the closed session would be a conference call with NIRMA Attorney John Christensen, in order to protect the public interest with respect to litigation regarding a motorcycle accident, May 28, 2012 on County Road P51. At 11:10 AM, motion by Quist and second by Clausen to end closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Chairman again stated the closed session was a conference call with NIRMA Attorney John Christensen, in order to protect the public interest with respect to litigation regarding a motorcycle accident, May 28, 2012 on County Road P51. No action was taken. Board took a short recess.

At 11:20 AM motion was made by Kruse and seconded by Clausen to enter into closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Chairman stated the reason for the closed session was in order to protect the public interest with respect to Sheriff's Office FOP labor negotiations and litigation. At 11:45, motion by Clausen and second by Hinline to end closed session. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was in order to protect the public interest with respect to Sheriff's Office FOP labor negotiations and litigation. Motion Quist second Kruse to: recommend Jeff Young fit into one of the CIR classifications and be paid out of the money set aside for the labor negotiation settlements; pay the employees not in the FOP a 1% raise for July 2011 through June 2012 and a 1½% raise for July 2012 through June 2013; and that the settlements for the employees not included in the FOP be paid from the Sheriff's budgets. Clerk stated in her opinion at budget time, no mention was made as to paying any of the settlements out of the Sheriff's office budgets, but money was set aside in the Miscellaneous Budget for this purpose. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Quist and seconded by Kruse that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Clausen, Kruse, Quist, Johnson, Abariotes and Hinline. Nay: None. Motion carried.
