

**February 12, 2013 Minutes

The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 8:30 A.M. on Tuesday, February 12, 2013 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door of the north wall. It was moved by Hinline and seconded by Kruse to have the Treasurer issue checks on the corrections for the Rogge and McIntosh properties as presented by the Assessor. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion Carried.

At 8:40 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Hinline and second by Abariotes to adjourn meeting until the next Board of Equalization meeting date, Feb 26, 2013. All members present voted aye. Chairman declared meeting adjourned.
