The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, April 23, 2013 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen.

Motion Kruse second Kruger to approve the agenda for April 23, 2013. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Kruse and seconded by Johnson that the rules be suspended and that the minutes of the Apr 9, 2013 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Cerio said he would like some corrections regarding the Ft Calhoun students presentations. Board voted on motion-Vote- Aye: Kruse, Kruger and Abariotes. Nay: Cerio, Johnson, Quist and Hineline. Noes have it, motion is lost. Cerio moved, seconded by Hineline to approve minutes with corrections Cerio will provide. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Dept of Rev Feb Lodging tax is \$693.78 and a letter from District Judge John Samson and County Judge Matthew Samuelson regarding increasing the court appointed attorney hourly rate to \$75.00/hour. Motion Kruger and second Abariotes to receive correspondence and place on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Chairman stated the update on the engineering of Ft Calhoun West Project RS-3840(7) and removing the culverts will be moved to the May14th agenda. Motion Kruger second Cerio to postpone these items until the next meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board had received a copy of the agreement and corresponding resolution for inspection and load re-rating on county fracture critical bridges with Dept of Roads. The cost to the County for this work for 16 bridges is approximately \$6,477.92, minus soft match credit. Clerk read resolution. Motion Kruger, second by Hineline to approve the Nebraska Dept. of Roads 2013 Fracture Critical Bridge Inspections/Load Re-ratings agreement and adopt Resolution 2013-8, subject to review by County Attorney's office. Vote- Aye: Cerio, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Communications Capt. Phil Brazelton and Sheriff Mike Robinson discussed an upgrade agreement with Motorola for the countywide radio system. Brazelton said in the past there was grant money to cover the cost of upgrades, now the County must pay for this. The upgrade will cover software, hardware and implementation services for one system infrastructure upgrade in a two-year period. Motion Johnson second Hineline to approve the ASTRO 25 System Upgrade Agreement II (SUA II) at an annual cost of \$19,500, pending review by the County Attorney's office. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Dennis McCormick discussed the county sending a bill to Tim Andersen for damage on CR34 and CR38 ditches. Kruger said Hwy Supt Cheryl Parsons will send a bill to Andersen for both sites at the request of the Board. Later in the morning, Joyce Graybill, whose property is on CR38, informed the Board she had received an e-mail from OPPD, and OPPD will be sending a bill to Andersen for damages on CR38. Tim Andersen was present at this time. Andersen said he thought this issue was closed and said he has cleaned out ditches before and it has not been an issue. Andersen said there were no County regulations or permits in place at the time this was done and he had permission from the Road Dept. Pam Daly, Robbin Jeffrey and Wes Stamp spoke in favor of sending Andersen a bill.

Quist said he and Kruger went to the NRD meeting where merging Washington County Rural Water Project #1 & #2 was discussed. Quist said RWP#1 comes out of Omaha, serves the Ft Calhoun area and is financially solvent. RWP#2 is a different project that comes out of Blair and is having financial problems. The County paid to upgrade the line for future expansion on RWP#2. The NRD wants to combine RWP#1 & 2. Board discussed this proposal. Robbin Jeffrey spoke. Motion Cerio second Johnson to send a letter to the Papio-Missouri River NRD expressing Board's concern for merging WCRWP#1 & #2. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Arlington Youth Sports applied to the Nebr Liquor Control Commission for a Special Designated Liquor License for a tractor pull at Wash Co Fairgrounds. This fundraiser will be held on June 22, 2013. Clerk read resolution. Motion Kruse second Kruger to adopt Resolution 2013-10 recommending approval of the application. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Wirtz discussed the CUP. Motion Johnson second Kruse to concur with the Planning Commission recommendation to renew CUP 94-11 with a review in five years. Vote- Aye: Clausen, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Wirtz also updated the Board on 911 addressing at DeSoto Park Estates, amending zoning regulations regarding biosolids and updating the County's flood-plain resolution.

Ben Scherer and Pam Daly, members of the advisory committee for Region 6 Behavioral Healthcare, discussed their request for the Board to send a letter asking for data by county from Region 6. Daly read the letter she drafted which said this information would, among other things, assess the extent to which county residents use Region 6 services, measure the impact of interventions and improve access to treatment. The Magellan Company, who contracts with the State, is the administrative branch that compiles data for Region 6. Patricia Jurjevich, Regional Administrator with Region 6 Behavioral Healthcare, talked of the difficulty of obtaining data from Magellan and said there is no connection between the payment data and the demographic data for Behavioral Healthcare. Jurjevich said they have made numerous requests for improved access to information. Board discussed the information and the method of determining the County's contributions to Region 6. Scherer and Jurjevich talked about the procedures for emergency protective custody. Robbin Jeffrey spoke. Motion Hineline second Abariotes to send a letter to the 5 people listed, after the County Attorney's office reviews it. Vote- Aye: Cerio, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 10:00 AM a public hearing was held to consider a new application for a Class C Liquor License for Riverview Park LLC. Motion Abariotes second Kruse to open the public hearing. Vote- Aye: Cerio, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Jason Armstrong discussed the recreational vehicle park, called Riverview Park, they are constructing and said they would like to operate a convenience store for campers. Board discussed the application with Armstrong. There were no comments from the public. Motion Kruse second Kruger to close public hearing. Vote- Aye: Cerio, Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Clerk read the resolution. Motion Kruse second Kruger to adopt Resolution 2013-9 recommending approval of the Class C Liquor License for Riverview Park LLC. Vote- Aye: Kruse, Quist, Johnson, Kruger, Abariotes and Hineline. Nay: Cerio. Motion carried.

Johnson discussed the Personnel Committee's 6 month review of the Planning Administrator and said the committee's recommendation is to raise her annual salary by \$1,500, making it \$49,500. Motion carried.

Kruger stated he attended the Legislative Day for County Officials and said it was informative. There were no comments on legislative bills

Kruger, Chairman of Finance Committee, went over the Committee's recommended budget timeline. Kruger said this provides a general outline that could be used in future years. Kruger moved, seconded by Johnson to adopt the Finance Committee's budget timeline. Board discussed the timeline and having evening meetings. Robbin Jeffrey spoke. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Chair said the next agenda item is determining who is going to prepare the budget. Kruger said Pete Petersen, from Ogallala, would agree to be the County's budget consultant for \$3,000 plus mileage. Kruger said he also talked to Clerk Truhlsen about preparing the budget. Kruger moved, seconded by Kruse, to hire Truhlsen to do the budget for \$3,000. Board discussed the motion. Hineline said paying the Clerk must be done in a public bidding process according to state statute. Kruger and Kruse withdrew their motion until the County Attorney could review the statute. Discussion continued regarding the budget and the budget making authority. Robbin Jeffrey and Pam Daly spoke. Kruger moved, seconded by Hineline, to table discussion at this time, and before the next meeting, define the budget making authority and have the County Attorney office review State Statute 49-14,102. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Chair asked if there were any Committee reports: Kruger said the Jail Committee sent the changes suggested by the Board to Prochaska and asked if everyone was ready to vote on the law enforcement contract. If there are any more comments, please let Kruger know. Hineline talked about Three Rivers Health Department. The Technology Committee is meeting Friday.

Comments from the public- Pam Daly, Dennis McCormick and Scott Japp spoke.

At 11:40 am motion was made by Johnson and seconded by Kruger to enter into closed session. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hineline. Kruse absent. Nay: None. Motion carried. Chairman stated the reason for the closed session was in order to protect the public interest with respect to Sheriff's Office FOP labor negotiations and litigation. Kruse was present. At 12:23 pm, motion by Kruse and second by Abariotes to end closed session. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for the closed session was in order to protect the public interest with respect to Sheriff's Office FOP labor negotiations and litigation. No action was in order to protect the public interest with respect to Sheriff's Office FOP labor negotiations and litigation. No action was taken.
