The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:37 a.m. on Tuesday, August 13, 2013 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steve Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen.

Motion Kruse second Kruger to approve agenda for August 13th, 2013. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruse and seconded by Kruger that the rules be suspended and that the minutes of the July 23, 2013 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Kruse and seconded by Abariotes that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$307.50, Reg of Deeds \$54,997.25, Co Court \$17,914.70, Co Plan Dept \$10,309.00, Clk Dist Crt \$4380.68, Sheriff \$2,705.50 and Road Dept \$16,603.09. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. The following correspondence has been received: Community Planning Sessions on LB561 in Norfolk on Aug 28, MAPA's annual dinner is Oct 16th, Jail Standards Div will visit the Wash Co Jail on Sept 18, e-mail from Ed Schroeder, who lives on CR 32, asking if he could buy the property between his property at 10052 CR32 and the new road. It was moved by Kruger and seconded by Kruse that the correspondence be received and placed on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Phil Lorenzen, DA Davidson & Co, gave the Board information on various bonds the County has, reviewed the early pay off of the Courthouse Bonds in March 2013 and then discussed calling the balance of Highway Allocation Bonds in September as set out in Resolution 2013-20. Lorenzen next went over refunding the \$555,000 balance on the East Annex Bonds. Kruger said the Finance Committee's recommendation was to pay off the balance of the Highway Allocation Bonds. Motion Kruger second Hineline to use the balance in the bond fund and \$42,000 from Inheritance Fund to pay off the Road Reconstruction Bonds and adopt Resolution 2013-20. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Lorenzen said he would return in Sept to discuss refunding the East Annex Bonds.

RESOLUTION NO. 2013-20

RESOLUTION CALLING HIGHWAY ALLOCATION FUND PLEDGE BONDS, SERIES 2008, FOR REDEMPTION

BE IT RESOLVED by the Board of Supervisors of Washington County, Nebraska, as follows:

Section 1. That the following bonds are hereby called for redemption in accordance with the resolution providing for their issuance, at par plus accrued interest on September 15, 2013 after which date said bonds shall cease to bear interest:

Highway Allocation Fund Pledge Bonds, Series 2008, Dated September 15, 2008, in the principal amount of \$225,000, becoming due on September 15, 2015, issued by the County for the purpose of paying the costs of constructing streets and other related and appurtenant improvements in said County.

Section 2. Said bonds are payable at the office of the Washington County Treasurer, Blair,

Nebraska as Paying Agent and Registrar.

Section 3. A copy of this resolution shall be filed at least 30 days prior to the date of call with the Washington County Treasurer, Blair, Nebraska, as Paying Agent and Registrar and said Paying Agent and Registrar is hereby instructed to give notice of redemption in the manner provided for in the ordinance authorizing said bonds.

Cheryl Parsons, Hwy Supt., said there was a change order for the Ft Calhoun West project. Scott Cowles, JEO Consulting Group, Inc. said 2 cattle crossings were deleted from the plans and this resulted in reducing the contract price by \$93,940.40. Motion Hineline second Kruger to approve Change Order 1 for the Fort Calhoun West Grading and Drainage, a decrease of \$93,940.40. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Parsons had several project updates for the Board. Eric Obert, JEO Consulting Group, Inc. updated the Board on the deck reconstruction of the 2020 Bridge. They are meeting with the contractor today and the anticipated completion date for opening the bridge is mid-September. Obert next talked about the Ft Calhoun NW Project Bridge C89-02605P located on CR P26 and went over several scenarios regarding starting and ending dates. Board discussed advertising for the bridge in September and starting the project this fall. Matt Japp, Japp Construction, said grading on the Ft Calhoun West project is at a standstill, waiting for OPPD poles/lines to be relocated. OPPD has moved some poles, but there are still some in the ditch and in the way of the grading. Board asked Cowles to talk to OPPD about the situation. Parsons had information from Darin Brown, Schemmer Associates, Inc on the preliminary engineering for Bridge C89-02420, the bridge that has been closed due to damage by CVA Equipment. Brown submitted a bill for the portion of engineering completed. Parsons said it may be December or next spring before the structure will be open. Board discussed adding money to the Road Dept to repair this structure. Parsons talked about where road crews are working and said they spent a week hauling sand that was blowing across the Ft Calhoun bottom road. Parsons said a guard rail was installed on CR P39 and Township 2 paid the cost of \$8000. William Burdess talked about a problem with a culvert by his property.

Parsons talked about an agreement with the State and read Resolution 2013-19 on Project STP-31-2(110), Elkhorn North, CN 21991, regarding the resurfacing Spur S28J and project detour located by Washington Village. Motion Kruger second Kruse to adopt Resolution 2013-19 and authorize Chairman sign the agreement. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The Chairman of the Washington County Board of Supervisors is hereby authorized by the board to execute Resolution herein and the County Clerk is authorized to file said resolution

ATTEST: Merry Truhlsen County Clerk, Washington County Robert Denton, Chief Probation Officer for Probation District Six gave the Board a handout. Denton gave a brief review of the County's Probation office workload, employees and budget for operating expenses. Board had requested Denton talk about the recent juvenile justice legislation. Denton went through an overview of LB561 that listed several points of the legislation including shifting the supervision of juveniles to probation office and more State and grant funding. The legislation also sets limitations on sending juveniles to secure detention centers, which Denton sees as a positive move. A pilot program of this type has been in place in Douglas County for 4 years with good results. Board discussed the information. Denton gave the Board an article from Omaha World Herald regarding alternatives to prison.

Sheriff Mike Robinson told the Board they currently have 2 drug dogs, Tank and Panzer. The handler for Tank wants to resign his duties as handler and no other officers are interested in being a handler. Robinson said since the dog is county property, purchased with donated funds, he is requesting the Board's approval to retire the drug dog and see if another agency could use him. Motion Johnson second Kruger to approve retiring Tank the drug dog and sell the canine equipment. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Deputy Rob Bellamy said the Jail Committee met and prioritized some Law Enforcement building issues that were raised at last year's annual State Jail inspection. Committee recommends: 1) Replacing approximately 12 doors, some of which will have electronic locking mechanisms and glass panel inserts for supervision. 2) Replacing 9 or 10 inmate beds. Bellamy said a local welder said he could do the work for approximately \$10,000. 3) Cleaning the air ducts. Maintenance had received bids from Getschman-\$17,000 and Duct Medic-\$14,500. 4) Place a perimeter fence on the north and east side of the building as a buffer between the jail cell windows and the public. Bellamy spoke of numerous incidents which demonstrate the need of the fence. Bellamy had received several bids on 8' tall colored vinyl/metal chain link fences with privacy panels: Cardinal Fence Covinyl \$7,439, metal \$6,629; Quality Fence Co-vinyl \$7,596, metal \$6,691; Diamond Fence Co-vinyl \$8,395, metal \$5,395. Board discussed the fence. Motion Kruse second Kruger to authorize Sheriff's office to order vinyl fence from Cardinal Fence for \$7,439. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Kruger, second Abariotes to authorize Bldg & Grnds and Sheriff's Office have the duct work cleaned in Law Enforcement bldg. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. 5) As a result of an incident in the jail, glass blocks were placed in certain cell areas. These glass blocks are restricting air flow and it's been suggested that maintenance start removing glass blocks from certain cells to see if this will improve air flow. Board discussed the various issues.

Finance Committee recommended adopting a resolution to allow a 1% increase to budget limit pursuant to Nebr. Budget Act NRS 13-518 to 13-522. This would be a 1% increase to the allowable dollar amount to restricted funds. Board discussed the resolution. Motion Kruger second Kruse to adopt the resolution. Vote- Aye: Kruse, Johnson, Quist, Kruger and Abariotes. Nay: Cerio and Hineline. Motion did not pass as this resolution requires the approval of 75% of the Board.

Cerio had put several budget items on the agenda for discussion: Allocating benefits by dept, Budget headings, Election Commissioner and Deputy's designation, Discuss how much money do we need in cash reserve and Schedule evening budget hearing. Board spent over two hours discussing these items with comments from Pam Daly, Wes Stamp and William Burdess. Cerio first spoke of the Budget Heading that said "Official Estimation" and said it should say "Official's Estimation". Clerk said that is how the MIPS program reads. Motion was made by Hineline, seconded by Cerio to show the employee benefits of social security, retirement and medical costs in each office budget of the General Fund. Board and public discussed this at length. Sheriff Robinson said he has concerns on making these changes to increase the office budgets and figuring the estimated cost of health insurance with the January health insurance renewal date. Hineline said his motion was to include actual costs of benefits in each office so the public could see what each department costs. Kruger said the 2012-2013 actual cost of each office's benefits and expenses is on the county website. Comments were heard from Daly, Stamp and Burdess supporting showing benefits in each department. Kruger called for the vote regarding putting employee benefits in each office budget. Vote-Aye: Cerio, Abariotes and Hineline. Nay: Kruse, Johnson, Quist and Kruger. The noes have it, motion did not pass. Cerio next talked about the Election Commissioner budget and raised his objections to the title Election Commissioner. Clerk said she performs the duties of the Election Commissioner in this county. Daly spoke of Statute 32-218 that says the deputy county clerk for elections should be a different party from the clerk. Clerk said the Board has never established the position of deputy county clerk for elections. Motion Kruger second Kruse to call this the "Election" budget and remove the word "Commissioner". Vote-Aye: Kruse, Johnson, Quist, Kruger and Abariotes. Nay: Cerio. Hineline abstained. Motion carried. Cerio next said his next item, "Discuss how much money do we need in cash reserve" is a question for the chairman of the finance committee. Kruger said currently the County has \$2,150,000 in cash reserve and State Statute allows up to 50% of the budgeted expenditures minus capital outlay, which for \$18 million would be \$9 million, and the County has \$2,150,000. The cash reserve has to carry us from year to year until the revenue from taxes comes in April and August. Cerio asked about the amount of money in the net fund balance line. Kruger handed out a spreadsheet of estimated expenses and allocated revenue for 2013-2014. Cerio next made a motion to schedule another evening meeting on Sept. 3 to discuss the budget, Hineline seconded the motion. Board discussed

the motion and discussed having the budget hearing, when the Board will vote on the budget, on Sept 10. Board voted on having a night meeting on Sept 3. Vote- Aye: Cerio, Abariotes and Hineline. Nay: Kruse, Johnson, Quist. Kruger abstained, as he would not be able to attend the meeting. Motion did not pass. Daly, Stamp and Burdess commented on various budget related items.

Motion Kruse second Johnson to adopt Resolution 2013-21 approving the application from Rise's Drive-In Liquor Inc for a Special Designated License. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
