The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, August 27, 2013 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen. Chairman said there was no Board of Equalization today.

Motion Kruse second Abariotes to approve the agenda for August 27, 2013. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruse and seconded by Kruger that the rules be suspended and that the minutes of the August 6, 2013 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Quist, Kruger, Abariotes and Hineline. Johnson abstained. Nay: None. Motion carried. Dennis McCormick spoke. It was moved by Kruger and seconded by Kruse that the rules be suspended and that the minutes of the August 13, 2013 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. The following correspondence had been received: Dept of Rev Lodging tax for June is \$1466.51 and a letter from Northeast NACO requesting applications for Sec/Treas. Motion Kruse and second Johnson to receive correspondence and place on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Parsons discussed purchasing a pickup and snow plow as budgeted. Motion Hineline second Kruger to allow Road Supt to advertise for a ¾ ton pickup and snow plow. Parsons said Peggy Smith, Burt Co Road Supt, who is a certified bridge inspector, had completed the annual inspection of Washington County bridges. Parsons gave the Board copies of the report. Motion Kruger second Kruse to amend the correspondence received and placed on file to include this bridge report. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Parsons discussed the progress on various road projects.

Dan Norman, Civil Solutions, presented a proposal for completing the engineering design for a box culvert to replace Bridge C89-00605 on Co Road 6. Structural deficiencies were noted at the annual bridge inspection prompting the Board's attention. Norman also recommended replacing the culvert on Co Rd 5, which is about 200' upstream, with a box culvert. Norman said there would be cost savings to include both structures in the engineering design. Board discussed the culverts. Motion Kruger second Johnson to have Norman include both structures in the engineering design at a cost of \$19,450. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Norman also discussed a request to put rock dams in a deep ditch on CR26. Norman said he would apply for a 404 Permit.
