The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, November 26, 2013 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, Deputy County Clerk Carol Kuhr. Chairman announced there was no Board of Equalization today. Motion by Kruger and second by Kruse to approve the agenda for November 26, 2013. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: none. Motion carried.

It was moved by Kruse and seconded by Johnson that the rules be suspended and that the minutes of the November 12, 2013 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: none. Motion carried. In the public comment time slot, Cerio said the newspaper minutes for Nov. 12th regarding tabling Sheriff Robinson's request for vehicles didn't agree with the Board's copy of the minutes. Cerio also requested the minutes reflect whether public response to an agenda item was in favor or opposed to item. Board directed him to visit with the County Clerk.

The following correspondence had been received: Dept of Rev Lodging tax for Sept is \$1803.24, letter from Madison Co Commissioner Lee Klein- running for Sec/Treas of NACO, letter from NACO re: Affordable Care Act, letter from Wes Ehlers, Sequoia Consulting Group re: indirect cost allocation services. Motion by Kruger and second by Kruse to receive correspondence and place on file. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: none. Motion carried.

Deputy County Attorney Ed Talbot appeared regarding the approval of hiring an attorney for litigation against American Contractors, bonding company for Investors for Infrastructure. Talbot asked the board to appoint Attorney Charles Campbell from York County who has handled cases of this type in the past. Talbot stated that NIRMA would not handle cases involving contracts. Board discussed price and time line for filing law suit. Motion by Kruger and second by Abariotes to hire Charles Campbell to represent Washington County in litigation against American Contractors, bonding company. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: none. Motion carried.

Cheryl Parsons, Highway Superintendent, not in attendance, had requested the Board schedule a Road Committee meeting. Motion by Kruger and second by Kruse to set the Road Committee meeting for Tuesday, December 3, at 7:00 PM at the Courthouse. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: none. Motion carried.

Sheriff Mike Robinson gave the Board information regarding ordering replacement patrol vehicles, which was tabled from the Nov 12th meeting. Cerio stated that the purchase amount was in Sheriff's budget and made a motion to let the Sheriff purchase vehicles as outlined at the last meeting. Motion failed for lack of second. Robinson discussed the vehicles with the Board and the rotation of vehicle purchases. Robinson stated it would be 60 to 90 days for delivery and he would try to include the cost to outfit the vehicles in the lease-purchase agreement. No interest rates had been obtained as financing will occur closer to delivery date. Motion by Cerio and second by Johnson to give Sheriff permission to go ahead and purchase vehicles as stated in e-mail sent November 24, 2013 which included 5 Ford Police Utility Interceptors @ \$27,337 each and 3 Ford Taurus @ \$18,124 each for detectives. Vote-Aye: Cerio, Johnson, Kruger, Abariotes and Hineline. Nay: Quist, and Kruse. Motion carried.

Johnson reported the Personnel Committee had met with County Attorney Shurie Graeve and Talbot regarding proposed revisions to the county personnel manual. Committee will review copy of the current manual and meet again. Hineline spoke regarding revisions to the manual, including a disclaimer for the Sheriff's department because of the union contract, and giving elected official a chance to look at the proposed manual. Hineline went on record asking the Board approve his request for a written legal opinion from the County Attorney on 1) whether law enforcement employees who do not belong to the union are

covered under the FOP Contract as per Article 2 of said contract; 2) whether personnel manual covers elected official's employees. Quist stated he would contact the County Attorney. There were no further committee reports.

Tanna Wirtz, Planning & Zoning Administrator presented the following:

Motion by Kruse and second by Johnson to concur with Planning Commission recommendation to approve the CUP with a review in one year to obtain a status report on the project.
