The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, Dec 10, 2013 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steve Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen Motion Kruse second Johnson to approve agenda for Dec 10<sup>th</sup>, 2013. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruse and seconded by Johnson that the rules be suspended and that the minutes of the November 26, 2013 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Kruger and seconded by Kruse that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$196.82, Reg of Deeds \$22,647.00, Co Plan Dept \$6,113.00, Clk Dist Crt \$840.25, Sheriff \$2,135.50 and Road Dept \$2,590.80. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Fee report for County Court will be submitted at next meeting.

The following correspondence has been received: Information from Region 6 showing expenditures by service and by County and update from FEMA on money reimbursed this year. It was moved by Kruger and seconded by Kruse that the correspondence be received and placed on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt., had several items for the Board: Parsons said the Board had previously approved installing rock dams along Co Road P28. Dan Norman, Civil Solutions, said the Corp is now asking that a survey and a more detailed design be done. Kruger said the Road Committee's recommendation was to approve the additional cost to complete the grade stabilization project. Motion Kruger second Kruse to approve additional funding, not to exceed \$6400, for a survey and more design work on the project. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Road Committee had also discussed improvements to Co Rd P43, located near Ft Calhoun High School. Norman estimated the construction cost at \$282,000 and the engineering cost at \$25,000, which would include widening the roadway, grading new shoulders and an asphalt overlay. Board held a lengthy discussion that included comments from Don Johnson, Supt. of Ft. Calhoun Community Schools regarding the safety of the students, David Genoways and William Burdess. Chairman said some of the items to be clarified are: checking the road ROW, impact on trees and curve, what has been done with roads by other schools, where the city limits are and if city zoning affects project. Parsons suggested consulting with the County Attorney regarding the ROW. Motion Kruse second Kruger to table this until January 14 and have Chairman appoint a 3 person committee to research this. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman appointed himself, Kruger and Cerio to the committee.

Eric Obert from JEO Consultant Group had a handout for the Board and gave an update on the Ft Calhoun Northwest Bridge Project. Obert discussed several things that had changed since the plans were drawn up over 10 years ago, including some legals and ownership of property, which affected the ROW. Obert said the ROW is now resolved and the County Surveyor has the descriptions.

Pam Daly gave the Board a handout with her suggestions for County Board actions regarding behavioral health issues in the County. Daly read through the handout, gave the Board 2 brochures, and said she was leaving the position as a representative on the Region 6 Behavioral Health Advisory Committee. Chairman thanked Daly for her service and concern for the community. Board discussed the information.

Chairman said Board would go into a Closed Session-Executive Session, and that a motion for Closed Session is to be made for the purpose of a legal strategy session whereby protected attorney client privilege discussion will ensue with respect to pending litigation, specifically, Douglas E. Cook v. Washington County Supervisors and Washington County, CI-12-167, for the protection of the public interest that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights, and liabilities. At 10:10 motion by Abariotes second Hineline to go into closed session. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. At 10:18 motion by Kruger second Abariotes to end closed session. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again restated the motion for Closed Session was made for the purpose of a legal strategy session whereby protected attorney client privilege discussion ensued with respect to pending litigation, specifically, Douglas E. Cook v. Washington County Supervisors and Washington County, CI-12-167, for the protection of the public interest that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights, and liabilities. In open session, motion by Abariotes second Kruse to authorize 3 payments be made to resolve issue with Douglas E. Cook – one in December 2013 and 2 in January 2014 and authorize Chairman Quist to sign a release on behalf of the County. William Burdess spoke in opposition to the motion. Vote- Aye: Kruse, Quist, Kruger, Abariotes and Hineline. Nay: Johnson. Cerio abstained. Motion carried.

Parsons had sent a Snow Fence Policy to Board members and said this clarifies and reaffirms what the statutes say. Hineline spoke in opposition to the policy. Motion Kruger second Kruse to adopt the snow fence policy as presented and reviewed by the County Attorney. Vote- Aye: Kruse, Johnson, Quist, Kruger and Abariotes. Nay: Cerio. Hineline abstained. Motion carried.

Road Committee had discussed correspondence from Edward Schroeder stating he was told if the road was ever moved the NRD would relocate the fire hydrants located at the intersection of Co Rd P32 & P35. The road has been moved, Schroeder contacted the NRD regarding the situation, but no action has been taken. Motion Hineline second Johnson to have Parsons send a letter to NRD with correspondence from the property owner asking if the NRD will relocate the hydrants. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Cerio abstained. Motion carried.

Clerk read through the annual Certification of County Highway Superintendent form. Motion Abariotes second Kruse to approve the Certification of County Highway Superintendent and authorize Chairman to sign. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Motion Kruger second Kruse to approve the Extension of Temporary Easement with Martin Marietta Materials Inc. until 12/31/2014 on Co Road P30. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board discussed a Quitclaim Deed drawn up by County Attorney's office transferring tax sales property from the County to the Riverside Estates Homeowners Association. Motion Kruse second Abariotes to accept the Quit Claim Deed and authorize Chairman to sign. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Motion Abariotes second Kruger to designate The Enterprise and the Pilot Tribune as the Official County Newspapers for 2014 on the Dept of Roads form. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Clerk discussed Resolution 2013-33 regarding polling places. Motion Kruse second Abariotes to adopt Resolution 2013-33 setting the Polling Places for the 2014 Election year. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
