The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 8:30 A.M. on Tuesday, Jan 14, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Hightree went through the list of motor vehicle exemptions. There were no comments from the public. Motion Kruger second Kruse to close the public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion carried. Motion Kruger, second Johnson, to approve all the Motor Vehicle Exemptions submitted for: Great Commission Baptist Church, Good Shepherd Lutheran Community, Girl Scouts Spirit of Nebraska, Blair Family YMCA, Crowell Memorial Home, MCH Auxiliary, Memorial Community Hospital, First United Methodist Church, First Christian Church and Josephs Coat as presented by Deputy County Treasurer.

At 8:35 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Abariotes and second by Kruger to adjourn meeting until the next Board of Equalization meeting date, Feb 11, 2014. All members present voted aye, Chairman declared meeting adjourned.
