The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 8:30 A.M. on Tuesday, Aug 12, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Jeff Quist, County Board Members: Paul Cerio, Mary Alice Johnson, Steven Kruger, Ernie Abariotes and Ron Hinline. Jerry Kruse was absent. Also present, County Clerk Merry Truhlsen, County Assessor Steve Mencke and Deputy Jean Ray.

Motion by Johnson and second by Kruger that the rules be suspended and that the minutes of the July 22 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Motion by Abariotes second by Hinline to open a public hearing for Motor Vehicle Exemption. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion carried. County Treasurer Marj Hoier went through the application for vehicle exemption on a 2014 Chevrolet truck for Crowell Home with the Board. There were no comments from the public. Motion Abariotes second Hinline to close the public hearing. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion carried. Motion Kruger second Johnson to approve the Motor Vehicle Exemption for Crowell Memorial Home as presented by County Treasurer. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

It was moved by Johnson and seconded by Hinline to approve Correction #6701 as presented by the Assessor. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hinline. Nay: None. Motion carried.

Mencke discussed the 2014 County Valuation.

At 8:43 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Abariotes and second by Kruger to adjourn meeting until the next Board of Equalization meeting date, August 26, 2014. All members present voted aye, Chairman declared meeting adjourned.
