The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 8:30 A.M. on Tuesday, Oct 14, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Jeff Quist, County Board Members: Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger and Ernie Abariotes. Ron Hineline was absent for roll call but came in at 8:35. Also present, County Clerk Merry Truhlsen and County Treasurer Marj Hoier.

Motion by Kruger and second by Kruse that the rules be suspended and that the minutes of the Sept. 9 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger and Abariotes. Hineline absent. Nay: None. Motion carried.

Motion by Abariotes second by Kruger to open a public hearing for Motor Vehicle Exemption. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger and Abariotes. Hineline absent. Nay: None. Motion carried. Hoier went through the new application of Highways and Hedges Evangelism for vehicle exemption with the Board. No representative of the organization was present. Board discussed the application. Motion Kruse second Johnson to close the public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Kruse second Johnson to table this Motor Vehicle Exemption for Highways and Hedges Evangelism until the October 28<sup>th</sup> meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

There were no corrections or valuation changes from the Assessor's office. At 8:40 motion Kruger second Abariotes to go out of Board of Equalization and to reconvene later to discuss setting levies. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 1:45 PM Board reconvened as Board of Equalization. Clerk read resolution to set levies. Motion Kruger second Abariotes to adopt Resolution 2014- 28 Setting Final Tax Levies. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

## Resolution 2014 - 28 Board of Equalization Washington County, Nebraska Resolution Setting 2014-2015 Levy of Taxes

WHEREAS, by virtue of Neb. Rev. Stat. Sec. 77-1601 (2003 Supp), the Board is required by law to levy the taxes necessary for all political subdivisions within the County; and,

BE IT FURTHER RESOLVED, that this Board's Clerk provide a certified copy of this resolution to the Washington County Assessor for proper transcribing of such levy of taxation to the Tax Commissioner.
