## February 25, 2014 Minutes Washington County Board of Supervisors **Supervisor's Room Courthouse** Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, February 25, 2014 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen. Chairman announced there was no Board of Equalization today.

It was moved by Kruse and seconded by Kruger that the rules be suspended and that the minutes of the February 11, 2014 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Kruger second Kruse to approve the agenda for February 25, 2014. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Papio-Missouri River NRD cost share programs, Northeast NACO meeting info and Deb Fisher's mobile office will be at Courthouse today. Motion Kruse and second Abariotes to receive correspondence and place on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, introduced TJ Ernst, Greater Omaha Area Trailrunners, who had contacted Parsons about holding a running race on gravel roads in the County. Ernst said Skinny Bones Pumpkin Patch was hosting this and gave the route of the race, which would last from 8 am to 5 pm on May 24. Parsons and Sheriff Mike Robinson spoke. Board discussed the race and farm traffic on the road. Motion Kruse second Abariotes to give Greater Omaha Area Trailrunners permission to run the race course as set out, without closing the gravel roads, from 8 am to 1 pm. Vote- Aye: Kruse and Abariotes. Nay: Johnson, Quist, Kruger and Hineline. Cerio abstained. Motion did not pass.

Dan Norman, Civil Solutions, handed out information on the asphalt program for 2014 as shown in the One & Six Year Road Plan. Norman discussed the 5 projects listed at an approximate cost of \$1,260,000 and asked if the bid opening could be March 25. Motion Kruger second Johnson to allow Norman to go out for bids, with bids submitted to the County Clerk's office by March 24 @ 4:00 and opened March 25. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Next agenda item was the project on Co Rd P43 by the Ft Calhoun High School. Chairman said the Township Board contacted him saying they had some funds available for the project and talked of using a T intersection. Board discussed the project. Norman said he could present a general concept of the road to illustrate this option. Don Johnson spoke. Motion Kruger second Abariotes to have a Road Committee meeting March 4, 7:00 PM, in Courthouse multipurpose room where the City of Fort Calhoun, Ft Calhoun School, Township Board #1 and property owners could meet with the Board to see if this final option of a T intersection would have the support of the parties involved. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Legislative bills were discussed. Motion Johnson second Kruger to send a letter of opposition on LB1003, which would provide authority for Natural Resources Districts to issue general obligation bonds. Sheriff Robinson said there were 3 mobile homes that had distress warrants, where the value of the mobile home was less than the back taxes. Robinson wanted the Board's guidance to resolve this issue. Chairman asked Robinson to send the Board information on the mobile homes and his suggestions to resolve the issue.

Phil Green, Asst City Admin of Blair discussed two Inter-local agreements between the County and Blair City. Green said the Revised Interlocal Agreement Shared Law Enforcement Records Management System had a change in language which reflected the City paying their share of the cost directly to Intergraph Corporation. Board discussed the agreements. Motion Kruger second Johnson to enter into the Interlocal Agreement to Cooperate in the Joint Use of Computer Hardware, Software and Information Technology Personnel. Sheriff Robinson discussed payment of the RMS System.
