## September 9, 2014 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:38 a.m. on Tuesday, September 9, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steve Kruger and Ernest Abariotes. Ronald Hineline was absent. Also present, County Clerk Merry Truhlsen.

Motion by Kruger and second Kruse to approve agenda for September 9, 2014. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried. It was moved by Kruger and seconded by Abariotes that the rules be suspended and that the minutes of the August 19, 2014 and August 26<sup>th</sup> meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Johnson, Quist, Kruger, and Abariotes. Nay: None. Kruse abstained. Motion carried.

It was moved by Kruse and seconded by Kruger that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$367.50, Reg of Deeds \$33,578.25, Co Court \$19,793.60, Co Plan Dept \$19,946, Clk Dist Crt \$1,683.02, Sheriff \$ 2,233.93 and Road Dept \$1,175.82; August Treas Statement- Collections \$3,357,944.88; Disbursements \$1,436,739.97; Inheritance Tax 2,036,489.12; Ending balance \$9,832,981.77. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.

The following correspondence was received: NIRMA is soliciting nominations for 4 positions on their Board of Directors and NACO is seeking nominations for a Vice President. It was moved by Johnson and seconded by Abariotes that the correspondence be received and placed on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.

Dan Norman from Civil Solutions discussed the 2 bids that were received 8/26 for new buildings to be located at the County Road Department. Norman recommended rejecting the bids and discussed this with the Board. Rick Maslowsky, Road Foreman, agreed with Norman. Motion by Kruse and second by Cerio to reject the bids, refine them and rebid the project. Vote-Aye: Cerio, Kruse, Johnson, and Quist. Nay: Kruger and Abariotes. Motion carried.

Eric Obert, JEO Consulting Group, was not in attendance, but sent the following information: there was a rain delay for Thiele Geotech to do boring on the Marshall Nursery Road box culvert project on County Road 38; the rehab of Bridge C89-05105P (Boyer Chute area), is waiting on the contractor. Motion by Kruger and seconded by Kruse to table these items until the September 23, 2014 Board meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried. Obert also mentioned Steve Arens, engineer from JEO who came and assessed the structural damage to the courthouse roof/dome, would send documentation about the emergency roof repair for the insurance company. Board discussed the repairs.

The following pickup bids were received for the Road Department, with a 1997 Ford F150 trade in - Woodhouse Ford bids: 2015 Ford F250 \$24,511 and 2015 Dodge \$27,418; Sid Dillon bids: 2015 Ford F250 \$21,755 and 2015 Chevrolet Silverado \$24,933. Motion by Kruse and second by Kruger to receive bids, have the Road Department review them, and award the bid at the Sept. 23 meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.

Board reexamined the \$40,000 budget line item approved at the Aug 26<sup>th</sup> meeting for the Washington County Historical Association to determine if it should be paid in light of review by Co Atty. Kruger discussed information from the State Auditor's office and read a letter from the County Attorney's office that referenced Statute 23-355.01 regarding levying for historical associations and requests for funding. Based on this information it would appear that a historical association may levy or request funding, but not do both. Julie Ashton, Director for WCHA, had a handout and discussed the need for additional funding. Mike O'Brien spoke. Motion Johnson second Kruse to reconsider the motion made August 26 and remove the \$40,000 funding for the WCHA. Vote- Aye: Kruse, Johnson, Quist and Kruger. Nay: Cerio and Abariotes. Motion carried.

Board discussed setting a day and time for 2014-2015 Budget Hearing. Motion by Cerio and seconded by Abariotes to have the 2014-2015 Budget Hearing on Tuesday, September 16 at 7:00 PM. Vote- Aye: Cerio, and Abariotes. Nay: Kruse, Johnson, Quist, and Kruger. Motion did not carry. Motion by Kruger and seconded by Kruse to hold the 2014-2015 Budget Hearing on September 16, 2014 at 9:00 AM. William Burdess spoke. Vote- Aye: Kruse, Johnson, Quist, Kruger. Nay: Cerio and Abariotes. Motion carried.

Mike Robinson, Washington County Sheriff, discussed renewing law enforcement contracts. Motion by Kruse and second by Kruger to renew the Law Enforcement Contracts with Arlington Village and the City of Fort Calhoun. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.

Board discussed the renewal of the natural gas contract with Constellation NewEnergy – Gas Division, which the County Attorney had reviewed. Motion by Kruger and seconded by Abariotes to renew the contract with Constellation NewEnergy. Vote- Aye: Cerio, Kruse, Quist, Kruger, and Abariotes. Nay: Johnson. Motion carried.

Board discussed a request from Rebecca Versch, Extension Educator, to fill a vacancy on the Washington County Extension Board. Motion by Abariotes and second by Johnson to approve the appointment of Trevor Gnuse to the Wash Co Extension Board. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.

Paul Cerio discussed a proposal he had emailed to Board members to decrease certain budgets by 3 percent. Motion by Cerio to cut the indicated budgets as outlined. Motion was not considered as there was no second.

Committee reports were heard from: Bldg & Grounds, NRD, Technology and Personnel Committee.

Public comment was received from John Fowler of Unifirst, further information will be forwarded to Board and Co. Attorney.

Claims were received and reviewed, following which it was moved by Kruse and seconded by Johnson that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, and Abariotes. Nay: None. Motion carried.
