September 23, 2014 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, September 23, 2014 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting was being recorded. Chairman made note that the Open Meetings Law was posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steven Kruger, Ernest Abariotes and Ron Hineline. Also present, County Clerk Merry Truhlsen. Chairman said there was no Board of Equalization today.

Motion Kruse second Kruger to approve the agenda for September 23, 2014. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruse and seconded by Kruger that the rules be suspended and that the minutes of the Sept 9, 2014 meeting and the Sept 16th budget meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger and Abariotes. Hineline abstained. Nay: None. Motion carried.

The following correspondence had been received: Mike Wicht from Prochaska & Assoc sent info about the new Cherry County Jail/ Justice Center and Douglas Ewald sent info about the Nebr Job Creation and Mainstreet Revitalization Act. Motion Hineline and second Abariotes to receive correspondence and place on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, had the following road items: Parsons and Foremen Rick Maslowsky and Bob Smith discussed the pickup bids received 9/9 with the Board. Motion Kruse second Cerio to accept the Road Dept recommendation to purchase a 2015 Ford F250 4X4 pickup from Woodhouse Ford for \$24,801. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger and Hineline. Nay: Abariotes. Motion carried.

Discussion was held on the final payment for Phase II Ft Calhoun paving project and the two change orders. Eric Obert, JEO Consulting Group, presented Change Order 2. Cheryl Parsons is contacting the County Attorney about filing a claim for repair and replacement of the pavement that was damaged in the accident, (Change Order 2). Motion by Kruger seconded by Kruse to approve the final payment of Phase II of Ft Calhoun West Paving Project to Tab Construction and put JEO on notice for miscalculation of the cement quantities (Change Order 1) asking them to work with us on future engineering costs. Vote-Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Obert discussed the testing done by Thiele Geotech Inc on the Co Road 38, Marshall Nursery road, box culvert and said it checked out well. Motion Kruse second Kruger to have Eric Obert, JEO Consulting Group, modify the plans and bid specifications for the culvert repair on Co Road 38. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Obert said Tyson Construction has the Boyer Chute bridge on his agenda for the end of October. Motion Kruger second Kruse to table the rehabilitation of the CR51 bridge until more information is available. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Five companies submitted proposals for a dumptruck, plow and sander. The following bids include the trade in cost of a 2001 International truck, plow and sander: RDO - 2016 Mack \$139,056; Peterbilt of Council Bluffs – 2015 Peterbilt \$136,766; Cornhusker Int Trucks had 2 bids – 2015 International, no sander, \$122,345 and 2015 International \$123,457; Volvo International – 2016 Volvo \$141,000. The Omaha Truck Center bid was not read as a cashier's check was not found. Motion Johnson second Kruger to accept all bids, have Chairman check with Co Atty's office on reading the Omaha Truck Center bid, and table until the Road Committee meeting. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: Cerio. Motion carried. Motion Kruger second Kruse to have a Road Committee meeting on Tues, Sept 30th, at 7:00 P.M. in the Board room. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Later in the

meeting, Board took a break and Chairman talked to the County Attorney about the dump truck bids. Motion Kruse second Cerio that the Omaha Truck Center bid be rejected due to failure to include a cashier check, as per legal counsel from the Co Attorney's office. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Tanna Wirtz, Planning & Zoning Administrator had the following items:

- 1. Conditional Use Permit request for Jerry Hensler and Eugene Wayne Hull. Motion Kruger second Johnson to open a public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Wirtz went through the request that would temporarily allow for two single-family residences on one lot of record in Tax Lot 26 Section 33-Township 17 North Range 10 East of the Sixth P.M. (location: 20304 High Hill Lane, Arlington, NE. There were no comments from the public. Motion Abariotes second Hineline to close the public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Kruger second Abariotes to concur with the Planning Commission recommendation to approve CUP as presented. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
- 2. Replat request of Subdivision, Nashville Acres Replat I submitted by Tietz Construction and Ward & Melissa Ruge Motion Kruger second Johnson to open a public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Wirtz went through the replat request to reconfigure a boundary change between Lots 187 & 188, then split Lot 188 into 2 Lots. (Lot 188 = Lot 3, Lot 187 = Lot 2 and create a new Lot 1) in Nashville Acres, Section 31-Township 17 North Range 13 East of the Sixth P.M. (general location: Corner of County Road P47 and County Road P40). Gary Tinkham, Tinkham Land Surveying, discussed the replat request. There were no comments from the public. Motion Kruger second Johnson to close the public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Abariotes second Hineline to concur with Planning Commission recommendation to approve replat request as presented. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Co Treas Marj Hoier submitted a list of properties that have delinquent taxes and weren't purchased at the last annual tax sale. County Board will direct Treasurer to issue county certificates on certain parcels at the Oct 14th meeting. Motion Johnson second Kruger to receive list of properties and review information. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Co Treas Marj Hoier gave the Board a list of distress warrants and asked the Board to strike them from the tax rolls, due to non-collection for the past 2 or more years. Motion Johnson second Kruse to strike the Treasurer's Sept 10th listing of Personal Property taxes from the tax rolls. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Committee reports were heard from Technology, Personnel Manual, Jail, Region 6 and Storm Damage.

There were no comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Johnson that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.
