#### October 14, 2014 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:40 a.m. on Tuesday, October 14, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Jerry Kruse, Mary Alice Johnson, Steve Kruger, Ernest Abariotes and Ronald Hineline. Also present, County Clerk Merry Truhlsen.

Motion Kruger second Kruse to approve agenda for October 14, 2014. Vote- Aye: Kruse, Johnson, Quist, Kruger and Abariotes. Nay: Cerio and Hineline. Motion carried. It was moved by Kruse and seconded by Kruger that the rules be suspended and that the minutes of the September 23, 2014 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Kruger and seconded by Kruse that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$243.16, Reg of Deeds \$22,550.25, Co Plan Dept \$19,719.00, Clk Dist Crt \$696.00, Sheriff \$ 2,208.22 and Road Dept \$35,491.50; Sept Treas Statement- Collections \$693,371.72; Disbursements \$1,083,376.96; Inheritance Tax 2,110,833.54; Ending balance \$9,442,976.53. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Nebr Jail Standards changed their meeting to Friday, Oct 31; Papio Missouri River NRD is doing a study and there will be a low flying helicopter recording geologic measurements; and due to the passing of the American Recovery & Reinvestment Act of 2009 an additional reimbursement of \$5,689.20 has been disbursed to the county for Child Support Enforcement. It was moved by Kruse and seconded by Abariotes that the correspondence be received and placed on file. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, had the following Road Dept items: Kruger said the Road Committee met and reviewed the bids for the purchase of a new dump truck, plow and sander. Committee recommended purchasing the Mack truck, even though it wasn't the lowest bid, but felt it was the best vehicle for the money. Rick Maslowsky, Road Foreman, said the truck met all the specifications. Motion Cerio second Kruger to accept the RDO Truck Center Co bid and purchase a 2015 Mack dump truck, snow plow and sander for \$139,056, with the trade in of an International dump truck, plow and sander. Vote- Aye: Cerio, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: Kruse. Motion carried.

Parsons read through a Certification to Board of Classification & Standards regarding the County constructing projects according to minimum design standards from 7/1/2013 through 6/30/2014. Motion Hineline second Abariotes to approve the Certification and authorize Chairman to sign. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Parsons next read a Certification to Board of Classifications and Standards stating Washington County does not have a sales tax. Motion Kruger second Kruse to approve the Certification and authorize Chairman to sign. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Parsons read through a document to Board of Class. and Standards verifying projects constructed in the last fiscal year and their costs. Motion Kruger second Hineline to direct Chairman and Road Superintendent to sign the Road and Bridge Contracts Report. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Kruger said the new shop buildings were discussed at the Road Comm meeting, one proposal was to build 2 separate buildings 60x80, insulate, with 40x80 apron. Recommendation of the Rd Comm was to have Building Committee meet with Dan Norman, Civil Solutions, for further consideration of the project. Abariotes said Committee met with Steve Andersen, Architect, to go over changes to the plans. Andersen will make the changes and send plans to Norman. Norman talked about the buildings. Motion Kruse second Abariotes to table this issue until next Board meeting, when plans are finished. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Road Committee talked about Bridge Project C89-00605 (replacing bridge with box culvert) on Co Rd 6 and an undersized culvert on Co Rd 5 close to the intersection of County Road 5 & 6. Road Comm recommended replacing these at the same time. Norman discussed the work to be done. Motion Kruger second Kruse to update plans on culvert for Co Rd 5 and project C89-00605 on CR6. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Norman said he and Parsons have discussed the project near Ft Calhoun High School located on Co Rd P43 with LeMoyne Schultz, Director of Board of Classifications and Standards. Schultz said since this road falls within the City of Fort Calhoun zoning jurisdiction it is classified as a municipal road and doesn't need to follow the standard guidelines for a county road. Norman read from Nebr Statute 39-1501 and said the current alignment of that road doesn't need to be changed. The road will be widened and this will be done within the current road easement. Kruger said this was discussed at the Road Committee meeting and that the resolution passed on 8-26-2014 is no longer needed. Motion Kruger second Hineline to rescind Resolution 2014-22 and withdraw the relaxation of standards and follow municipal codes. Clerk read the resolution. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Theisen Construction gave an estimate of \$91,000 to repair County Bridge C89-05105P near Boyer Chute. Parsons talked about the work that will be done and that she offered to have the County do some of the work to cut costs. Theisen noted there are several unknown factors to these repairs, such as if they can reach bearing at 60 feet and other condition issues that may be found when work commences. Theisen can start work the end of next week. Motion Hineline second Kruger to approve Theisen Construction repairing bridge C89-05105P, at the discretion of the Road Supt- if cost of \$91,000 was reduced to \$86,000 with the County doing part of the work, otherwise have Theisen do all construction for \$91,000. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Later in the meeting Parsons came back to the Board and said she called Theisen Const. The estimated repairs for \$91,000 included the Road Dept doing part of the work. Motion Kruger second Cerio to reconsider earlier motion for Theisen Const. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion Kruger second Kruse to hire Theisen Construction to repair County Bridge C89-05101P at an estimated cost of \$91,000 with Rd Dept doing part of work. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Marj Hoier, Co Treasurer, discussed delinquent taxes (list given to Board at last meeting) not sold at annual tax sale. Motion Johnson second Kruse to direct County Treasurer to issue County Certificates on 5 parcels, which the taxes are delinquent for three or more years, as numbered on the Treasurer's listing: #31, 41, 60, 61 and 67. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Motion Kruger second Abariotes to open public hearing on 2014-2015 Revised Budget- for the consideration of revision of previously adopted budget. Changes were only made on the Notice of Revised Budget Hearing to include the delinquent tax allowance in the cash reserve column to balance the Notice of Budget Hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Board had lengthy discussion on the notification from the Auditor's office of an accounting error in the previously adopted budget, emails regarding this and options to correct the Notice of Revised Budget Hearing and Budget Summary. Public comments opposing the revised budget were heard from Pam Daly-who had a handout, Wes Stamp, Dan Flynn, William Burdess and Joyce Graybill. Motion Kruse second Kruger to close public hearing. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Cerio second Hineline to cut the delinquent tax amount of \$318,824.28 from the total Personal and Property Tax requirement column on the Notice of Revised Budget Hearing in order to balance the budget. Chairman asked if budget discussion could be interrupted and bids could be opened for the replacement of Bridge C89-02420. Cerio and Hineline withdrew the motion.

Parsons opened bids received for the replacement of Bridge C89-02420 with a triple box-culvert (this bridge was damaged by CVA Equipment). Darin Brown from Schemmer & Associates was not present. Two bids were received: ME Collins Contracting Co Inc for \$173,150.10 and Charles Vrana & Son Construction Company for \$321,114.70. Motion Kruger second Abariotes to table this until engineer reviews specifications and cost estimates. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Budget discussion resumed. Motion Cerio second Hineline to remove the delinquent tax allowance of \$318,824.28 from the budget in order to balance the Notice of Budget Hearing. Board discussed the motion. Deann Haeffner, Auditor's Office, spoke via telephone and answered various questions on the levy and other topics from the Board and the public. Board continued discussion. Vote- Aye: Cerio, Johnson, Abariotes and Hineline. Nay: Kruse, Quist and Kruger. Motion carried. Motion Kruger second Johnson to recess until 1:30 so the levy could be refigured. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

At 1:30 PM Board resumed discussion on the budget. Changes to the Revised Budget will be as follows: the 4% delinquent tax allowance, in the amount of \$318,824.28, will be removed from the budget, reducing the amount of taxes to be collected from \$8,289,431.57 to \$7,970,607.29. The County's levy will be reduced from .309741 to .297828. Clerk read Resolution 2014-26. Motion Kruger second Johnson to adopt Resolution 2014-26 adopting 2014-2015 Revised Budget. Vote- Aye: Cerio, Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

SECTION 3. That the income necessary to finance the appropriations made and expenditures authorized shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and tax levy requirements for each fund.
