The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Monday, November 10, 2014 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Chairman announced there was no Board of Equalization today. Present: Chairman, Jeff Quist, County Board Members, Jerry Kruse, Mary Alice Johnson, Steve Kruger, Ernest Abariotes and Ronald Hineline. Paul Cerio was absent. Also present, County Clerk Merry Truhlsen. Motion Kruger second Kruse to approve agenda for November 10, 2014. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. It was moved by Kruse and seconded by Abariotes that the rules be suspended and that the minutes of the October 28, 2014 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

It was moved by Hineline and seconded by Abariotes that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$354.25, Reg of Deeds \$20,053.25, Co Court \$20,759.50, Co Plan Dept \$17,116.00; Clk Dist Crt \$1996.00, Sheriff \$ 2,162.27 and Road Dept \$8,328.17; Oct Treas Statement- Collections \$473,029.20; Disbursements \$967,792.08; Inheritance Tax 2,129,764.22; Ending balance \$8,948,213.65. It was moved by Kruger and seconded by Kruse that the correspondence be received and placed on file. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board held a closed session for the purpose of a legal strategy session whereby protected attorney client privilege discussion will ensue with respect to negotiated settlement/possible litigation, specifically, Central Valley Ag Coop and Bridge C89-02420, for the protection of the public interest that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights and liabilities. Motion Kruse second Abariotes to go into closed session at 8:35. Vote-Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Motion Johnson second Kruse to end closed session at 8:48. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Chairman again stated the reason for closed session was for the purpose of a legal strategy session whereby protected attorney client privilege discussion will ensue with respect to negotiated settlement/possible litigation, specifically, Central Valley Ag Coop and Bridge C89-02420, for the protection of the public interest that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights and liabilities. In open session, motion Abariotes second Hineline to have Steve Kruger, Road Committee Chairman, work with Hwy Supt Cheryl Parsons to negotiate a settlement regarding the County's interest in Bridge C89-02420 and Central Valley Ag. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, had the following Road Dept items:

Raymond Arnold, Western Engineering Co Inc, had a proposal to overlay County Road P30, Kennard Bypass for \$265,320. He and the Board discussed the projects on Highway 75 and 133 and their impact on the Kennard road. Motion Kruger second Kruse to table the Western Engineering proposal until the November 25th meeting. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board had approved the proposal from ME Collins for structure C89-02420, replacing a bridge with a box culvert on Co Rd 24 at the last meeting. Parsons said they will start next week. Motion Hineline second Kruger to execute the contract with ME Collins for \$173,150.10. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Parsons discussed amending the contract with Schemmer Assoc Inc to include the costs for construction engineering services. Motion Kruger second Hineline to amend the original contract with Schemmer to add construction engineering services for

structure C89-02420 for a total of \$43,950. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried. Parsons next discussed a supplemental agreement for construction engineering services for structure C89-02420 with Schemmer Assoc to do the oversite of construction. Motion Hineline second Johnson to approve the supplemental agreement stating what CE services Schemmer will provide. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Board had directed Parsons to do a Road Study for CR P30, also known as Quarry Road, on Oct 28. Parsons read through the Study, which recommended continuing with the vacation process. Motion Kruger second Johnson to receive the Road Study on CR P30 from Hwy Supt Parsons. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

Parsons read Resolution 2014-31. Motion Hineline second Abariotes to approve and adopt Resolution 2014-31, setting the date and time for a public hearing for Road Vacation of County Road P30, aka Quarry Road. Vote- Aye: Kruse, Johnson, Quist, Kruger, Abariotes and Hineline. Nay: None. Motion carried.

RESOLUTION 2014-33 FOR AMENDMENT AND ADDENDUM TO NIRMA/NIRMA II INTERGOVERNMENTAL AGREEMENTS

WHEREAS, Washington County has previously entered into Intergovernmental/Interlocal Agreements with various other Nebraska Counties and other public agencies to form and participate in the Nebraska Intergovernmental Risk Management Association (NIRMA) and the Nebraska Intergovernmental Risk Management Association II (NIRMA II) as authorized by the

Intergovernmental Risk Management Act (Neb.Rev.Stat.§44-4301 et seq.) and the Nebraska Interlocal Cooperation Act (Neb.Rev.Stat.§13-801 et seq.); and

WHEREAS, Counties and other Public Agencies as defined in Neb.Rev.Stat.§44-4303 are allowed to participate in said cooperative undertakings; and

WHEREAS, the Legislature has found that proper risk management requires the spreading of risk so as to minimize fluctuation in insurance needs and that benefits can be derived through the pooling of insurance purchasing by local government, and

WHEREAS, NIRMA and NIRMA II have provided coverages to the County in a cost effective way which meet and exceed that provided by standard insurance carriers; and

WHEREAS, NIRMA and NIRMA II provide risk management services such as loss prevention, safety audits, claims and litigation management, and coverages tailored to address loss exposures counties and other related public entities face not economically available from other sources; and

WHEREAS, these coverages and risk management services are essential for the continued effective and efficient use of county taxpayer dollars; and

WHEREAS, the current Intergovernmental/Interlocal Agreements will expire on June 30, 2015 and NOW, THEREFORE, BE IT RESOLVED that the Washington County Board hereby;

- 1. Extends it commitment to participate in NIRMA and NIRMA II for the period July 1, 2015 through June 30, 2018; and
- 2. Declares that this Resolution shall serve as an amendment and addendum to the previous Intergovernmental/Interlocal Agreements entered into by the County Board, said Intergovernmental/Interlocal Agreements readopted by and incorporated herein by this reference as amended.
