January 13, 2015 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County met in regular session at 8:30 AM on Tuesday, January 13, 2015 in the Supervisor's Room at the Courthouse, Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

County Clerk, Merry Truhlsen, declared the reorganization meeting for 2015 was in session and that the meeting is being recorded. Clerk made note that the Open Meetings Law is posted on the door and the north wall. Present: Paul Cerio, Lisa Kramer, Mary Alice Johnson, Jeff Quist, Steve Kruger, Carl Lorenzen and Ronald Hineline. Scott VanderSchaaf, County Attorney, was also present. Clerk said there was no Board of Equalization today.

Clerk said the first order of business is that of electing a chairman and requested nominations. Kruger nominated Quist. Hineline nominated Lorenzen. Johnson moved that nominations cease, Kruger seconded motion. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Board voted by ballot. Clerk and County Attorney tallied the following: 4 votes for Quist, 3 votes for Lorenzen. Clerk announced Quist is the Chairman. Clerk next requested nominations for vice-chairman. Quist nominated Kruger. Cerio nominated Hineline. Lorenzen moved that nominations cease, Johnson seconded motion. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Board voted by ballot. Clerk and County Attorney tallied the following: 4 votes for Hineline, 3 votes for Kruger. Clerk announced Hineline is the Vice-Chairman. Chairman Quist presided over the meeting.

Johnson moved, seconded by Kramer to approve the agenda for January 13th, 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Next item of business was to designate depositories for County funds. It was moved by Johnson and seconded by Lorenzen that Washington County Bank, Two Rivers Bank and the Nebraska Public Agency Investment Trust (NPAIT) be designated as depositories for County Funds in 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Johnson and seconded by Hineline to authorize County Treasurer, Marj Hoier, to invest County Funds in any of the designated depositories. Dennis McCormick spoke. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

It was moved by Kruger and seconded by Johnson that the rules be suspended and that the minutes of the Dec 23, 2014 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Kramer abstained. Nay: None. Motion carried.

Motion Kruger second Cerio to receive the following monthly fee reports: Co Clerk \$336.50, Reg of Deeds \$39,714.00, Co Court \$21,439.50, Co Plan Dept \$10,654.00, Clk Dist Crt \$2184.56, Co Sheriff \$2,620.25 and Road Dept \$58,628.85. Treasurer's Dec. statement Collections 1,511,383.23; Disbursements 1,437,085.35; Ending balance 8,234,198.64. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The following correspondence had been received: Ben Scherer gave a notice of resignation from Region 6 Advisory Comm and Notice of Dodge Co Board meeting to consider amending Comp Plan/Zoning Regs. It was moved by Lorenzen and second by Johnson that correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Mike Smith, Weed Dept, discussed year end reports he will email to the Board for their review.

Cheryl Parsons, Hwy Supt, had the following Road Dept items. Erik Obert, JEO Consulting Group, Inc gave an update on 2 projects that are currently being advertised. Obert discussed Bridge #C89-22605P, Project Ft Calhoun Northwest. The bids received last summer on this project came in higher than expected and were rejected. Obert went over the modifications made to the plans and had a cost estimate sheet of \$603,786 for the rebid of this project. Obert next discussed the repair of a box-culvert on Marshall Nursery Road. Obert said this box culvert has had erosion problems and issues for a number of years and has had a

number of attempts to correct the problem. Obert handed out a drawing of the project and a cost estimate sheet of \$236,396 with alternate bid items of \$440. Bids will be received on these projects at the January 27 meeting.

Mike Robinson, Sheriff, asked the Board's approval to sell excess property: 2007 Chevrolet. Robinson will advertise the sale in the paper and receive sealed bids. Motion Kruger second Lorenzen to approve the Sheriff's sale of a 2007 Chevrolet Impala. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Tanna Wirtz, Planning & Zoning Administrator, said Gary Lambrecht and Dale Albracht are currently on the Planning Commission. Their terms have expired, they would like to be reappointed. There were no other applicants. Motion Kruger second Kramer to re-appoint Gary Lambrecht and Dale Albracht to the Planning Commission. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Wirtz next discussed the Board of Adjustment. David Taylor's term expired, he is willing to be reappointed to serve another term. Irwin Nelson was an alternate member to the Board of Adjustment, his term expired and he is not interested in serving again. Wirtz advertised for this position and received 2 applications: Jerry Kruse, Omaha and Cynthia Timmermier. This Board meets when needed. Sarah Bryan and Dennis McCormick spoke. Motion Kruger second Cerio to table the appointments to the Board of Adjustment until they have more information on the candidates. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Wirtz discussed an interlocal agreement with the Village of Washington pertaining to building permit issuance, inspections and storm water management. Motion Johnson second Kruger to approve the interlocal agreement with the Village of Washington. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Marj Hoier, County Treasurer, submitted the Semi Annual Statement to the Board, showing the summary of collections, disbursements and balances of various funds for July 1, 2014 through December 31, 2014. Motion Kruger second Lorenzen to receive the semi-annual statement and place on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Board discussed the Investors for Infrastructure lawsuit. VanderSchaff stated Ed Talbot's motion to withdraw from the case was based on the fact Talbot no longer had an agreement with the County. Motion Kruger second Lorenzen to hire the current County Attorney to research this lawsuit and take it over. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Cerio. Motion carried.

Board discussed a benefit from UnitedHealthcare to provide partial payment for gym memberships for Wash County employees for 1 year. Dennis McCormick spoke. Motion Lorenzen second Johnson to allow this benefit be offered to county employees for 2015, at no cost to the County. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Technology Committee had met and discussed various issues with the County's computer system and the Multi-County Information & Programming Services (MIPS) site survey. Board discussed the County's computers/servers/cabling etc. and hiring IT to move forward. Motion Lorenzen second Hineline to table this and have committee research this further and report back in 2 weeks. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Kruger second Johnson to designate notice of meetings will be published in the local newspaper: Enterprise and Pilot Tribune, on the County's websites www.co.washington.ne.us and for emergency situations will post a notice at the Courthouse. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Public comments were received from Scott Japp and Dennis McCormick.

Chairman said the Board would go into a closed session for the purpose of a legal strategy session whereby protected attorney client privilege discussion will ensue with respect to possible litigation, specifically, Shurie Graeve's severance pay, for the protection of the public interest, that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights and liabilities. Motion Johnson second Hineline to go into closed session at 9:55 am. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried. Motion Johnson second Kruger to go out of closed session at 10:29 am. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Chairman again stated the Board went into a closed session for the purpose of a legal strategy session whereby protected attorney client privilege discussion will ensue with respect to possible litigation, specifically, Shurie Graeve's severance pay, for the protection of the public interest, that is shared by citizens in general and by the community at large concerning Washington County's pecuniary interests, legal rights and liabilities. In open session, motion was made by Lorenzen seconded by Johnson that the claim for sick pay be denied and the claim for the accrual of vacation hours be paid at a rate of

\$27.50 per hour with a cap of \$8,250. Lorenzen then amended his motion to say the claim for sick leave be denied and the request for vacation pay be limited to \$27.50 per hour for a maximum of \$8,250, this is an adjusted claim and if the claimant accepts the payout, there would be no further claim going forward. Johnson agreed to the amendment. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Cerio. Motion carried.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Kramer that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.
