The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:45 a.m. on Tuesday, June 9, 2015 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen, Steven Kruger and Ronald Hineline. Paul Cerio was absent. Also present, Deputy County Clerk Carol Kuhr and Deputy County Attorney Christina Carr.

Motion by Kruger and second by Lorenzen to approve agenda for June 9, 2015. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion by Hineline and second by Johnson that the rules be suspended and that the minutes of the May 26, 2015 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion by Kruger and second by Lorenzen that the regular monthly fee reports of the following officials be received and placed on file: County Clerk \$363, Register of Deeds \$26,601, County Court \$29,530, County Planning Dept \$14,026; Clerk Distrct Court \$958, Sheriff \$2,196 and Road Dept \$121,465; May Treasurer's Statement- Collections \$1,034,414; Disbursements \$2,104,844; Inheritance Tax \$779,087; Ending balance \$9,025,143. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The following correspondence has been received: State Lodging Tax for March-\$1,088.20; Region 6 Behavioral Healthcare the county match for 2015-16 fiscal year will be \$50,377. Cheryl Parsons, Highway Superintendent was present to discuss road items. She recommended to leave the Township Contract rate at the current rate of \$1475/mile and stated all Townships fees were paid for the budget year 2014-15. Board discussed rate. Motion by Kruger second by Hineline to leave the Township contract rate at \$1475/mile. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Parsons discussed motor-grader specs with the Board. Motion by Hineline second by Johnson to approve last year's specs for this year. After discussion, motion by Hineline and second by Johnson to amend the motion to add 245 horse power to the specs from last year. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Parsons received and read truck-tractor bids from the following: RDO-2008 Mack, \$42,000; RDO-2009 Mack \$42,000; RDO-2004 Mack \$34,500; Omaha Truck Center 2007 Mack \$39,218. Board discussed bids. Motion by Kruger and second by Johnson to accept the 2007 Mac from Omaha Truck Center for \$39,218 if it has warranty. Kruger rescinded original motion. Motion by Kruger and second by Lorenzen to accept the bid for the 2007 Mack with approval for purchase by Parsons if warranty is included. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Gary Lambrecht discussed the Special Liquor License for the Washington County Fair stating that there would be two locations on the application, the Two Rivers Building Area and the Rybin Building where wine tasting would possibly be available.

Gary Tinkham, County Surveyor discussed the purchase of survey equipment to replace non-functioning instruments with the Board. Tinkham explained instrument use and reviewed 4 bids for a used Robotic Total Station as follows: A&D Technical Supply Co., Inc.-\$10,083.95, used; Seiler Geospatial Div.-\$26,250, used; Transit Works-\$22,921, demonstrator; Kara Company Inc.-\$32,653.85, new. Tinkham recommended the bid from A&D, although it was used equipment, as it best met the needs of the Surveyor's office and was compatible with their current equipment. Motion by Lorenzen and second by Hineline to approve the bid from A&D Technical Supply Co., Inc. for \$10,083.95. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

County Attorney Scott Vande Schaaf and District Judge John Samson discussed a County funded Drug Court with the Board. VanderSchaaf outlined the services to be provided with an estimated cost to the County of \$161,376. Office space would be available in the courthouse and program would be overseen by State Probation Office and County Attorney's Office. Judge Samson discussed the present operations in other counties and possible funding here by the State in the future. He also stated that LB 605 recently passed by the Legislature regarding sentencing of offenders could impact the participation in the program. Robert Denton from District Six Probation Office and Patty Lyon, Drug Court coordinator also spoke regarding the program. Board reviewed information presented and determined that implementation would take an estimated 90 days after start of new budget year if funded in the 2015-16 County budget. Motion by Hineline to set \$162,000 in next year's budget for Drug Court died for lack of a second. Motion by Kruger and second by Lorenzen to allow County Attorney to proceed with negotiations for an inter-local agreement between the State of Nebraska and Washington County for a Drug Court. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Denton and Vande Schaaf also discussed the approval of the Washington County Juvenile Services Comprehensive Community Plan with the Board. This is required in order to implement a Juvenile Diversion Grant provided by the state. The grant would start July 1, 2015 with \$46,000 guaranteed available from the Nebraska Crime Commission in reimbursement form and paid quarterly. The County would have space available for service. Motion by Lorenzen and second by Kruger to approve the Washington County Juvenile Services Comprehensive Community Plan for July 1, 2015-June 30, 2018 and move forward with the Juvenile Diversion Program. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Parsons discussed that a satisfactory warranty for the 2007 Mack truck had been faxed to her. She also stated that she would remain as Road Superintendent until a current Federal Aid road project was completed.

Committee Reports were are follows: Finance-some department heads have already turned in budgets to be reviewed; Technology -cities and villages have been contacted to join TOC, some offices are still having e-mail issues, a budget recommendation is needed for data processing costs; Public Health-3 Rivers Health Department has a new program and is having issues with office space; Personnel-manual is waiting for attorney review.

William Burdess gave public comment.

Claims were received and reviewed. Sheriff Robinson spoke regarding a claim for activation of a fuel credit card that was denied at previous meeting. Motion by Kruger and seconded by Lorenzen that the claims presented be allowed excluding the Workforrce Solutions claim and adding the claim from Sheriff Robinson and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.
