The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, July 14, 2015 in the Supervisor's Meeting Room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen, Steven Kruger and Ronald Hineline. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf.

Kramer discussed an agenda item for GIS Workshop that was mistakenly left off the agenda. Motion Lorenzen second Cerio to place GIS Workshop on the July 28th agenda. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Motion Kruger second Lorenzen to approve agenda for July 14, 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Lorenzen and seconded by Hineline that the rules be suspended and that the minutes of the June 23, 2015 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. It was moved by Kruger and seconded by Cerio that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$360, Reg of Deeds \$32,880, Co Court \$21,197, Co Plan Dept \$22,594; Clk Dist Crt \$1121, Sheriff \$2855 and Road Dept \$157,025; June Treas Statement- Collections \$1,685,352; Disbursements \$2,730,503; Inheritance Tax \$779,317; Ending balance \$7,979,992. It was moved by Kruger and seconded by Hineline that the correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, had the following Road Dept items:

Dan Norman, Civil Solutions discussed a change order for the shop building which included adding 2 septic tanks, a conduit sleeve for the aluminum feeder wire and extending the wall liner panel to full height for a total of \$33,520. Motion Hineline second Lorenzen to approve Change Order 1 for new shop building. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Norman gave an update on the road project at County Road 5 & 6. The County wasn't able to get the last easement, so the project will be bid without the culvert.

Board discussed a problem with the Marshall Nursery Box Culvert Project C89(531). Motion Cerio second Kramer to request a representative from JEO Consulting Group and Neuvirth Construction attend the July 28th Board meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Kruger second Kramer to accept NDOR Highway Allocation Fund revenue for Fiscal Year 2015-2016 to help address local road and bridge maintenance and construction needs. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Parsons said the Road Committee recommended purchasing 2 motor-graders. Motion Kruger second Johnson to purchase 2015 John Deere 772GP AWD motorgrader for \$293,196, with a trade in of a 2011 John Deere G for \$132,500 making the purchase price \$160,696. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Johnson second Kramer to purchase a 2015 NMC Caterpillar 12-M3 AWD motorgrader for \$300,000, with a trade-in of a 2011 Cat 140M-2 for \$126,900 making the purchase price \$173,100. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried.

Parsons discussed participating in NDOR, Nebr LTAP & Fed Hwy Admin pilot project to develop a County Safety plan. Motion Kruger second Lorenzen to table this until more information is received. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Tanna Wirtz, Planning/Zoning Administrator, said she had advertised for proposals to update the Wash Co Zoning & Subdivision Regulations. An informal bid from Marvin Planning Consultants was received for \$9,380. A bid from JEO Consulting for \$15,750 was received after the stated deadline. Motion Lorenzen second Hineline to accept the bid from Marvin Planning Consultants for \$9,380. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Kramer. Motion carried.

Jesse Gonzalez, Courthouse Maintenance, advertised for a new mower and received 1 bid from Andy's Mow-Town. Gonzalez said the snow attachments he has will fit this new machine. Gonzalez discussed using the old mower at the annex. Motion Kruger second Lorenzen to approve the bid for a new Grasshopper Model 729 for \$17,059.50. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Sean Johnson, Gateway Development Corp, thanked the Board for their commitment, support and participation. Sean gave an update on activities and meetings for the last 6 months.
