Sept 8, 2015 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:34 a.m. on Tuesday, Sept 8, 2015 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Jeff Quist, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen, Ron Hineline and Steven Kruger. Also present, County Clerk Merry Truhlsen.

Motion Kruger second Hineline to approve agenda for Sept 8, 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Hineline and seconded by Cerio that the rules be suspended and that the minutes of the Aug 25, 2015 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

It was moved by Cerio and seconded by Hineline that the regular monthly fee reports of the following officials be received and placed on file: Co Clerk \$435, Reg of Deeds \$30,534, Co Court \$23,667, Co Plan Dept \$33,592; Clk Dist Crt \$1143, Sheriff \$2083 and Road Dept \$5,603; Aug Treas Statement- Collections \$3,127,046; Disbursements \$1,094,224; Inheritance Tax \$861,296; Ending balance \$7,955,073. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. There was no correspondence.

Cheryl Parsons, Hwy Supt, discussed the truck bids received at the last meeting and said Road Committee recommended purchasing a 2016 Mack from RDO for \$132,925 and purchasing a 2016 Freightliner from Omaha Truck Center for \$137,416. Board discussed the bids. Motion Kruger second Hineline to accept the low bids from Omaha Truck Center on 2-2016 Freightliners, with trade-ins of 1998 and 2003 Internationals, for \$129,416 and \$137,416. Vote- Aye: Cerio, Kramer, Johnson, Kruger, Lorenzen and Hineline. Nay: Quist. Motion carried.

Parsons next discussed financing for motorgraders. Motion Kruger second Lorenzen to ask for bids for financing motorgraders from banks, John Deere and Nebr Machinery Caterpillar. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Cerio abstained. Motion carried.

Shane Swope, Schemmer & Assoc, handed out an engineering proposal for improvements on Co Rd 4, aka the Herman Scribner Road. Swope discussed the project/proposal, mentioning, among other things, the survey, Terracon Consulting doing a wetland delineation, design services, advertising, letting and developing bid documents. Board discussed the information. Motion Lorenzen second Hineline to approve the Schemmer Assoc Inc proposal for Basic Services, at a cost of \$117,245, on County Road 4. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

County Attorney Scott VanderSchaaf was present.

Ron Hineline discussed criteria he would like to see in place when the Road Supt retires. No action was taken.

Mike Smith, Weed Superintendent discussed spraying weeds along the river and renting a boat. VanderSchaaf discussed the process and giving notice to landowners. Motion Kruger second Lorenzen to table this until further information is received. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Co Atty Scott VanderSchaaf discussed the easement he prepared between Cargill and Washington County on Co Rd 43 and P26 and gave the Board copies to look at. Chairman went ahead with the next agenda item while Board members looked at the easement.

VanderSchaaf had an Interlocal Agreement for the Chairman to sign between the State and Washington County regarding Drug Court. The County will be reimbursing the State for the Drug Technician and some expenses, not to exceed \$72,000. Motion Kruger second Cerio to approve the interlocal agreement with the State for District 6 Drug Court, changing the wording of the

payment from quarterly to once a year. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Board went back to finish discussion on the easement. Motion by Kruger second Johnson to reaffirm Board's previous motion for closing and relocating a portion of Co Rd P26 and Co Rd 43 and authorizing Chairman to sign new easement with Cargill, drawn up by County Attorney. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion Lorenzen second Cerio to approve 2015 Office Inventories of County Attorney and Sheriff and place on file. Vote-Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Jesse Gonzalez, Maintenance Dept, said the Bldg & Grounds Committee looked at the bids to service the County's heating and cooling for the year. Bids were received from Ray Martin Company for \$10,100, Control Service Inc \$12,610 and MMC for \$12,000. Gonzalez explained how the bids varied and what services were offered by each company. Motion Hineline second Kruger to accept bid from MMC for \$12,000 as Bldg & Grounds Committee recommended. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Kramer said the Technology Committee met and recommended the County seek an hourly rate and turn around time for PC related calls and IT Services from LANTEX, James Overton. VanderSchaaf discussed IT Services and said he didn't get the Resolution drawn up as mentioned on the agenda. Board discussed getting several informal bids. Hineline made a motion to ask for an informal bid from LANTEX, it did not receive a second, then withdrew his motion. Sheriff Robinson asked that his offices be included in the bid. Motion Hineline second Cerio to go out for 3 informal bids for IT Services for the Courthouse. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Motion Kruger second Lorenzen to table the resolution regarding computer upgrades. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Marj Hoier, Co Treas sent a request that the following Personal Property/Real Estate taxes be stricken from tax rolls. Motion Cerio second Kruger to strike 2011 taxes for Pacific Coast Juice and Java for \$262.94 and 2010 taxes for John Welker for \$426.52 from the tax rolls due to non-collection as distress warrants. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Steve Mencke, Co Assessor, discussed participating with Metropolitan Area Planning Agency (MAPA) and Nebraska Iowa Regional Orthophotography Consortium (NI-ROC) in their 2016 aerial imagery pictometry. Mencke said the County has participated in the past and spoke of the usefulness of the aerials. Motion Lorenzen second Johnson to tell MAPA Washington County intends to participate in the 2016 project and is interested in Option II, the six inch ortho-rectified imagery at an estimated cost of \$34,442. Vote- Aye: Cerio, Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried.

There were no committee reports or comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Lorenzen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.
