October 27, 2015 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, October 27, 2015 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen and Steven Kruger. Ronald Hineline was absent. Also present, County Clerk Merry Truhlsen and Co Atty Scott VanderSchaaf

Motion Lorenzen second Kruger to approve the agenda for October 27, 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Lorenzen and seconded by Kruger that the rules be suspended and that the minutes of the Oct 13, 2015 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. The following correspondence has been received: Received a dividend check from NIRMA, our insurance carrier, for \$11,585, bringing the total of dividends received \$34,556. It was moved by Johnson and seconded by Kramer that the correspondence be received and placed on file. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

Cheryl Parsons, Hwy Supt, discussed setting a speed limit in the Looking Glass Hills Subdivision. Motion Lorenzen second Kruger to direct Rd Dept to do a full traffic study of the roads in Looking Glass Hills subdivision. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

The County Attorney's office had several items on the agenda. VanderSchaaf said the Board had asked him to research procedures for Mike Smith, Weed Supt, regarding access and weed control. VanderSchaaf said he looked at the statutes and has worked with Smith to clarify his responsibilities and procedures. Smith went through the steps he will follow when noxious weeds are spotted along the riverbank.

VanderSchaaf said he asked Beverly Reicks, National Safety Council, Nebr, to give an overview of the STOP Adult Diversion Programs that are administered through the Co Atty's office. Reicks had a handout and said Wash Co's program is run through the Omaha City Prosecutor's office at no cost to the County. Reicks went through the diversion programs that are available for young adult and adult low level misdemeanor offenses and explained the benefit of completing the 6 month classes and getting the criminal conviction off their record. A participant pays a fee of \$250, of which \$200 goes to the Safety Council and \$50 goes to the County. Board discussed the program. Mike Smith spoke.

Lisa Scheve, newly appointed Executive Director of Gateway Development Corp introduced herself and gave the Board an update on current projects.

VanderSchaaf said the County had been alerted to the fact we are to have a uniform 911 surcharge fee and handed out a statute concerning this. Currently people in the cities and villages pay .75¢ per month and rural residents pay \$1.00. VanderSchaaf asked that a committee of Board members work with him to check the current practice. Motion Kruger second Lorenzen to appoint the E911/Communications Committee, consisting of Quist, Johnson and Hineline, to work with the Co Atty in reviewing the County's 911 surcharge fee. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

VanderSchaaf said the Board had asked him to review information on the Papio Missouri River NRD bonding authority. The information was provided to him from Scott Japp a week ago on 6 bonds that consisted of approx 100 pages each. VanderSchaaf said he didn't have time to review this before the meeting. Motion Kruger second Cerio to table this until the Co Atty has a chance to research the materials. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

VanderSchaaf next talked about the Jail Standards inspection report from Sept 9th when the Wash Co Jail had it's annual evaluation. The report stated the client/attorney meeting room was out of compliance and VanderSchaaf urged the Board to

address this. Jail Committee member Lorenzen said he has talked to contractors and they have a plan to provide a secure room for atty/client visits. Sheriff Mike Robinson spoke. Later in the meeting, Kruger said he would like to address the Jail report again. Motion Kruger second Lorenzen to instruct Lorenzen to hire contractors to provide a secure room for atty/client visits. Board discussed the estimated cost will be less than \$5,000. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None, Motion carried.

VanderSchaaf handed out a letter that several officials had signed that addressed some concerns about Courthouse security. Board discussed the suggestions. Robinson also spoke about several safety issues. Motion Lorenzen second Johnson to have Bldg & Grounds Committee work with Sheriff to look at security in the building. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

A group of law enforcement personnel were present for the discussion of GIS information on the County's website. Steve Mencke, Co Assessor, said he had been approached by law enforcement personnel about blocking certain information and had talked to VanderSchaaf about the request. VanderSchaaf said he is researching this. Rob Bellamy, Brenda Konfrst, John Villwok and Dennis Sexton spoke. Motion Kramer second Cerio to request the Assessor's office and Co Atty's office review this further with regard to our online GIS information as well as statutes; and in the mean time direct the Assessor's office to maintain those files inactive for law enforcement and judicial personnel. Vote- Aye: Cerio, Kramer, Johnson and Quist. Nay: Kruger and Lorenzen. Motion carried.

At 10:45 am Lorenzen made a motion to go into a closed session in order to protect the public interest; whereby attorney client privileged discussion will ensue with respect to current litigation matters, specifically, River Wander LLC v. Wash Co; Investor's for Infrastructure LLC v. Wash Co; James Smith v. Wash Co. et al; and Fort Calhoun Public Schools. Second by Kruger. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried. Motion Lorenzen second Johnson to come out of closed session at 11:26 AM. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried. In open session, Chairman stated the closed session was in order to protect the public interest; whereby attorney client privilege discussion ensued with respect to current litigation matters, specifically, River Wander LLC v. Wash Co; Investor's for Infrastructure LLC v. Wash Co; James Smith v. Wash Co. et al; and Fort Calhoun Public Schools. Chairman said they received an update on River Wander, James Smith and Ft Calhoun Public Schools, no action taken. Motion Kruger second Lorenzen to choose Option B as presented by the Co Atty on the Investors for Infrastructure lawsuit. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger and Lorenzen. Nay: None. Motion carried.

Marj Hoier, Co Treas, discussed offering the option to pay your real estate taxes on line. Hoier said the only cost to the County would be a monthly fee to MIPS of \$171 for the program. Taxpayers who use the service will pay a fee of 2.75% to Certified Payments on the transaction. Hoier has checked with other counties using this and verified the reliability of the system. Hoier said customers have requested the option to pay real estate taxes on line and said taxpayers already can renew their motor vehicle taxes and drivers license on line. Board discussed the information. Lorenzen made a motion, Board continued to discuss the information, it didn't receive a second. Lorenzen left the meeting at 11:30. Kruger restated Lorenzen's motion, second by Kramer to have Hoier get a contract from MIPS and bring it back to the next Board meeting to make sure there are no additional charges. Vote- Aye: Cerio, Kramer, Johnson, Quist and Kruger. Lorenzen absent. Nay: None. Motion carried.

Kruger gave an update on the Northeast Nebraska Juvenile Services Detention Center and also said now that the bonds are paid off, the Detention Center will be drawing up new contracts for counties to use the facility to house juveniles. Currently Wash Co has 4 juveniles at the center, making the cost for last month \$17,472.50, which is more than the anticipated monthly expense budgeted.

Committee Reports were heard from Technology, Region 6 and Bldg & Grounds. There were no comments from the public

Claims were received and reviewed, following which it was moved by Kruger and seconded by Kramer that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same. Vote- Aye: Cerio, Kramer, Johnson, Quist and Kruger. Lorenzen absent. Nay: None. Motion carried.
