Nov 10, 2015 Minutes Washington County Board of Supervisors Supervisor's Room Courthouse Blair, Nebraska 68008

The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:30 a.m. on Tuesday, November 10, 2015 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman Jeff Quist, County Board Members, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen, Ron Hineline and Steven Kruger. Absent, Paul Cerio. Also present, Deputy County Clerk Carol Kuhr and County Attorney Scott VanderSchaaf

Motion by Hineline second by Kruger to approve the agenda for November 10, 2015. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion by Lorenzen and second by Kruger that the rules be suspended and that the minutes of the Oct 27 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Motion by Kruger and second by Lorenzen that the regular monthly fee reports of the following officials be received and placed on file and to correct agenda to show October Treasurer's statement instead of June: County Clerk \$504, Register of Deeds \$37,502, County Court \$17,806, County Planning Dept \$18,571; Clerk District Court \$1,590, Sheriff \$2,518.63; and Road Dept \$3,457; Oct. Treasurer's Statement- Collections \$528,382; Disbursements \$1,186,500; Inheritance Tax \$45,953; Ending balance \$6,794,493. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The following correspondence has been received: Audit report for NACO, and election procedures for Voting for NACO Officers. Motion by Hineline and second by Lorenzen that the correspondence be received and placed on file. Vote-Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Dan Norman, Civil Solutions, discussed the following County Shop Building close out items with the Board: 1) Change order to final contract showed a reduction of \$2,556.53 due to damage that was done to the existing well in construction. Final Contract Amount is \$566,463.47. Motion by Hineline and second by Lorenzen to accept Change Order No 2 showing the \$2,556.53 reduction to the contract price. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. 2) Accept Close-out Documents including Substantial Completion Date of October 26, 2015. With the signing of the documents, the two year warranty begins on the date of October 26, 2015. Motion by Kruger and second by Lorenzen to accept to close out documents as presented. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. 3) Approval of Pay Request No. 7 in the amount of \$52,717.85. This would be a progress payment. Motion by Kramer and second by Kruger to approve Pay Request No. 7 in the amount of \$52,717.85. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. 4) Approval of Pay Request No. 8 in the amount of \$56,646.35. This last pay request releases the 10% retainage and closes the project. Norman indicated most inspections had been completed except the Fire Marshall inspection and recommended that the Board hold off payment until that was completed. Motion by Kruger and second by Kramer to table Pay Request No. 8 in the amount of \$56,646.35 until the next board meeting. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Norman and Board discussed the box culvert on County Road P26/P33 in light of the construction work on Highway 133. Culvert is currently functional, but is undersized according to the 25 Year Storm Event. Norman recommended leaving it alone and asking the Board of Standards for relaxation of the speed limit. However, Chairman Quist indicated that the road may be planned for full depth asphalt and that would raise issues if culvert needed to be corrected in the future. Board instructed Norman to look at different ideas regarding the culvert and report back to the Board at a later date.

Cheryl Parsons, Highway Superintendent, read Resolution 2015-31 regarding a change in construction engineering services for BRO-7089(23) Blair West. An increase of \$2,330.71 was due to grading in excess of the project amount paid to Schemmer Associates, Inc. who did the staking for grading. This was the last of the old Federal Aid projects and was completed last

Friday. Board discussed change order. Motion by Hineline and second by Kruger to adopt Resolution 2015-31. Vote-Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Kruger discussed issues with the Marshall Nursery Road box culvert regarding grading. Parsons stated that the Road Committee meeting could be set after analysis of repairs or a major project on the culvert.

Scott Vander Schaaf, County Attorney, was present to discuss the Prochaska presentation and recommendation regarding jail status. He requested a written directive or recommendation from the Board regarding the transporting of prisoners as recommended by the jail committee. Board discussed the options contained within the Prochaska recommendation. Motion by Kruger to do transporting as recommended in option 3 in the report. Lorenzen added that this was to be on a one year basis. Motion failed for lack of second. Vander Schaaf stated that the jail committee had not set up an advisory board as the committee had discussed. Sheriff Mike Robinson spoke on the need for an advisory board made up of the public. Board discussed having Prohaska to come to a meeting as they had been asked for a cost analysis and not presented one. Motion by Lorenzen and second by Hineline to allow transporting as we are and ask the jail committee to come up with a plan of action and report at the next Board meeting. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Kruger spoke regarding the progress on the attorney-client conference room in the jail needed to meet jail standards.

Sheriff Robinson discussed a request from City of Fremont (police/fire/communications center) to join the Washington County 800 MHz Communication System. Shelly Holzerland, Communication Director for the City of Fremont and Todd Bernt, Fremont Fire Chief were present. Holzerland discussed the implementation of the system with the Board. Phil Brazelton spoke regarding the request. He stated that Fremont would be responsible for any cost and indicated that an inter-local agreement would be needed. City of Fremont would also need a letter of acceptance from the Board. Motion by Lorenzen and second by Kramer to accept the request from the City of Fremont to join the Washington County 800 MHz Communication System and direct the County Attorney to draft an inter-local agreement for such. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Steve Kruger discussed the NE Nebraska Juvenile Detention Center, Juvenile Services Agreement with the Board and County Attorney. The agreement would guarantee the County a representative on their Board, a voice in making decisions and a requirement that the Center would take our juveniles. Motion by Lorenzen and second by Kruger to authorize chairman to sign the Juvenile Services Agreement with the NE Nebraska Juvenile Detention Center. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Tanna Wirtz, Planning and Zoning Administrator, requested Board approval to open a checking account in order to accept credit card payments for building permits. Wirtz discussed details of the method using Point & Pay. Board questioned security issues that could arise. Motion by Kruger and second by Kramer to authorize the Planning Department to open a checking account and to have a security system in place for credit card numbers. Vote- Aye: Kramer, Johnson, Quist, Kruger, and Lorenzen. Nay: Hineline. Motion carried.

Deputy Clerk read Resolution 2015-30 regarding holidays that Washington County Courthouse will observe for 2016. Board discussed resolution. County Attorney was requested to look into the policy regarding State Holidays. Motion by Johnson and second by Kramer to table Resolution 2015-30 and act on it at the next Board meeting. Vote- Aye: Kramer, Johnson, Quist, Lorenzen and Hineline. Nay: Kruger. Motion carried.

Marj Hoier, County Treasurer, delivered to the Board the Report of Distress Warrants that were turned over to Washington County Sheriff. Hoier also discussed the information continued from 10/27 meeting regarding paying real estate taxes on line. Hoier reported that MIPS is owned by the counties in Nebraska and therefore would not need a contract. The fee for the rest of this fiscal year would be prorated with next budget year fee amount assessed at \$171.00/month. Discussion was held on funds available for payment for the system. Motion by Hineline and second by Kruger to give Treasurer the authority to begin on-line payment of real estate taxes and have the fees paid out of the Miscellaneous line in the General Fund budget. Dennis McCormick spoke. Vote- Aye: Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: Kramer. Motion carried.

Committee Reports: Technology-Kramer reported that the committee had received 4 informal bids regarding day to day expenses of the IT operation, including hourly rate, services provided, and turn-around time. The committee had not met to review them and make a recommendation to the Board. GIS website- Quist reported that the Assessor spoke with the vendor and the process for restricting certain Law Enforcement personnel information from searches can be resolved. A full report would be given at next board meeting.

Dennis McCormick spoke during public comment.

Brian Tuma, Assistant Director of Nebraska Emergency Management Agency, was present to recognize Washington County and thank them for their participation in the Hostel Action Base Exercise held on August 4, 2015 at the Fort Calhoun Nuclear Station. Also present with Tuma were John Schwartz, Technical Hazard Section Manager; Deb Robinson, Program Specialist; and Bill Pook, Regional Emergency Manager. Special recognition was given to Sheriff Mike Robinson and the Washington County Sheriff's Department, Captain Phil Brazelton and Dr. Mark Sand for their efforts in the exercise.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Lorenzen that the claims be allowed with removal of the Nelson Hill claim for the last County Shop Building payment for \$56,646.35t to be tabled to the next meeting. Clerk is ordered to issue warrants on the various funds for the claims allowed. Vote- Aye: Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Claims follow.
