The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 8:35 a.m. on Tuesday, December 22, 2015 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Jeff Quist declared the meeting was in session and that the meeting is being recorded. Quist made note that the Open Meetings Law is posted on the door and the north wall. Present: Chairman, Jeff Quist, County Board Members, Paul Cerio, Lisa Kramer, Mary Alice Johnson, Carl Lorenzen, Steven Kruger and Ronald Hineline. Also present, County Clerk Merry Truhlsen and Deputy Co Atty Jennifer Walkingstick.

Motion Kruger second Hineline to approve agenda for December 22, 2015. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. It was moved by Cerio and seconded by Hineline that the rules be suspended and that the minutes of the Dec 8, 2015 meeting be approved but not read at this meeting for the reason that all board members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The following correspondence has been received: Nebraska Loess Hills annual report and information that mileage rate for Jan 1 is .54¢. It was moved by Cerio and seconded by Hineline that the correspondence be received and placed on file. Vote-Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Weed Dept, Mike Smith, handed out Year End Reports, asked the Board to review them, then approve at the Jan 12th meeting.

Board discussed the offer from the Nebr Dept of Roads Dist#2 for broken concrete and milling materials. Motion Hineline second Kramer to table action on broken concrete and milling materials offer until the Jan 12th meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

The Highway Supt search committee handed out a job notice and discussed the details of advertising the position. Motion Lorenzen second Kruger to use Kramer's suggested abbreviated verbiage for the World Herald and Enterprise ads and use the full paragraph on NACO website. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Board next discussed the application and job description. Motion Hineline second Cerio to table this and continue discussion later in the meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Terra Uhing, Executive Director of the Three Rivers Public Health Dept, gave the Board an Annual Newsletter and briefly discussed highlights from the year.

Board next discussed official's salaries for 2016 and spoke of Resolution 2013-35, which set the salaries for January 2015. Marj Hoier, Mike Robinson and Merri Hightree spoke of employees and appointed officials receiving raises this year. Dep Co Atty spoke. Hineline made a motion, seconded by Quist, to increase elected officials salaries by 2% but then later withdrew the motion, Quist withdrew the second. Motion Kramer second Hineline to table this until the Jan 12th meeting. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Co Assessor, Steve Mencke discussed the Manatron Inc, Support Services Agreement for Treasurer's and Assessor's programs. Motion Lorenzen second Cerio to approve Addendum 1 and 2 with the Manatron Inc, Support Services Agreement. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried.

Board continued their discussion on hiring a Highway Supt. Motion Lorenzen second Kruger to approve the Hwy Supt Search Committee be given the latitude to create a preliminary job description and application for inclusion in the packet to be distributed to potential applicants. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hineline. Nay: None. Motion carried. Dep Co Atty spoke.

There were no committee reports or comments from the public.

Claims were received and reviewed, following which it was moved by Kruger and seconded by Lorenzen that the following claims be allowed and Clerk ordered to issue warrants on the various funds for the same.
