

**March 22, 2016 Minutes

The Washington County Board of Equalization of Washington County, Nebraska, met in regular session at 4:00 P.M. on Tuesday, Mar 22, 2016 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgment of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice to the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Lorenzen declared the meeting was in session and that the meeting is being recorded. Chairman made note that the Open Meetings Law is posted on the door and the north wall. Motion by Hinehline and second by Quist that the rules be suspended and that the minutes of the Mar 8 meeting be approved but not read at this meeting for the reason that all Board Members were furnished a copy of said minutes prior to the meeting. Vote- Aye: Cerio, Johnson, Quist, Kruger, Lorenzen and Hinehline. Kramer abstained. Nay: None. Motion carried.

It was moved by Kruger and seconded by Quist to approve Correction #6753 and #6754 as presented by the Assessor. Vote- Aye: Cerio, Kramer, Johnson, Quist, Kruger, Lorenzen and Hinehline. Nay: None. Motion carried.

At 4:05 A.M., there being no further business to come before the Board of Equalization at this time, it was moved by Hinehline and second by Quist to adjourn meeting until the next Board of Equalization meeting date, April 12, 2016. All members present voted aye, Chairman declared meeting adjourned.
